There have been no viability assessment submitted as part of the proposals. It has now been confirmed by Planning Policy that a proportion of the contribution would be directed towards increased capacity at Twynham Primary School and this scheme has now been delivered by DCC. The PPG and latest DFE guidance now clearly states that where education infrastructure has been forward funded by local authorities developer contributions are still necessary for the mitigation of the development. The contribution to the increased capacity at Twynham School is in conformity with CIL regulation 122. In terms of the secondary school provision the Pupil Place Team have identified that this will be directed towards the Grange School and the improvement of the condition of capacity which isn't currently fit for purpose. The education contribution calculated by BCP is an update of the work undertaken previously by DCC which meets the Reg 122 tests and takes into account actual pupil yields, capacity in the system and appropriate mitigation directly related to the development.
