# <u>Mandatory Conditions - (Embedded Restrictions) - Attached as part of Conversion Application under Transitional Grandfather Rights</u>

- 1.1 Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied, except alcohol sold or supplied with and for consumption at a meal supplied at the same time, consumed with the meal, and paid for together with the meal.
- 1.2The abovementioned restrictions on the times permitted to supply alcohol do not prohibit the supply to, or consumption by, any person of alcohol in any premises where they are residing.
- 1.3The consumption of any alcohol supplied shall be consumed by the end of the first twenty minutes after the permitted hours.
- 1.4The supply of alcohol for consumption off the premises must be made at a time when the premises are open for the purposes of supplying alcohol, in accordance with the certificate, to members of the club for the consumption on the premises.
- 1.5The licensee shall have regard and comply with any relevant provisions of the following enactments during any licensable activities taking place on the premises:-
  - 1.5.1 Children and Young Persons Act 1933
  - 1.5.2 Cinematograph (Safety) Regulations 1955
  - 1.5.3 Sporting Events (Control of Alcohol Etc) Act 1985
- 1.6 This Licence is subject to the document supplied with the application form entitled 'Byelaws, Memorandum and Articles of Association of The Southbourne Sports Club Limited'.
