(d)	the allocation of seats to each political group to the outside bodies as detailed in Appendix A, Table 4, be approved and the Group Leaders advise the proper officer of their representatives <i>(these are shown in Table 5)</i> ;						
(e)	subject to (d) above the Council is requested to approve the appointment of unaligned members to the relevant outside bodies.

- 3. The Council is asked to consider the proposed allocation of seats to political groups as detailed in the table above following the annual review of the political balance of the Council and the by-election on 2 May 2024. The last column in the above table identifies there is no variance in the allocation of seats compared to calculations set out in Table 1. However, it should be noted that the Christchurch Independents and Poole People political groups have expressed a desire to allocate seats other than by political balance on the Western and Eastern BCP Planning Committees as shown in the table^(a), which will require no dissent by Council.
- 4. Seats on committees, which are allocated to political groups, are to be filled by councillors of the respective political group in accordance with the wishes of the relevant group.
- 5. The Monitoring Officer has been notified by the Leader of the Poole Engage Political Group, which consists of two members, that whilst recognising the important work of the Appeals Committee neither member of the group is able to attend the scheduled meetings and has given notice that they are unable to appoint to the seat in question^(b).
- 6. The Local Government (Committees and Political Groups) Regulations 1990 makes provision, where a political group is unable to appoint a member of that group to an allocated seat, for the council to 'make such appointment as they think fit'. In such circumstances, the seat may be allocated to a named councillor without regard to the political balance requirements. This same position was taken in November 2023 and Councillor Chris Rigby was appointed to this seat. It is proposed that Councillor Rigby is allocated the seat on the Appeals Committee.
- 7. The following table (Table 3) therefore sets out the proposed membership of the Committees and Boards as advised by the respective political groups. Where a political group has not advised of their proposed members to serve on each committee or board, this will be shown as a vacancy.
- 8. The Political Groups may at any time alter their Group's membership of Committees and Boards, but any seats allocated to the unaligned Members must be approved by full Council. Members are asked to consider the following and any revised nominations submitted by the political groups.
