To Whom It May Concern,

I am writing this letter to share my personal experience of knowing lasc and to explain why I believe he is a genuinely good, trustworthy and responsible person who would be suitable to operate a nightclub during later hours.

In my experience, lasc is a caring, respectful and genuine individual. He treats people with respect regardless of who they are, and he is someone who can be relied upon when things become difficult. His character is demonstrated not just by what he says, but by the way he behaves towards other people.

Having known him personally, I believe he understands the importance of responsibility, particularly when it comes to looking after other people. A nightclub operating late at night requires somebody who can remain calm under pressure, communicate effectively, deal with different personalities and situations, and put the safety and wellbeing of customers and staff first. I believe lasc possesses these qualities.

I also believe that his ability to build positive relationships with people would be an important strength in running a nightclub. He is approachable and able to communicate with people, while also understanding that boundaries and rules need to be respected. I would have confidence in him making sensible decisions when faced with challenging situations.

Most importantly, my opinion of lasc comes from seeing first-hand how he treated me when I was going through a difficult period. The support he gave me showed me that he has genuine compassion for other people and that he is willing to step up when somebody needs help. That experience has given me a great deal of respect for him as a person.

For these reasons, I strongly believe that lasc is a good and genuine person who should be given the opportunity to demonstrate his ability to operate a nightclub responsibly during later hours. I believe he would take the responsibility seriously, respect the requirements placed upon him, and make the safety and wellbeing of customers, staff and the wider

community a priority.

I am happy to provide this statement based on my own personal experience of knowing and dealing with lasc, and I sincerely believe that he is a person who can be trusted with this responsibility.

Dear Las,

I wanted to write in support of you and your licensing application for Lost.

I will always be incredibly grateful for the way you and your team looked after my son, Connor, on the night he was assaulted near Bournemouth Beach and had suffered a head injury. This occurred at the previous venue you managed, Bar So.

You found Connor wandering around and immediately recognised that something was wrong. You brought him into the venue, made sure he was somewhere safe, and cared for him in the medical and welfare room. On realising that he needed proper medical attention, you arranged and paid for a taxi to take him to hospital and ensured that I was contacted so that I could make my own way there.

As his mum, knowing that someone had found him, cared for him and made sure he reached the hospital was incredibly reassuring during what was a very worrying time for our family.

What meant the most to me was that this had nothing to do with you or your venue. You did not really know Connor then, but you saw someone who was unwell, did the right thing and took responsibility for ensuring that he was safe and received the medical attention he needed.

I genuinely believe that your actions that night were incredibly important and I cannot thank you enough for not only looking after Connor that evening, but on all subsequent evenings that he crossed your path. I know he was not the easiest to deal with on occasions, but you always treated him with kindness and respect and put his safety first above all.

I believe this is a genuine example of the importance you place on welfare, safeguarding and looking after people who may be vulnerable or in need of help.

I am more than happy for you to include this email as part of the supporting information for your licensing application.
