The continuity of functions from the existing Councils was a key element of this work, such as planning and licensing and the associated policies.</p> <p>For transparency purposes, the Interim Monitoring Officer referred to the tabled documents in respect of Council Tax Harmonisation, including the background report from the Bournemouth, Christchurch and Poole Joint Committee on 16 April 2018. The Interim Chief Finance Officer introduced the documents, which followed the receipt of a request via officers at the Ministry of Housing, Communities and Local Government (MHCLG). The request was that the Chairman of the BCP Shadow Executive Committee writes to the Parliamentary Under-Secretary of State for Local Government setting out the preference for the harmonisation of council tax in the new authority.</p>
