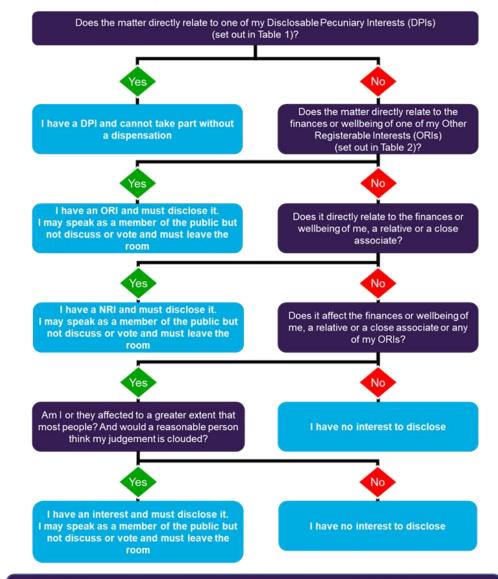

LICENSING COMMITTEE AND SUB COMMITTEE -PROTOCOL FOR PUBLIC REPRESENTATION AT VIRTUAL MEETINGS

1. Introduction

- 1.1. The existing protocol for public speaking has been adapted to apply in respect of virtual hearings under the Licensing Act 2003, the Gambling Act 2005, and Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982 (as amended by the Policing and Crime Act 2009).
- 1.2. This includes applications relating to the licensing of alcohol, regulated entertainment, late night refreshment, gambling, and sex establishments, Hackney Carriage and Private Hire vehicles, which are the responsibility of the Licensing Committee/Sub Committee to determine as set out in Part 3(A)-3 of the Council's Constitution.
 - 1. The Chair welcomes everyone, matters of general housekeeping are dealt with, notification that the hearing may be recorded for live and subsequent broadcast on the Council's website, reminder to switch mobile phones to silent, principles for managing formal skype meetings.
 - 2. The Chair identifies all parties present and makes introductions.
 - 3. Matters of general housekeeping are dealt with, notification that the hearing may be recorded for live and subsequent broadcast on the Council's website, reminder to switch mobile phones to silent.
 - 4. All persons who have given notice of their intention to speak are identified.
 - 5. Identify if any person who wishes to withdraw a representation or wishes not to speak
 - 6. Chair explains proposed procedure and order of speaking for hearing as set out in Appendix A. All parties confirm agreement or make representations on procedure proposed.
 - 7. Licensing Officer's report is presented.
 - 8. Parties present their representations in the order agreed.
 - 9. Parties who are speaking should not repeat the information which they have already given in writing in their representation. They will be able to expand on the written information given, provided the information remains relevant. Any addition information should be limited to the grounds of their representation(s). For example, if they are objecting on the grounds of Public Nuisance, then they should confine their comments to matters relating to Public Nuisance.

- 10. Members of the Licensing Committee or Sub Committee may ask questions after each representation and at the end of all representations. Parties, will be allowed to ask questions through the Chair.
- 11. Following representations, the parties will be given the opportunity to sum up. Party who spoke first to go last. The hearing will then conclude.
- 12. Members will deliberate in private with the clerk and legal representative as appropriate present.
- 13. The decision will be taken by the Committee and notification of the decision will be given within the period of five working days beginning with the day or the last day on which the hearing was held in accordance with the regulations. The notification of decision will include information about the right of appeal as appropriate.
- 14. The Legal Advisor will advise the parties of any right of appeal as appropriate at the conclusion of the hearing.

2. General points

- The hearing may be adjourned at any time at the discretion of the Members
- Members may amend the procedure at any time if they consider it to be in the public interest or in the interest of a fair hearing
- The Sub Committee may decide to conduct all or part of a hearing in non public session where it considers the public interest in doing so, outweighs the public interest in the hearing.
- The Chair may exclude any person from a hearing for being disruptive.
- Meetings of the Licensing Committee in public session are recorded by the Council for live and subsequent broadcast on its website.
- The hearing will take the form of a discussion.
- Only persons (or their representatives) who have made an application, are subject to an application or have submitted a written representation to the Licensing Authority under the relevant Act are permitted to speak at the hearing.
- Any further information to support an application or a representation must be submitted at least 5 working days prior to the Hearing. Any submissions submitted less than 24 hours before the hearing must be agreed by all parties at the Hearing, before it can be considered
- If a party has informed the Authority that they do not intend to participate, or be represented at the hearing, or has failed to advise whether they intend to participate or not, the hearing may proceed in their absence
- 2.2. For other matters in Part 3(A)-3 of the Council's Constitution which are the responsibility of the Licensing Committee, the procedures set out in Part 4D of

the Council's Constitution in relation to public questions, statements and petitions shall apply.

- 2.3. This includes such matters as making recommendations on relevant policies, approving the level of fees charged by the Council, and making decisions on tariffs charged by the Public Carriage Trade.

- Questions of the Responsible Authorities and Other Persons. Members of the Committee/Sub-Committee to go first.
- All parties will be given an opportunity to sum up (with the party who spoke last to go first). The hearing will then conclude.
- Sub-Committee will deliberate in private with Legal Adviser and Clerk present. (Councillors new to Licensing may observe but will not take part in the decision making).
- Notification of the Sub Committee's decision will be given within the period of five working days beginning with the day or the last day on which the hearing was held in accordance with the regulations. The notification of decision will include information about the right of appeal as appropriate.
- The Legal Adviser will advise parties of any right of appeal as appropriate at the conclusion of the hearing.

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

Contracts with be put in place with all contractors and suppliers for the use and management of the premises and this will be overseen by the Seafront Operations team on a daily basis.

All staff involved in the sale of alcohol shall receive training on the law relating to prohibited sales, the age verification policy adopted by the premises and the conditions attaching to the premises licence before they can serve alcohol.

A record shall be maintained of all staff training and that record must be signed by the person receiving the training and the trainer. The records must be kept for a minimum of 12 months and made available for inspection by Dorset Police, Local Authority or other authorised officers. The training must be delivered by or on behalf of an accredited training provider and contact details for those receiving the training must be included in the records.

b) The prevention of crime and disorder

A refusals register must be maintained at the premises and used to record all occasions upon which any person is refused the sale of alcohol with a note of the reason for the refusal, the date and time and a brief description of the person(s) concerned. The register must be kept at the premises for the duration of operation after which time it will be held by the Council's Seafront Team and made available for inspection by Dorset Police, Local Authority and other authorised officers on request.

An incident log must be kept at the premises. The log will include the date and time of the incident and the name of the member of staff involved. The log will be made available on request to an authorised officer of the Local Authority or Dorset Police, which will record the following:

- a) All crimes reported to the venue
- b) All ejections of patrons
- c) Any complaint received
- d) Any incidents of disorder
- e) All seizures of drugs or offensive weapons
- f) Any visit by a relevant authority or emergency service
- g) Any faults in the CCTV system or searching equipment or scanning equipment

No beers, lagers or ciders of 5.5% ABV (alcohol by volume) or above shall be sold at the premises.

The premises must install and maintain a temporary CCTV system to cover the bar area where sales are taking place. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings must be made available immediately upon the request of Dorset Police or authorised officer throughout the preceding 31 day period.

A staff member from the premises who is conversant with the operation of the CCTV system must be on the premises at all times when the premises is conducting licensable activities. This staff member must be able to show a Police or authorised council officer recent data or footage with the absolute minimum of delay when requested.

The holder of the licence must undertake a written risk assessment and give due consideration to advice from Dorset Police and the Local Authority with regard to the deployment of SIA Door Supervisors at different times of the day and on different days of the week to determine whether it is appropriate to deploy door staff on those days and/or at any other time(s) and to then implement the outcome of the risk assessment. A copy of the risk assessment should be made available to an authorised officer of the Licensing Authority or Dorset Police upon request.

The licence holder shall ensure that any queue to enter the premises which forms outside the premises is orderly and supervised by door staff or management to ensure that there is no public nuisance or obstruction to the public highway. The designated queuing area must be enclosed within appropriate barriers to ensure that sufficient footway is kept clear. All staff engaged outside the entrance to the premises, or supervising or controlling queues, must wear high visibility yellow jackets or vests.

There will be no sales of alcohol for consumption off the premises.

Outside of the hours authorised for the sale of alcohol, all alcohol within the trading area is to be secured behind locked grills, locked screens or locked cabinet doors to prevent access to the alcohol by both customers or staff.

There will always be a personal licence holder on duty on the premises when there is a provision of alcohol.

Unless written agreement is received by Dorset Police, no shots or shooters shall be available for purchase at the event.

There shall be on site, at all times when licensable activities are taking place, a person nominated by the licence holder to liaise with the Police and Licensing Authority in order to deal with any issues arising as a result of licensing checks performed at the premises.

The licence holder shall maintain a register giving details of each and every person employed in the role of security and shall provide upon request by any Police Officer or Council Officer, the following details:

- a) The licence number, name, date of birth and residential address of that person;
- b) The time at which he/she commenced that period of duty;
- c) The time at which he/she finished the period of duty;
- d) Any times during the period of duty when he/she was not on duty;
- e) If that person is not an employee of the licence holder, the name of the person by whom that person is employed or through whom the services of that person were engaged

The register shall be in paper or digital format.

Every entry/exit point to the venue must be staffed by an appropriately accredited SIA person or member of staff to ensure that no alcoholic drinks leave the premises.

All security persons shall be linked via radio

The DPS shall ensure that any person appearing to be under the influence of illegal drugs shall be refused entry.

Customers shall not be permitted to bring their own alcohol onto the site

The DPS shall ensure that customers do not bring glass bottles into the premises

The licence holder shall ensure that patrols or CCTV monitoring of the site are performed by security staff or CCTV operators whilst the site is closed to the public.

c) Public safety

A procedure for supporting and dealing with unwell members of the public will be in place including those who appear to be affected by alcohol or drugs. Staff will be appropriately trained in such procedures.

A currently qualified first aider must always be employed on the premises when the premises are open to the public. The venue will also provide first aid facilities commensurate with the type of event and customers expected.

The Licence holder will conduct a written risk assessment to identify the requirements for a Medical Plan. This risk assessment must be updated for each event that takes place at the premises. That risk assessment must be kept for a period of 6 months and made available to responsible authorities with minimum delay.

A fire risk assessment shall be performed for the premises. A copy shall be made available to the Police and relevant licensing authorities on request.

The licence holder shall comply with the most recent event management plan for the event (if one is intended). The Police shall have access to the most recent event management plan on request. Any breach of the event management plan will be seen as a breach of the premises licence.

If it is intended to hold any function, special event or live music, the Premises will conduct a written risk assessment to determine whether it is appropriate to deploy additional door supervisors for a period of time before the event is scheduled to start, during the event and for a period of time after the event is scheduled to end and will deploy door supervisors in accordance with the outcome of the risk assessment. Such risk assessments will also be conducted at the request of the police in respect of any other event scheduled to take place at the premises. Copies of all risk assessments shall be retained on the premises for a minimum period of 6 months and shall be made available for inspection by police and other authorised officers on request.

d) The prevention of public nuisance

Music noise levels shall not exceed 65dB(A) over a 15-minute period when measured at the boundary of any noise sensitive premises.

Low frequency noise shall be adequately controlled particularly 63Hz and 125Hz which shall not exceed 70dB(A) at any time when measured at the boundary of any noise sensitive premises.

Regular contact shall be maintained with the Police, authorised officers of the Council in charge of Environmental Health by the Seafront Operations Team to manage contractors and events onsite.

The PLH/DPS will operate to a written dispersal policy which ensures the safe and gradual dispersal of customers from the premises. The policy will be agreed with Dorset Police. The PLH/DPS will ensure that staff receive training on the policy and a record of training shall be kept/made available to an authorised officer upon request.

No advertisements of any kind (including placard, poster, sticker, flyer, picture, letter, sign or other mark) that advertises or promotes the establishment, its premises, or any of its events, facilities, goods or services shall be inscribed or affixed upon the surface of the highway, or upon any building, structure, works, street furniture, tree, or any other property, or be distributed to the public.

Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and businesses and leave the area quietly.

No food or alcohol shall be served on the patio/terrace area after 22:00 hours.

No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.

Loudspeakers shall not be located in the entrance lobby or outside the premises building

A direct telephone number for the manager at the premises shall be publicly available at all times the premises is open. This telephone number is to be made available to residents and businesses in the vicinity.

e) The protection of children from harm

'Challenge 25', shall be operated at the premises where the only acceptable forms of identification are (recognised photographic identification cards, such as a driving licence or passport *I* Holographically marked PASS scheme identification cards). Appropriate signage advising customers of the policy shall prominently displayed in the premises

All staff will be fully trained in the Seafront's Lost Child procedure and use this process in the premise communicating with the Seafront Operations Team.

There shall be a written policy in place stating how the management shall deal with lost children and vulnerable adults.

The licence holder will conduct a written risk assessment to identify the requirements for an area within the licensable area to be dedicated to dealing with child welfare and vulnerable adults.

Persons staffing these areas shall be CRB checked or have the appropriate similar legal check performed and have the necessary qualifications to look after children or vulnerable adults. These checks and qualifications shall be documented and provided to Police on request.

Any member of staff responsible for the welfare of a child or vulnerable adult must work with a minimum of one other member of staff when dealing with children or vulnerable adults and shall not be left along with them at any time.

No person under the age of 18 shall be permitted entry to the premises without being with a responsible adult over the age of 18 whilst licensable activities are taking place.



I am writing to object to the above application. The basis for the objections is the prevention of nuisance, the prevention of crime and disorder and public safety.

Firstly, I would like to point out that I was only made aware of the application yesterday, leaving 48 hours in which to register my objection, not a great deal of time and I would ask you to consider these as preliminary and unfocused objections and once I understand more about what is proposed I would seek to amend these if deemed necessary.

Last year, there was a very long debate and wide consultation relating to activities along Bournemouth seafront and it was agreed that such activities, which could include the playing of music and the sale of alcohol under certain conditions, could take place provided they finished by 22.00 hrs.

I now understand an applicant has asked for events to finish at later times - up to 11.00 pm

Additionally, the application infers that such events may be wedding receptions. It is difficult to imagine any attendees to such events complying with the condition that alcohol can only be served during the partaking of a substantial meal. As everyone knows, guests at wedding receptions, parties etc where alcohol is available will not expect to be restricted to consuming such beverage only whilst eating.

Who is making the application please? After much searching, I found the application on your website but it does not include the applicant's name or even the part of Bournemouth seafront that is involved. Where is this Hospitality Marquee to be situated, or if more than one marquee, the site of each of them? What type of events are envisaged as being held in the marquee(s)? May I remind the Council that last year during the hearing for the extension of licenses for 3 sites along the beach it was clearly stated that, while the applications included permission for many different types of event, it was really only "pop-up restaurants" that were thought likely. Already this has been shown to be false, given the concert to be held near Boscombe Pier in July.

I would wish for the committee to refuse the application for the following reasons

- 1. The timing of the events is unacceptable. Music could potentially be played from mid-morning until the very late evening and attendees would be leaving the venue after midnight and passing through residential areas. This will cause nuisance to the residents of blocks of flats overlooking the seafront. It will also lead to the possibility of criminal activities.
- 2. The application is too wide in terms of number of days and times within those days. There is no comfort in being advised that "Live music will not be in place throughout all of the times listed." Theoretically, music could be played every day of the week up to 11.00 pm or later, again causing nuisance.
- 3. It will be impossible to monitor compliance of alcohol consumption rules for events such as wedding receptions. Will someone be at every reception policing this? This can cause a hazard to public safety.

As a general comment, I will be dismayed if this application is approved as it would make a mockery of the very long process last year when the parameters for such events were agreed and published. Those living in a long established residential area should not be expected to tolerate noise day after day.

- 9. Information was received from Dorset Police following a visit to the premises, they witnessed breaches to the premises licence and issued a Warning Letter. These were identified on two separate occasions, the 12th and 20th of April 2022. Copies of the Warning Letters are attached at Appendix 5.
- 10. The licensing Authority have also written to the licence holder regarding the breached reported by Dorset Police and providing advice on the consequences of further breaches. This is attached at Appendix 6.

Annex 1 – Mandatory conditions

Mandatory Conditions (Sections 19,20,21 LA 2003)

- 1.1. There shall be no sale or supply of alcohol when there is no designated premises supervisor in respect of this premises licence or at a time when the said premises supervisor does not hold a personal licence or when his/her licence is suspended.
- 1.2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The Licensing Act 2003 (Mandatory Licensing Conditions) (Amendment) Order 2014

- 1.3.
- 1. The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- 2. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises –
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to -
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti- social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 1.4. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 1.5.
- 1. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- 2. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- 3. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request,

before being served alcohol, identification bearing their photograph, date of birth and either

- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 1.6. The responsible person must ensure that -
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: $\frac{1}{2}$ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

The Licensing Act 2003 (Mandatory Conditions) Order 2014

1.7.

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1 -
- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula —

$$\mathsf{P} = \mathsf{D} + (\mathsf{D} \times \mathsf{V})$$

Where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 – Conditions consistent with the operating schedule

Prevention of Crime and Disorder

- 2.1 All staff involved in the sale of alcohol shall receive training on the law relating to prohibited sales, the age verification policy adopted by the premises and the conditions attaching to the premises licence.
 - 2.1.1 Refresher training shall be provided at least once every 6 months. A record shall be maintained of all staff training and that record shall be signed by the person receiving the training and the trainer. The records shall be kept for a minimum of 12 months and made available for inspection by police, licensing or other authorised officers.
- 2.2 An incident log shall be kept at the premises. The log shall include the date and time of the incident and the name of the member of staff who has been involved. and made available on request to an authorised officer of the Council or the Police, which shall record the following:
 - (a) any complaints received
 - (b) any incidents of disorder
 - (c) any faults in the CCTV system / or searching equipment /or scanning equipment
 - (d) any refusal of the sale of alcohol
 - (e) any visit by a relevant authority or emergency service
 - (f) all crimes reported to the venue
 - (g) all ejections of patrons
 - (h) all seizures of drugs or offensive weapons
 - 2.2.1 This log to be checked on a weekly basis by the DPS of the premises.
- 2.3 Challenge 25, shall be operated at the premises where the only acceptable forms of identification are (recognised photographic identification cards, such as a driving licence or passport I Holographically marked PASS scheme identification cards).
 - 2.3.1 Appropriate signage advising customers of the policy shall prominently displayed in the premises.
- 2.4 A CCTV system, shall be installed to cover all entry and exit points enabling frontal identification of every person entering in any light condition.

- 2.4.1 The CCTV system shall continually record and cover areas where alcohol is kept for selection and purchase by the public, whilst the premises is open for licensable activities. It shall operate during all times when customers remain on the premises.
- 2.4.2 All recordings shall be stored for a minimum period of 31days with correct date and time stamping. Recordings shall be made available immediately upon the request of Police or an authorised officer of the council throughout the preceding 31 day period. The CCTV system shall be updated and maintained according to police recommendations.
- 2.4.3 A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open to the public. This staff member must be able to show a Police or authorised council officer recent data or footage with the absolute minimum of delay when requested.
- 2.4.4 CCTV shall be downloaded on request of the Police or authorised officer of the council. Appropriate signage advising customers of CCTV being in operation, shall be prominently displayed in the premises.
- 2.4.5 A documented check of the CCTV shall be completed weekly to ensure all cameras remain operational and the 31 days storage for recordings is being maintained.
- 2.5 All persons making deliveries shall be instructed to report to the holder of the licence or the DPS any and all occasions when a delivery is refused and the reason for that refusal and a record of all such refusals shall be maintained at the premises.
 - 2.5.1 The record shall be checked by the DPS or the manager (ess) in charge of the premises at least once a week and shall be signed to that effect.
 - 2.5.2 Alcohol deliveries shall only be made to residential/business addresses.
- 2.6 Alcohol sold shall be ancillary to food prepared and served on/delivered from the premises.

Prevention of Public Nuisance

- 2.7 No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.
- 2.8 Loudspeakers shall not be located in a position that will cause nuisance. No loudspeakers will be located within the entrance lobby or outside the building.
- 2.9 All windows and external doors shall be kept closed at any time when regulated entertainment takes place, except for the immediate access and egress of persons.
- 2.10 The premises licence holder shall ensure that any patrons smoking outside the premises do so in an orderly manner and are supervised by staff so as to ensure that there is no public nuisance or obstruction of the public highway.
- 2.11 The holder of the licence shall use all reasonable endeavours to ensure that customers do not loiter outside the premises and to that end, the licence shall not commence until a written dispersal policy is in place and a copy sent to the local Licensing Authority.
 - 2.11.1 The dispersal policy should be periodically reviewed and be visibly displayed in an outside window on ground floor level of the premises and must include a contact number that neighbours can call if an issue arises.
- 2.12 If the outside area is used in the future, all tables and chairs shall be removed from the outside area by 22:00 each day.


- 2.13 If the outside area is used in the future, no food or alcohol shall be served in the outside area after 22.00 hours each day.
- 2.14 Patrons permitted to temporarily leave and then re-enter the premises after 22.00, e.g. to smoke, shall not be permitted to take drinks or glass containers with them.
- 2.15 Notices shall be prominently displayed at all exits, requesting patrons to respect the needs of local residents and businesses and leave the area quietly.
- 2.16 No waste or recyclable materials, including bottles, shall be moved, removed from or placed in outside areas between 22.00 hours and 07.00 hours on the following day.
- 2.17 Suitable lidded receptacles will be provided to receive and store refuse from the premises/site.
- 2.18 Litter will be regularly cleared from the vicinity of the premises.
- 2.19 No deliveries to the premises shall take place between 22.00 and 07.00 on the following day, and delivery drivers will be required to park considerately.

I wish to raise objections to the varying of premises licensing for Conroy's Bar 33 Sea Road Boscombe.

Conroy's Bar took over the premises of Corner 33 Fish and Chip Restaurant, formerly Corner Cafe 33. These previous establishments have been food led business operating within reasonable hours within the predominantly residential area. Neither produced any noticeable noise outside of the premises. Conroy's appears to be billing itself more as a bar and music venue with DJ's rather than a food led premises, and this could produce excess noise in a residential area, this does not just concern the noise from music, but also noise from people congregating outside to smoke and upon leaving the premises at closing time. I've attached a video from Conroy's facebook page (https://www.facebook.com/conroysbarbournemouth) showing their DJ in their cellar, complete with security staff walking around, and sufficient space to dance, and a noticeable lack of food. It doesn't exactly present itself as a food led restaurant. I therefore believe they are misrepresenting their intentions as I understand the existing licence is for a food led establishment not a bar with music.

In addition, the junction of Sea Road and Windsor Road in which Conroy's is located is a magnet for antisocial behaviour. Observations of suspect behaviour, potential drug dealing etc are frequently witnessed and regularly reported to the local police. Sea Road Food and Wine located opposite Conroy's was forced to amend their opening hours as a result of the antisocial behaviour within the vicinity of the junction of Sea Road and Windsor Road. The presents of a bar instead of a restaurant in this vicinity could contribute or amplify existing antisocial behaviour, especially as there are links between the dance music they wish to host and drugs culture

(http://clubresearch.org/2015/02/10/drugs-and-dance-music-culture/). It may also force existing antisocial behaviour into the adjacent more secluded residential roads. Having been threatened and assaulted on my own forecourt in Westby Road after discovering numerous groups of people taking drugs on my premises, I can safely say it is not a pleasant experience not knowing what you'll find and meet when leaving or entering your own home. Antisocial behaviour within Westby Road also has a negative impact on the last few remaining B&B's.

Finally, the junction of Sea Road and Westby Road is the premises of SWRAC, an educational facility for vulnerable young adults. Having already witnessed people drinking pint's of beer at 0830 in the morning outside of Conroy's, I do wonder about the appropriateness of such an establishment serving alcohol from such an early time, in such close proximity to an educational facility with vulnerable young adults.

Please see below our objections to the varying of the current premises licensing for Conroys Bar at 33 Sea Road.

- 1. When Conroys opened it was not serving any food. This offer was made after a few days. It seems very strange that a so-called restaurant opens with no food just alcohol.
- 2. All marketing and posts online such as their Facebook page seem very much bar orientated with the DJ nights for example. It does not come across as a restaurant at all.
- 3. There is concern about the DJ in the basement and other planned events. Is the sound-proofing sufficient? Also now there is a juke box installed in the upstairs bar, will this create an issue?
- 4. Smoking outside is another concern. We do not need that outside potentially at 2am in the morning. Who will monitor the litter and the noise? Also at kick out time?
- 5. The corner is already a very anti-social area with many concerns which we feel will be exacerbated by the pub's location. We have already seen know troublemakers/ druggies who are usually on that corner move round into our road since the pub opened. It has pushed the problem round the corner and made things worse.
- 6. Add to that we already have issues with people on their way home after a night out urinating and vomiting in our front gardens. We fear that this will now become worse with additional drinkers in the area.
- 7. We also have concerns with placing a bar next to a school for vulnerable adults (SWRAC). It seems quite an issue to want to serve alcohol for even longer hours with the school just opposite.
- 8. Also the pub does not seem in keeping with other businesses around here (such as the B&Bs/ hotels) and would have been much better placed out of a residential area.
- 9. Urban Beach and Obsidian are both placed within the residential area here but are open reasonable hours and do not seem to be of concern, whereas Conroys does not seem to fit at all here especially after seeing what it is like at their other bar Marroys. Their clientele seems to be a completely different demographic to the people that drink/ eat around here.
- 10. Our local police are stretched to the limit anyway around here keeping the area safe and pleasant for the locals and our many tourists. Again Conroys just does not seem to fit here and we are so concerned that it is creating a situation where we do not have the extra police around here to deal with an issues that may occur due to additional drinkers to the area. Conroys seems to come across too much as a bar and not a restaurant from speaking to people around here. It really is giving the wrong impression.

I am writing to you as a long standing resident of Westby Road.

In the context of the wider regeneration of the area I am in favour of the Bar being opened and could see it contributing to the 'Cafe Culture' we need in this area to help revive it. However, I do object to the extended licencing hours.

This area of Sea Road is problematic enough and I feel extending the licencing hours will exacerbate public nuisance. Local groups and services have worked very hard to clean up the area - and as a resident I feel it is working. The bar in it self could be a great asset but allowing extended licencing hours may well reverse this good work and encourage more petty crime and drug related activity.

1. It will encourage drinkers to congregate outside on the pavement - particularly smokers. This may be acceptable to 10 pm but any later and it becomes a **residential nuisance**. People spilling onto the pavement at 1am in the morning and disbursing is always going to cause a noise nuisance.

2. The junction is very busy and the presence of a number of people congregating on the corner which is a crossing just adds to **the Safety Issue** - particularly when alcohol is involved..

3. This area of Sea Road always has a rougher feel to it. Operating 'night club' hours on the edge of a residential district which includes a large community of retired and elderly in sheltered flats at number 4 Sea Road and further down the hill at Viscount Court is guaranteed to cause **noise and disturbance**. I am a resident in Westby Rd and wanted to raise some points about this application. I want to remain anonymous

- My understanding is this is meant to be a cafe/restaurant that serves alcohol with the food they serve.
- The application is asking for extended hours for music as well as on and off sales.

I am a local resident living in Westby Road **and the second secon**

I do understand that the town centre and precinct area does have late night venues, but as this is in a residential area I think this should be considered as an infringement on our quality of life as residents, if allowed to open beyond reasonable hours. I also believe there will be associated public nuisance and crime & disorder as a result of these extended late night hours.

- All day and night drinking fine if people responsibly drink and eat all day, but why not keep it to the standard café/restaurant hours and close by 11pm. We do not live in Europe and nobody goes out for food after 9.30pm – so there will only be alcohol consumed after 11pm leading to late nightcrime&disorder/public nuisance/public safety issues.
- Late night music license again people are only going to drink and not eat. If the music is acoustic or a local band fine, but if they have a disco that is for dancing and drinking, not eating. To be clear what sort of music plays until 2am only dance music. So the chairs and tables will therefore be pushed to the side with no food in sight and hours of drinking ahead leading to late night crime&disorder/public noise nuisance.
- 3. Noise whilst the noise will be contained, people will be opening and closing the front door continuously, especially to step outside onto the pavement outside where there are already tables and chairs presumably with a pavement license. Before you know it, the door will be left open and lots of people will be outside hanging around making noise late into the night and also effectively blocking the street corner, where pedestrians have to walk thru and that will be intimidating. All leading to late night crime&disorder/public nuisance/public safety issues. (Suggestion get an internal door installed to stop the noise nuisance from downstairs.)
- 4. Do we really need to allow Off Sales from 8am-2am we have a corner shop/off license opposite already with basic hours will lead to late night crime and disorder/public nuisance/public safety.

If the application sadly does go thru, what can we expect as local residents in terms of monitoring the situation, so the license terms are not abused?

Luckily we do not have to cross the road to get to town ourselves, but the restaurant is in a very prominent corner position and other residents will not be so fortunate.

The poor residents of Windsor Road – one of our most socially deprived roads are next door - is this really going to improve their quality of life and have they been encouraged to comment on the application?

It's a very welcome thing to have a successful new restaurant/cafe extending from the high

street. But it is quite another to allow a drinking and music venue until the early hours every weekend, with all the associated problems this will bring. I hope common sense prevails. Thanks,

I am writing to object to Conroys licensing application. The LAST thing this area needs is a dated/grotty-looking boozer that serves alcohol from 8am. There are already plenty of other places to go for music, food and drink - we don't need another venue - especially not in this residential area.

Let's consider some the licensing objectives;

- 1. "The prevention of public nuisance" serving booze at 8am is going to instantly attract the kind of problem drinkers who are a nuisance. What kind of person has lager for breakfast? Need I say more? Encouraging problem drinkers to gather here.. and with the friends they associate with.. will be a nuisance for residents and tourists alike. Around here problem drinking seems to go hand-in-hand with antisocial behavior, and drugs. Also, music until 2am... in a residential area..... there's your nuisance right there. Even if the music is in the basement.. the sound will still escape.. either indirectly through vibrations and reverberations, or directly when patrons come and go through the front door. I live in Cecil Road, close to the above property and I have visited Conroy's Bar where I was able to have a very helpful conversation with a staff member not the owner of the business. I was glad to find his general attitude sympathetic and sensitive to neighbours. I remain, however, a little anxious that the way in which the Application has been worded could perhaps leave room for misunderstandings and possible loose interpretation of the restrictions contained in the Licence.

I have also telephoned the phone number at the bottom of the Application said to be the phone number for Laceys Solicitors but, when I called that number, I was informed it is a private phone number. When I telephoned the Licensing Dept at BCP Council Offices, it was confirmed to me that the number is not the phone number for Laceys, so I know I did not make a dialling error. I did visit the Council Offices in the hope of obtaining a copy of the full Application for variation of Premises Licence, but was told I could not see an officer from that department and instead was given a phone number to telephone the Licensing Department which I have used. I would, however, appreciate a copy of the Full Application from somewhere (Laceys Solicitors or BCP Council)

Personally, I think confusion would be avoided by stating the opening hours as follows:

My main concern is that Conroy's Bar is located in a highly residential area and that the Bar plans to have live and recorded music playing until 22.00 hours daily; twice a week to 02.00 hours. It was explained to me that the music will be in the basement area of the bar and the loudspeakers are set below the legal level such that it is impossible for the music to be 'turned up'. This is reassuring, but is nonetheless a huge difference to what happens at present when the neighbourhood is quiet from about 18.00 onwards. I am assured also, by the member of staff I talked to, that there will be staff at the door of the Bar to control the exit of customers.



Dear Sir/Madam,

I am to respond to the above license application with respect to Conroy's bar. My apologies for the lateness of this response but a particular event occurred very recently which has stimulated my response.

I am writing in my capacity as the Managing Director of SWRAC, which is a Specialist Independent College situated at 22 Sea Road, immediately opposite Conroy's bar. Our organisation works with young adults with Special Educational Needs. Ranging in age from 16 to 25. We have contracts with the Department of Education, as well as commissions by BCP Council to provide education to people who do not engage in mainstream education and have diagnoses of ADHD, Autism, Anxieties etc.

We have been occupants of Sea Road for nearly 4 years.

When the premises, 33 Sea Road, was operating as a café we had no problems at all with any interactions with our students.

Since opening as a bar we and our students have experienced one serious level of abuse from users of the bar (see copy of email trail below) and on many occasions we are hearing very loud shouting using the normal swear roads associated with drunken behaviour and now with serious abusive behaviour to one of our staff members. You will appreciate that this does not make for a conducive learning environment, particularly with the vulnerable students that attend our premises from Monday to Friday.

We are particularly concerned at the request to extend opening hours (to 8:00 am each day) as we feel this will exacerbate the potential for instances of unsociable behaviours. Please accept this email as our formal objection to this part of the extension request.

Up until very recently our objection would have been based upon concerns. However, below is an extract from a member of my staff who was directly impacted by the existing situation with the bar.

"on leaving work at about 5.25 pm today I was blocked in from leaving a designated parking bay (these parking bays are actually part of our property) by a woman in a white MPV type vehicle who was half on and half off the road on double yellow lines.

After waiting a while it was clear she was not aware I was there. I then proceeded to beep my horn. I did it once no response did it again no response and a third time no response.

I had no option but to get out and ask her. I went to the window but she still did not acknowledge me. A male who was drinking at Conroys Bar was talking to her from the other side. He proceeded to ask me what the fuck I was doing and came around to confront me. I told him that I had beeped 3 times and needed to get home so had to ask her if she could move forward so I could go home. The man was clearly drunk and very threatening in his body

language and communication. He was a tall and stocky man who was trying to intimidate me. I asked him not to be so aggressive and threatening and that I had not been rude to the driver in anyway in fact she dldn't even acknowledge me.

He clearly thought he had scared and intimidated me as I apologised in an attempt to diffuse the situation. if I had been more assertive I have no doubt he would have gone to hit me.

I got in my car and left the scene. I hope this is in CCTV. It causes me concern for our Learners Parents and Taxi Drivers and I am very disappointed that this Place was granted a licence so close to a College for Vulnerable young adults.

This incident has been recorded by our CCTV and has been reported to the Police. It clearly demonstrates behaviour that we are experiencing now and we are now concerned that any extension to the licensing hours will contribute further to these incidents.

Thank you for your attention in this matter and I look forward to hearing the outcome of the application in due course.

I write further to Warning Letters sent out to you by Dorset Police on the 12th and 20th April 2022.

It has been noted that when Dorset Police Licensing officers visited the premises, they witnessed various breaches of the conditions of your Premises Licence BH181870, which are listed below: -

- 2.6 Alcohol sold shall be ancillary to food prepared and served on/delivered from the premises;
- 2.1.1 Refresher training shall be provided at least once every 6 months. A record shall be maintained of all staff training and that record shall be signed by the person receiving the training and the trainer. The records shall be kept for a minimum of 12 months and made available for inspection by police, licensing or other authorised officers.
- 2.4.1 The CCTV system shall continually record and cover areas where alcohol is kept for selection and purchase by the public, whilst the premises is open for licensable activities. It shall operate during all times when customers remain on the premises.
- 2.4.2 All recordings shall be stored for a minimum period of 31days with correct date and time stamping. Recordings shall be made available immediately upon the request of Police or an authorised officer of the council throughout the preceding 31-day period. The CCTV system shall be updated and maintained according to police recommendations.
- 2.4.3 A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open to the public. This staff member must be able to show a Police or authorised council officer recent data or footage with the absolute minimum of delay when requested.
- 2.4.4 CCTV shall be downloaded on request of the Police or authorised officer of the council. Appropriate signage advising customers of CCTV being in operation, shall be prominently displayed in the premises.
- 2.4.5 A documented check of the CCTV shall be completed weekly to ensure all cameras remain operational and the 31 days storage for recordings is being maintained.

In reference to this first reported alleged breach, we draw your attention to the fact that it is an offence under Section 136 of the Licensing Act 2003 to carry on, or attempt to carry on, a licensable activity otherwise than under and in accordance with your licence, or knowingly allow it

I also take this opportunity to make you aware that should you fail to comply with your licensing conditions, you may be prosecuted and will lose your due diligence defence.
