## LICENSING COMMITTEE AND SUB COMMITTEE – PROTOCOL FOR PUBLIC SPEAKING

## 1. Introduction

- 1.1 This protocol for public speaking applies to Licensing Committee and Sub Committee hearings in relation to matters including the licensing of alcohol, regulated entertainment, late night refreshment, gambling, sex establishments and hackney carriage and private hire drivers, vehicles and operators, as set out in Part 3.3 of the Council's Constitution.
- 1.2 These matters are considered in accordance with relevant legislation and associated regulations including the Licensing Act 2003 (as amended by the Police Reform and Social Responsibility Act 2011), the Gambling Act 2005, Part II and Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982 (as amended by Section 27 of the Policing and Crime Act 2009) and the Local Government (Miscellaneous Provisions) Act 1976.

## 2. Conduct of Hearings

- 2.1 Chair welcomes everyone, matters of general housekeeping are dealt with, notification that the hearing may be recorded for live and subsequent broadcast on the Council's website, reminder to switch mobile phones to silent, etc.
- 2.2 Chair asks everyone present to introduce themselves and state their role.
- 2.3 Chair checks that all persons who have given notice of their intention to speak and any person who wishes to withdraw a representation or wishes not to speak have been identified.
- 2.4 Chair explains proposed procedure and order of speaking for hearing as set out in Appendix A or B of this protocol as appropriate. All parties confirm agreement or make representations on procedure proposed.
- 2.5 Licensing Officer's report is presented.
- 2.6 Parties speak in the order agreed.
- 2.7 With the exception of hackney carriage and private hire hearings, parties who are speaking should not repeat the information which they have already given in writing in their representation. They will be able to expand on the written information given, provided the information remains relevant. Any additional information should be limited to the grounds of their representation(s). For example, if they are objecting on the grounds of Public Nuisance, then they should confine their comments to matters relating to Public Nuisance.

- 2.8 Members of the Licensing Committee or Sub Committee may ask questions after each party has spoken and once all parties have spoken. Parties will be allowed to ask questions through the Chair.
- 2.9 Once all parties have been heard, the parties will be given the opportunity to sum up. Party who spoke first to go last. The hearing will then conclude.
- 2.10 Members will deliberate in private with the clerk and legal representative as appropriate present.
- 2.11 The decision will be taken by the Committee and notification of the decision will be given as follows:
  - 2.11.1 For Licensing Act 2003 and Gambling Act 2005 hearings, determination must be within the period of five working days beginning with the day or the last day on which the hearing was held in accordance with the relevant Regulations, unless otherwise specified (for example, the issuing of a counter notice following objection to a TEN, in which case the determination must be at the conclusion of the hearing).
  - 2.11.2 For Sex Establishment and other hearings, where possible determination will be within the period of five working days beginning with the day or the last day on which the hearing was held.
  - 2.11.3 For Hackney Carriage and Private Hire hearings, notification of the decision will be given at the conclusion of the hearing, followed by a written decision letter where possible within the period of five working days beginning with the day or the last day on which the hearing was held.
- 2.12 Notification of the decision will include information for all parties of any right of appeal as appropriate.

## 3 General points

- 3.1 Hearings convened under the Licensing Act 2003 and the Gambling Act 2005 and associated regulations may be held remotely as required, if the Chairman agrees it is expedient to do so in the circumstances.
- 3.2 The hearing may be adjourned at any time at the discretion of the Members.
- 3.3 Members may amend the procedure at any time if they consider it to be in the public interest or in the interest of a fair hearing.
- 3.4 The Sub Committee may decide to conduct all or part of a hearing in nonpublic session in accordance with the relevant Regulations and/or where exempt information is likely to be disclosed.

- 3.5 The Chair may exclude any person from a hearing for being disruptive.
- 3.6 Meetings of the Licensing Committee in public session are recorded by the Council for live and subsequent broadcast on its website.
- 3.7 The hearing will take the form of a discussion.
- 3.8 Only persons (or their representatives) who have made an application, are subject to an application or have submitted a written representation or objection to the Licensing Authority under the relevant Act are permitted to speak at the hearing.
- 3.9 Any further information to support an application, representation, objection or notice (as applicable) can be submitted before the hearing. It may only be submitted at the hearing with the consent of all parties in accordance with any relevant Regulations. Wherever possible the Licensing Authority encourages parties to submit information at the earliest opportunity to allow sufficient time for this to be considered before the hearing and avoid the need for adjournment.
- 3.10 If a party has informed the Authority that they do not intend to participate, or be represented at the hearing, or has failed to advise whether they intend to participate or not, the hearing may proceed in their absence.
- 3.11 For other matters which are the responsibility of the Licensing Committee and not included in this protocol, the Meeting Procedure Rules in Part 4D of the Council's Constitution in relation to public questions, statements and petitions shall apply. This includes such matters as making recommendations on relevant licensing policies, approving the level of fees charged by the Council, and making decisions on tariffs charged by the Public Carriage Trade.

## Appendix A

## Proposed procedure and order of speaking for hearings (other than hackney carriage and private hire hearings)

- 1. The Licensing Officer presents report.
- 2. Questions of the Licensing Officer on their report. Members of the Sub-Committee to go first, then the applicant/licence holder.
- 3. Applicant will make their Application.
- 4. Questions of the Applicant by all parties, Members of the Committee/Sub-Committee to go first.
- 5. Responsible Authorities and Other Persons will make their representations.
- 6. Questions of the Responsible Authorities and Other Persons. Members of the Committee/Sub-Committee to go first.
- 7. All parties will be given an opportunity to sum up (with the party who spoke last to go first). The hearing will then conclude.
- 8. Sub-Committee will deliberate in private with Legal Adviser and Clerk present. (Councillors new to Licensing may observe but will not take part in the decision making).
- 9. Notification of the Sub Committee's decision will be given in accordance with the requirements of the Licensing Act and Gambling Act regulations. For other hearings, where possible determination will be within the period of five working days beginning with the day or the last day on which the hearing was held.
- 10. The notification of decision will include information about the right of appeal as appropriate.

## Appendix B

## Proposed procedure and order of speaking for Hackney Carriage and Private Hire hearings

- 1. The Licensing Officer presents their report.
- 2. Questions of the Licensing Officer on their report. Members of the Sub-Committee to go first, then the applicant/licence holder.
- 3. Applicant/licence holder presents their case.
- 4. Questions of the applicant/licence holder by all parties, Members of the Committee/Sub-Committee to go first.
- 5. All parties will be given an opportunity to sum up (with the party who spoke last to go first). The Hearing will then conclude.
- 6. Sub-Committee will deliberate in private with Legal Adviser and Clerk present. (Councillors new to Licensing may observe deliberations but will not take part in the decision making).
- 7. Notification of the decision will be given following deliberations at the conclusion of the hearing, to be followed by a written decision letter where possible within the period of five working days beginning with the day or the last day on which the hearing was held.
- 8. The Legal Adviser will advise parties of any right of appeal as appropriate at the conclusion of the Hearing. Information about the right of appeal as appropriate will also be included in the written decision letter.

## Background

- 1. An application for the renewal of the Sex Establishment Licence was made on 24 April 2024 in accordance with Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982.
- A Sex Establishment Licence permits the premises to be used as a sex shop business for selling, hiring, exchanging, lending, displaying or demonstrating sex articles or other things intended for use in connection with, or for the purpose of stimulating or encouraging sexual activity or acts of force or restraint which are associated with sexual activity.
- 3. The licence can only be issued for a twelve month period.
- 4. A copy of the application is attached at Appendix 1.
- 5. A map showing the location of the premises is attached at Appendix 2.
- 6. The premises have traded as a sex shop for approximately 15 years under the current ownership. A copy of the current Sex Establishment Licence is attached at Appendix 3.
- 7. One complaint has been received by the Licensing Authority in connection with these premises which was from the objector in April 2024. She complained about the wording used in the window display which related to a female sex organ. As a result, it was removed from the advertising display.

## Consultation

- 8. Applicants must give notice of the application by publishing an advertisement in the local newspaper together with notice displayed on the premises for a period of 21 days.
- 9. In considering the application the Council must have regard to any observations submitted to them and any objections of which notice has been sent to them under Schedule 3, paragraph 10(15) of the 1982 Act, which provides that any objections must be made in writing within 28 days of the application.
- 10. As a result of the consultation 1 objection was received against the renewal of the licence. A copy of the objection is attached at Appendix 4.

- 11. Consent from an objector must be obtained before the name or address is revealed to the applicant. The objector gave consent allowing the applicant to open up communication to address the issues of concern raised.
- 12. A pack from the applicant containing a copy of the communication letters sent to mediate with the objector, together with signed petitions in support from businesses and customers is attached at Appendix 5. There are 17 signatures from local businesses and 172 customers.
- 13. 56 letters of support were received from customers and members of the local community. A copy of the letters are attached at Appendix 6.
- 14. The application was consulted with Dorset Police and no observations, or any objection, was received from them.
- 15. As the renewal application had been submitted before the expiration date of the current licence the premises are permitted to continue to operate under the terms of the current licence under its determination.

## **Options Appraisal**

- 16. Before making a decision, Members are asked to consider the following matters:
  - The submissions made by or on behalf of the applicant together with the information supplied in Appendix 5.
  - The objection received.
  - The letters received in support of the application.
  - Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982.

## Summary of financial implications

17. No financial implications have been identified.

## Summary of legal implications

- 18. If the application for renewal is refused the applicant may appeal the decision to the Magistrates' Court, unless the application was refused under grounds (c) or (d) above at "Reasons for Recommendation", in which case the applicant can only challenge the refusal by way of judicial review.
- 19. It should be noted that BCP Council's Sex Establishment Policy was quashed by way of a Judicial Review in February 2022. Essentially the Court were of the view that some consultation responses had been considered by the Council as based purely on moral views and not equality. No decision has yet been taken whether a new policy is to be developed by the new Licensing Committee.
- 20. Local Authorities are not bound to have a Sex Establishment Policy and the nonexistence of a policy does not prevent an application being considered on its merits and in accordance with the legislation.

- 24. This Licence, which will remain in force until **26 April 2024**, unless it is revoked before that date, is granted on the terms and conditions and subject to the restrictions contained in regulations made from time to time by Bournemouth Borough Council under Paragraph 13 of the Third Schedule to the Local Government (Miscellaneous Provisions) Act 1982.
- 3. A CCTV system to be operated and maintained to the satisfaction of Dorset Police.
- 4. This licence shall be suitably framed and exhibited in a prominent position within that part of the premises to which the public are admitted.
- 5. A lobby entrance to the premises to be constructed to the satisfaction of the Building Control Officer.

#### General condition for Sexual Establishments

1.In the event of a conflict between these Regulations and any special conditions contained in a licence relating to a Sex Establishment the special conditions shall prevail.

2. The grant of a licence for a Sex Establishment shall not be deemed to convey any approval or consent which may be required under any enactment, byelaw, order or regulation other than Schedule 3 to the Local Government (Miscellaneous Provisions) Act 1982.

3. A refusals register shall be kept and made available for inspection by an authorised officer of the Council or Police Officer.

4. The Premises shall be maintained in good repair and condition.

5. Alterations or additions either internal or external and whether permanent or temporary to the structure, lighting or layout of the Premises shall not be made except with the prior approval of the Council.

6. The licence holder shall ensure a copy of the licence and of these Regulations are required to be exhibited in accordance with paragraph 14(1) of Schedule 3 to the Local Government (Miscellaneous Provisions) Act 1982 as amended and shall be reproduced to the same scale as those issued by the Council.

7. The copy of the licence required to be displayed shall be suitably framed and the copy of these Regulations shall be retained in a clean and legible condition.

#### Special Conditions for Sex Shops

#### Hours of opening

1.Except with the previous consent of the Council, a Sex Establishment shall not be open to the public before 09:00 hours and shall not be kept open after 06.00pm.

2.Except with the previous consent of the Council, a Sex Establishment shall not be open on Sundays or any Bank Holidays or any public holidays.

#### **Conduct and Management**

3.Where the licence holder is a body corporate or an unincorporated body, any change of director, company secretary or other person responsible for the management of the body is to notify the Council in writing within 14 days of such change and such written details as the Council may require in respect of any new director, secretary or manager are to be furnished within 14 days of a request of writing from the Council.

4. The Licensee or some responsible person nominated by him in writing for the purpose of managing the Sex Establishment in his absence and of whom details (including photographs) have been supplied to and approved in writing by the Council shall be in charge of and upon the Premises during the whole time they are open to the Public.

5. The Licensee shall maintain a register in which he shall record the name and address of anyperson approved under Regulations 8 or 9 hereof by the Council who is to be responsible for managing the Sex Establishment in his absence and the names and addresses of those employed in the Sex Establishment. Any change in the particulars shall be recorded forthwith in the register and the register shall be

kept available for inspection by the Police and by authorised officers of the Council.

6.The licence holder shall provide the Council with a list of all staff employed at the premises and shall advise the Council and Dorset Police in writing of all staff changes within fourteen days of such changes.

7. The licence holder shall retain control over all portions of the premises as defined on the approved premises plans, and shall not let, licence or part with possession of any part of the licensed premises.

8. The licence holder shall nominate a Duty Manager for the premises on each occasion they are open to the public.

9.The name of the person responsible for the management of a Sex

Establishment (whether the licensee or a manager approved by the Council) shall be prominently displayed within the Sex Establishment throughout the period during which he is responsible for its conduct.

10.The licence holder shall ensure the name of the Duty Manager is displayed in the foyer or reception of the premises so the name can easily be viewed by Police or authorised Council officers carrying out an inspection of the premises.

11. The Licensee shall maintain good order in the Premises.

12. The Duty Manager shall be responsible for ensuring the premises operate in accordance with the conditions applicable to the sex establishment licence.

13. The Duty Manager shall remain on the premises while they are on duty save in the event of an emergency situation.

14.No person under the age of 18 shall be admitted to the licensed premises whilst the sex establishment licence is being used. A notice advising no admittance to persons under the age of 18 shall be prominently displayed at each public entrance to the premises.

15.No person under the age of 18 shall be employed to work at the licensed premises in any capacity, or allowed to work in the premises on a self-employed basis.

16.The premises shall follow the 'Think 25' initiative, whereby any customer who enters the premises who appears to be under the age of 25 shall be asked for age identification. The only ID accepted shall be photo identification such as a picture driving licence, a passport or a PASS ID.

17.An incident / refusal logbook shall be maintained at the premises. The incident / refusal log shall, as a minimum, give details of:

- Any persons refused entry to the premises and the reason for refusal
- Any persons ejected from the premises and the reason for ejection
- Any inappropriate behaviour by customers
- Any incidents of crime or disorder

18.The incident/refusal log shall show the date, the time of the incident, the name of the staff member reporting the incident, a brief description of the customer involved or staff member where appropriate and brief description of the incident and any action taken by staff.

19.The incident/refusal log shall be kept in a place where it can be easily accessed by staff working at the premises and all staff shall be aware of the procedure to follow.

20.The licence holder shall ensure the incident/refusal log is checked periodically, at least once a week, to ensure the log is being effectively used.

21.The incident / refusal log shall be made available for inspection to the Police and or authorised officer of the council on request.

22.The licence holder shall ensure that the public is not admitted to any part or parts of the premises other than those, which have been approved by the Council.

23.No part of the licensed premises shall be used by prostitutes for the purpose of solicitation or otherwise exercising their calling.

24. There shall be no touting for business for the premises by way of persons holding advertising boards, branded vehicles or personal solicitation outside or in the vicinity of the Premises.

25.The Licensee shall ensure that during the hours the Sex Establishment is open for business every employee wears a badge of a type to be approved by the Council indicating his name and that he is an employee.

#### Advertising, Premises Appearance and Layout

26.The Council shall not permit the display of any form of imagery or photographs that the Council believes could be construed as offensive to public decency.

27.No displayor advertisement of the activities permitted by the sex establishment licence shall be exhibited so as to be visible from outside of the premises except:

•any notice required by law, by these regulations, or by any condition of the sex establishment licence granted by the Council

•the name of the premises as specified in the sex establishment licence

•the hours of opening of the premises

•notice of any admission charge to the premises

unless the Council has given its prior consent in writing that such displayor advertisement maybe used.

27.No display, advertisement, word, letter, model, sign, placard, board, notice, device, representation, drawing, writing, or any matter or thing (whether illuminated or not) shall be exhibited so as to be visible from outside the Premises except: -

(i) Any notice of a size and in a form approved by the Council which is

required to be displayed so as to be visible from outside the Premises

by law, or by any condition of a licence granted by the Council.

(ii) Such display, advertisement, word, letter, model, sign, placard, board, notice, device, representation, drawing, writing, or any matter or thing as shall have been approved by the Council.

28.All windows must be dressed or designed so as to prevent persons outside the premises having a view of the interior.

29.No window shall contain any sign, advertising material, goods or display without the written consent of the Council.

30.The external doors to the Sex Establishment shall be fitted with a device to provide for their automatic closure and such devices shall be maintained in a good working order.

31Windows and openings to the Premises other than entrances shall not be obscured otherwise than with the consent of the Council but shall have suspended behind them, in a position and at an attitude approved by the Council, opaque screens or blinds of a type and size approved by the Council. This regulations shall not be construed as lessening the obligation of the licensee under Regulation 28 hereof.

32.No fastenings of any description shall be fitted upon any booth or cubicle within the Sex Establishment nor shall more than one person (including any employee) be present in any such booth or cubicle at any time, unless by reason of disability.

33.Lighting in all parts of the Premises as approved by the Council shall be in operation continuously during the whole of the time that the Sex

Establishment is open to the public.

34.The number, size and position of all doors or openings provided for the

purposes of the ingress and egress of the public shall be approved by the Council and shall comply with the following requirements: -

(i) All such doors or openings approved by the Council shall be clearly

indicated on the inside by the word "exit".

(ii) Doors and openings which lead to parts of the Premises to which the public are not permitted to have access shall have notices placed over them marked "private".

(iii) Save in the case of emergency no access shall be permitted through the Premises to any unlicensed premises adjoining or adjacent.

35.No alterations or additions either internal or external and whether permanent or temporary to the structure, lighting or layout of the premises shall be made except with the prior approval of the Council.

36.The Licensee shall make provision in the means of access both to and within the Sex Establishment for the needs of members of the public visiting to the Sex Establishment who are disabled where applicable and accordance with the Equalities Act 2010.

#### Use

37.A Sex Shop shall be conducted primarily for the purpose of the sale of goods by retail.

38. No change of use of any portion of the premises from that approved by the Council as a Sex Shop shall be made until the consent of the Council has been obtained thereto.

39.No change from a Sex Cinema to a Sex Shop or from a Sex Shop to a Sex Cinema shall be effected without the consent of the Council.

40.Neither Sex Articles nor other things intended for use in connection with, or for the purpose of stimulating or encouraging sexual activity or acts of force or restraint which are associated with sexual activity shall be displayed, sold, hired, exchanged, loaned or demonstrated in a Sex Cinema.

#### Goods available in Sex Establishments

41.All Sex Articles and other things displayed for sale, hire, exchange or loan within a Sex Shop shall be clearly marked to show to persons who are inside the Sex Shop the respective prices being charged.

42.All printed matter offered for sale, hire, exchange or loan shall be available for inspection prior to purchase and a notice to this effect shall be prominently displayed within the Sex Establishment.

43.No sexually explicit film (including DVD or video) shall be sold, supplied or exhibited unless it has been passed by the British Board of Film Classification as R18 or such other classification and bears a certificate to that effect and is a reproduction authorised by the owner of the copyright of the film, DVD or video film so certified.

44.No film or video/DVD/Blu-ray film or computer game/memorystick or compact disc shall be exhibited, sold or supplied unless it has been passed by the British Board of Film Classification, or such other authority performing a similar scrutinising function as may be notified to the licensee by the Council, and bears a certificate to that effect and is a reproduction authorised by the owner of the copyright of the film or video/DVD/Blu-ray film or computer game/memorystick or compact disc, so certified.

45.The Licensee shall without charge, display and make available in the Sex Establishment such free literature on counselling on matters related to sexual problems as may be published by the Family Planning Association and by such other similar organisations as maybe specified by the Council. Such literature is to be displayed in a prominent position approved by the Council adjacent to all cash collection points in the Sex Establishment.

#### Safety

46. The licensee shall take all reasonable precautions for the safety of the public and employees.

47. The licensee shall comply with any fire prevention and safety measures that maybe required of him by the Council.

48. The premises shall be provided with fire appliances suitable to the fire risks of the premises and such fire appliances shall be maintained in proper working order and shall be available for instant use.

#### **Notification of Changes**

49.Where the consent of the Council is required to a change under Regulations 21, 22 or 37 hereof, the application for consent shall be accompanied by such specifications, including plans, of the proposed changes as the Council shall require in respect of their consideration of the application.

50.Where there is a material change in the particulars given or referred to in the application for the grant or, where the licence has been renewed, in the most recent application for the renewal of the licence, the licensee shall notify the Council of the change as soon as reasonably practicable after it has taken place PROVIDED THAT it shall be necessary for the licensee to notify the Council of that change under this Regulation where the Council have given their consent under Regulation 21, 22 or 37, or where the Council have been notified of that change under Regulation 7.

## Letter of Objection Dated – 17 May 2024

Hi

I would like to object to the licensing of Easy Tiger as a Sex Establishment, namely a sex shop.

I have seen BCP's former Sex Establishment Licensing policy, adopted by full council after debate and then quashed by the High Court in a judicial review. However, the contents of the policy are an indication of what is reasonable in Bournemouth by way of restrictions on where a sex shop should be licensed.

The location of this shop is opposite a public library and very near bus stops. Both should be available to children. The bus company offers children's tickets and the library has a children's section. Ex Parte Christian Institute makes it clear that at the time of hearing, although moral objections as to licensing a sex shop weren't then admissible, objecting to the moral character of some customers attracted to a sex shop were perfectly admissible. I am asking you to refuse to license at this location because it is near public transport and a public library, both of which should be accessible to children.

I have seen the current license for these premises which says that certain items are kept in the basement, has a plan attached which doesn't appear to comply with the conditions stated on the license to be required, that the interior of the shop shouldn't be visible from outside via the window display. There is also a list of items sold on the license application which doesn't include items which I have seen advertised outside on a A Boards.

Because of various apparent breaches of the license I would also ask you to refuse the license on grounds of suitability because of apparent breaches and an omission from the list of items stated to be sold. In addition the application states that certain items are kept in the basement, yet the public business rates area record states the basement is storage. It may be the area is still storage and the public can't browse through this type of item on display or that the public record is out of date, but I would encourage your department to question this. One type of item which is said to be kept in the basement has been advertised in a graphic display in the window, so it seems a bit pointless keeping them in the basement if you are going to have a large picture of one on display, albeit looking a bit like a microphone. The missing item from the application form is items consumed by the customers advertised as bulls something on the a board. I have seen displays which show the interior of the shop from the window in contravention of the license conditions, but have been told by licensing staff that this is approved by the chair of licensing when I sent one image of one.

A great deal of time and money has been expended on trying to attract people to Bournemouth Triangle to regenerate the area, including setting up arts events in the public area. However, the presence of a sex shop with a window display is not compatible with attracting the general public into the area so that public money has been wasted. Your Public Sector Equality Duty does not oblige you to license sex shops. You need to weigh up the impact of whether to license or not on all groups with protected characteristics who want to use this area, including pregnant women and those within the first year after childbirth who may be breastfeeding, women who may be with small children and children themselves as well as the groups that this sex shop is aimed at. My concern for children and those responsible for them, as well as other people who can't move away easily such as women or men waiting at a bus stop, that the people mentioned by the judge in exparte Christian Institute of questionable morals and attracted into the area by the sex shop will harass them. I have lived experience of breastfeeding, catching buses with small children and being pregnant and I was born as and identify as a women. Nothing would have induced me to visit this area with small children or whilst pregnant or breastfeeding and I still would walk up Poole Hill to catch a bus there rather than risk waiting at a bus stop outside a graphic display of advertising products designed to sexual stimulate. What you don't want is someone, particularly if they are intoxicated, noticing you are effectively a captive audience and forcing their attentions on you, the display having hit the mark and sexually stimulated the person looking at it.

This is not a moral objection, it is an objection based on the neighbourhood as the law allows. BCP has faced a very costly judicial review on the licensing policy for Sex Establishments by dismissing the complaints of women regarding street harassment. Please don't do this in making this decision but believe me and take my objection on this point seriously.

There is no legal presumption of licensing a sex establishment as there is for provision of alcohol and other items under the 2003 Licensing Act. It is for the applicant to prove that he should be licensed, not for you to prove that he shouldn't.

There is no requirement to prove harm when deciding to refuse a Sex Establishment License. The case law sometime cited in 2003 Licensing Act cases suggesting that there is a need to prove harm is widely considered to never have been good law, ie likely to be overturned on appeal because it is out of step with previous case law. In addition, it was decided before the current regime for sex establishment, being reported in 2008, whereas the current regime for sex shops post dates that, and did not incorporate that case law. This is a clear indication that it doesn't apply to sex shops. You do not have to prove that harm has taken place as a result of any of the breaches nor the location. You don't need to see a procession of women reliving the unpleasant experience of being harassed at bus stops to make a decision on this. I don't need to put a lone school child at that bus stop and then video them being harassed by one of the drunks about the contents of the window display because that would be highly exploitative and damaging.

I am writing to formally introduce myself and my business, White Tiger Europe Limited trading as Easy Tiger, in anticipation of the upcoming hearing for the approval of our sex establishment license. Our establishment, located at 27 The Triangle BH2 5SE, is designed to provide a safe, professional, and legally compliant venue for adult retail.

I am committed to ensuring that our business operates with the highest standards of integrity and respect for the community. Our establishment will strictly adhere to all relevant laws and regulations, including health and safety standards, zoning requirements, and operational guidelines.

I sold my chain of sex shops in 2019 but retained ownership of Easy Tiger in Bournemouth due to the significant community support and the value it provides to both local residents and visitors. Easy Tiger has become known for its friendly, warm, and welcoming shopping experience, attracting customers from beyond the local area. This community appreciation was evident during the initial licensing process in 2009 and continues to be reflected in the overwhelming support for our current renewal, despite receiving our **first-ever objection**.

We have always implemented a robust plan to ensure the security and well-being of our patrons, staff, and the surrounding neighbourhood. This includes comprehensive staff training, stringent age verification processes, and regular consultations with local law enforcement and community representatives. Furthermore, we are committed to fostering a positive relationship with our neighbours and addressing any concerns they may have promptly and effectively.

During the hearing, I look forward to discussing our application in detail and addressing any questions or concerns the committee may have. We believe that Easy Tiger is a valuable addition to the local economy, providing employment opportunities and contributing to the vibrancy of the community.

Because I appreciate the time and costs that occur to the taxpayer for a license hearing I will address in advance points that have not been addressed in the mediation between myself and the objector.

 Window displays. The Local Government Miscellaneous Act 1982 (as amended) is a very outdated Act that was set up when Sex Shops only sold pornographic material. The need for blacked out windows was needed to stop people seeing pornographic material. Today pornographic material like magazines and DVDs are nearly phased out and in the next 2 years I doubt we will stock these items.

In 2016 I purchased a shop in Salisbury that had been trading with a window display for over 20 years. I refurbished this store and in 2017 my store supported and sponsored Salisbury's first ever pride. Our window display was dedicated to the pride event and

tastefully advertised the event with rainbow point of sale material and a giant pride poster.

Someone objected to the council about this advertising as it was on a school route and the council made the shop black out the windows due to the complaint. I agreed to remove the Pride window display but the council officer decided that I was not allowed to advertise anything from that moment forward and I had to black out the windows which made the shop look seedy and dated.

I appealed the decision and went to Swindon Magistrate and County Court.

The District Judge heard the appeal and advised the council to mediate with me due to the potential costs that the council would incur if they did not mediate.

The judges points were:

- Although someone may find offence to a window display, in this case a gay pride event advertised, the council should use common sense enforcing the Local Government Miscellaneous Act1982 (as amended). In this case the enforcement of the Act to black out the windows because one person was offended.
- The council should not put in place restrictions on a business that were already covered by laws. Laws that if I broke I would end up with police involvement and a criminal record. The local authority couldn't simply presume that I would break the law especially as my livelihood depended on me respecting such Laws.
- If products are also found elsewhere on the high street without restriction, advantage shouldn't be given to retail competitors by the authority, as such restriction of enterprise constitutes an act of unfair competition.

I was happy to mediate with the council and after 10 minutes of discussions with the council and their legal advisors I was allowed window displays.

In 2024, I received one complaint, which is my only complaint to date. It concerned the wording on a boxed product that was part of a point of sale (POS) advertising campaign distributed to all retailers, including Superdrug, and also sold in public toilet vending machines. Upon receiving the complaint from the licensing officer, I promptly removed the products. Although clarification later allowed them to be displayed with minor modifications, I have chosen to keep them out of the window display.

The objections raised by the objectors regarding the 'Microphone' window displays pertain to massagers and massage guns. It's important to clarify that we sell these products as part of promoting sensuality in any relationship. Massaging, in this context, is not inherently sexual. Please find attached pictures showing what the objector refers to as 'Microphones.'



Our other window display of massagers was for the brand Theragun massager ('Microphone') which is also sold in John Lewis.



These items are clearly not designed for insertion and are not intended for sexual use

The objectors' imagination is unconstrained by reality

## 2. The Shop Location and customers.

The objectors' simplistic views on the shop's customers as dirty old drunks are nonsensical. The letters supporting the shop's license renewal demonstrate a diverse representation from the community, including many women who are regular customers.

There is no evidence provided by the objector that my shop causes 'the drunks' to gather in the Triangle. It is well-documented that the steps implemented during the Triangle's renovation are the actual cause of this congregation. I am actively collaborating with other traders who are striving to improve this area.

Moreover, there have been no reports of 'drunks' harassing people at bus stops, whether in a sexual or non-sexual manner.

I met with the objector at the license hearing for Wiggle and understand that, since the onset of COVID-19, she has been on a personal mission to close down all sex shops and sexual entertainment venues.

I respect and welcome the objector's democratic right to voice her concerns, but it is important to consider the significant cost to taxpayers, especially during times of financial strain for local authorities. It is evident from the objections to various SEVs and sex shops that the objector is often copying and pasting information from the internet. Many points in these objections are either untrue or lack supporting evidence.

I invited the Objector to the shop to see what she is objecting against, but she has refused.

How much longer can a keyboard warrior go on costing the council money?

On a more personal note, I have observed how a single objector can impact my staff, who thoroughly enjoy their work at Easy Tiger. Although the objector's disapproval and arguments against the shop appear muddled and confused, it nonetheless causes my staff to worry about the security of their jobs.

As humans, sexual intimacy is a natural part of our lives, and some individuals require assistance to achieve it. Providing a safe, welcoming, and friendly environment where they can purchase such items is essential. Healthy and fulfilling sexual relationships are crucial for our well-being and continuity as a species.

I understand and appreciate that some people choose not to be sexually active or have no desire for sexual activity. Like the objector, these individuals can simply choose not to enter a sex shop.

The support demonstrated and attached to this letter highlights the need for my store. I would appreciate it if you could take the time to visit the shop and read through the letters of support. These letters include endorsements from professional bodies as well as thoughtful messages from my customers.

My business supports several employees and contributes to a pension fund. I diligently pay all taxes, including VAT, PAYE, and Corporation Tax. Without this business, my contributions would be significantly reduced.

As you are aware, I pay an annual license fee that is significantly higher than those in other local authorities. If the shop were to close, this license fee revenue would be lost.

Thank you for considering our application. I am available at your earliest convenience for any further information or documentation you may require. I look forward to a favourable review and the opportunity to demonstrate our commitment to operating a reputable and responsible establishment.

## RE: Your letter of Objection to the licence at the above premises and Mediation

Thank you for your thought out and detailed objection regarding the licensing of Easy Tiger as a sex establishment. I appreciate the time and effort you have taken to articulate your concerns and the potential impact on the community, particularly children and other vulnerable groups.

Your reference to the former Sex Establishment Licensing policy and the High Court's decision provides a valuable context for understanding what constitutes reasonable restrictions on the location of such establishments in Bournemouth. The location of sex establishments are set out in the policy of the council which I have no control over. You could kindly ask them when the next consultation period will be and you will be able to raise your views and objections to sex shops including the location.

On granting the licence at 27 The Triangle (and previously at 8 The Triangle) the Council stipulated in the licence conditions that the store should be a mainly a LGBT+ lifestyle adult store. As such I stock much more than what you probably think is in a sex establishment, for example what you call 'the microphone' were Theragun massagers which are also sold in John Lewis. Also food supplements and protein shakes which are advertised on rotating A-boards which are also found in the likes of Holland and Barrett.

Yes we do sell sex toys but most are found in other shops on the High Street and even supermarkets have sex toy sections. The question about harm to the public must be raised against the likes of Tesco and Boots for selling sex toys for children who are more exposed to supermarkets than an over-18's shop like mine. To see a sex toy in my store you have to go into the shop where ID is required. In the likes of Tesco kids are left freely to wander the aisles including the sex toy section.

GP's and the NHS send people into the store for safe sex items along with the health products we sell.

I acknowledge your points regarding the visibility of the shop's interior from the outside, the discrepancies in the licence application, and the advertised items that are not listed on the application form. A full list of items would require reams of paper and thus these are classed as adult novelties, they have been for the past 20+ years with no objection but if you would like a complete list of items included I am more than happy to send them to you for your inspection? The reason for window displays is because we sell much more than sex items, the local authority didn't want a blacked out seedy shop and nor do my customers.

Restricting items in Easy Tiger that are also sold freely and without a licence by other shops on the high street would advantage other businesses and allow them to dominate the market. This is a breach of the Competitions Act and my human right to earn an honest living. This was highlighted to Wiltshire County Council in 2017 by the District Judge at Swindon County Court during a window display appeal.

We hardly sell any R18 DVDs and our shop space for 'adult toys and novelties' is less than Ann Summers. In the next 18 months to 2 years DVD sales will be zero thus negating the need for the licence and the annual renewal including the annual fees paid to the local authority. Until this point I will adhere to the licence and conditions as I have in the since 2004.

Your concerns about the basement storage being used. Bournemouth Borough Council Planning visited and inspected the Premises nearly 17 years ago and as Wilts and Dorset had been trading for over 30 years from the premises the 10 year rule applied and no planning or change of use

was needed. Thank you for your indepth research and bringing this to my attention. Rest assured I will look into why the records have not changed.

Your perspective on the Public Sector Equality Duty and the need to balance the impact on all groups, especially pregnant women, breastfeeding mothers, and children, is important. The lived experiences you have shared highlight the practical challenges and discomforts that may arise for the minority of the community. Most people have and enjoy sex. Some may need help from sexual aids or specific lubricants for assistance to succeed in happy and lengthy relationships, including making babies.

You didn't highlight the same objection for men or those of intersex. As a business we strive to be inclusive to all.

I feel you may have overlooked that the demographic of customers that come into my store which are approximately 50% adult females, Children under the age of 18 are not permitted and anyone looking under the age of 25 is challenged for ID.

Moreover, I recognise the effort and public investment aimed at revitalising Bournemouth Triangle. Ensuring that the area remains welcoming and family-friendly is crucial for its ongoing regeneration and success. When I moved into 27 The Triangle I set up the Triangle Traders association. My shop was one of twelve occupied units. By working together we managed to get the Triangle developed into what it is today. Although not perfect it is much better than the empty bus shelters that blighted the area 17 years ago. It has also encouraged more businesses into the area and we as a collective trading community are proud that the Triangle hasn't trended like the town centres of Poole and Bournemouth which are blighted with empty shop units.

I, along with Barry Alborough founded Bourne Free Pride which for years drove footfall into the town especially the Triangle. I do care about the Triangle and that is why I recently campaigned to get the rat infested planters changed outside the library and the public rubbish bins emptied regularly.

My business voluntarily joined and contributed to the Bournemouth BID this year. I also subscribe to the 'town centre link' sharing information on crime in the Triangle, and when requested support the Police with CCTV for the Triangle making it a safer and more welcoming place.

I recognise and fully appreciate your point regarding the harassment of drunk people in the Triangle. We all have had enough of this. This can only be stopped with the restriction of alcohol sales in the small off licences that blight the area and do not care who they sell alcohol to.

None of the people I have spoken to today in this area including a library worker have ever heard of any complaint of drunk people referencing my licensed premises in association with women or men.

There are very few buses that stop in the Triangle compared to many years ago. I completely understand you having to pass the Triangle to get your bus as I would travelling to and from Poole, the buses in the Triangle don't go to the same destinations as the Poole Hills bus stop.

Customers coming into my store travel from far and wide to visit the store and this town. They are from a wide demographic of people including councillors and your fellow peers at the

and loving relationships.

It was a pleasure to finally meet you face to face today and have a discussion prior to the hearing of Wiggle.

In response to your concerns in your email:

- Many of our products are FDA approved and go through more stringent processes than they would in the UK. This includes Lubricants.
- The staff always offer cleaners, sprays, foam and wipes with all purchases. We have a sign on the shop counter 'don't forget your toy cleaner'.
- Many products that you are concerned about these days are dishwasher safe negating the unfounded concern in your email about cleanliness.
- The majority of my customers are happy couples or solo customers who wanted individual adult novelties for sole use.
- I work very closely with Sexual Health Dorset and do not sell barrier methods you are mentioning as the sexual health industry has not produced an 100% effective solution to barrier lubricants. I do sell packs of CE certified condoms and give away free individual condoms.

- Your concern about my license and Herpes screening should be directed to Sexual Health Dorset. Thoroughly researching the Herpes virus it is not solely a sexual virus and to stigmatise Herpes in this way would have a negative effect on the detection and prevention of the virus. Herpes can be passed from person to person simply by touch. Herpes-zoster or Chicken Pox, part of the herpes virus family, is passed on in very young children which can cause shingles later on in life.
- I would not consider offering stop smoking products as I personally think these have the opposite effect and in some cases encourage smoking of vapes and the uptake of smoking real cigarettes including smoking addiction.
- Regarding Google street view. This is from 2002. Google automatically blurs out faces and also makes mistakes as you can also see it blurs out union flags, phones from the shop window next door etc. This window was the Jubilee window for which the shop won the Bournemouth Chamber of Commerce award for the best window display in the town.
- Yes there is adequate screening in the window display.
- The bus stop seating was removed in the Triangle in 2010 and a wall was built for people to sit on. The bus to and from Poole has not operated in the Triangle since 2009.
- You may have not seen sex toys displayed if you don't go to town centres. I have attached images of the shops in the high street displaying sex toys including Theragun at John lewis. My local pharmacy has clitoral stimulators advertised in the window next to signs selling Viagra. Nearly all toilets have vending machines for sex toys that will be seen by those of all ages.
- We do not sell pornagraphic material on our website so a pop up message was required but I will contact the people who run our website and get installed the 'are you 18 or over' button. Looking at other sites online I will probably be the first to do this. Your point is noted and will be acted on.

My main concern is not for my license but for the taxpayers' money in the crusade against Sexual Entertainment Venues. It is costing the council a fortune and the time haemorrhaged by those working for BCP Council. The time and money could be used in tackling your main concern - anti-social behaviour.

I am emailing as a nurse case manager for clients with spinal cord injury. I was made aware of a complaint in regard to the Easy Tiger shop in Bournemouth. I would like to professionally support the use of the sex shop as a valid and highly useful provider of items for my clients who have sustained injury. My clients are predominantly brain or spinal cord injured and the associate's neuropathy that occurs post injury can affect their sexual sensation as well as all other muscles groups. The loss of sexual sensation, libido, reduced confidence and the potential for a single lifestyle all contribute to very poor outcomes for my clients. However, as a nurse case manager my role is to assess holistically to restore as many aspects of their life as I can.

The loss of sexual function causes very real grief symptoms for which we generally treat with psychology, but this can take time. The use of sexual toys, aids and devices can actively stimulate the areas affected by the neuropathy injury and works very much in the same way as any other exercise to improve and potentially restore some or all of the sensation. This can lead to improved continence as well as sexual outcomes and of course fertility. My clients, many of whom did not have any sexual issues prior to their injury, are embarrassed, ill-informed and unsure about what to use or consider. Easy Tiger have staff able to assist with this who are open minded, discrete and educated in such areas so as to put my client at ease.

It is a basic human right to have access to a sex life and my clients are staunchly robust in their wishes to do so, as am I. Should the objections to this shop and others like it, proceed and result in these locations closing, then disabled clients will not be able to seek face to face advice, see the products and make informed decisions. Purchases over the internet can

lead to financial abuse and safeguarding issues therefore I always advocate for an in-person shopping experience in these areas.

Please can I note my support of this shop which has been hugely beneficial to a number of my clients, and I commend the staff and owner for the professionalism.

This is only evident by the sole objector out of over 400,000 people living in the BCP conurbation. ## Background

- 1. An application for a new premises licence under Section 17 of the Licensing Act 2003 was made on 23 May 2024.
- 2. The application is for a convenience store seeking the provision of late night refreshment on Fridays and Saturdays 23:00 to 02:00 and for the off sale supply of alcohol 06:00 to 23:00 from Sunday to Thursday and 06:00 to 02:00 on Fridays and Saturdays. A copy of the application is attached at Appendix 1.
- 3. The premises were previously occupied by Carphone Warehouse. A plan showing the location of the premises is attached at Appendix 2.

## Consultation

- 4. The application was served on all responsible authorities and the applicant has confirmed that the statutory notices were displayed on site and published in the local newspaper.
- 5. The application resulted in 10 representations from local residents under the prevention of crime and disorder, public safety, public nuisance and protection of children from harm licensing objectives. Copy representations are attached at Appendix 3.
- 6. Dorset Police also made representation under the prevention of crime and disorder, and public safety licensing objectives. Dorset Police indicated that mediation was ongoing, and that agreement was forthcoming. At the time of writing the report, conditions have not yet been agreed between the applicant and Dorset Police. A copy of the representation is attached at Appendix 4.
- 7. There were no other representations from any of the other responsible authorities or any other person.

## **Options Appraisal**

- 8. Before making a decision, Members are asked to consider the following matters: -
  - The representations made by six other persons.
  - The submissions made by or made on behalf of the applicant.
  - Mediated Conditions agreed with Dorset Police.

- The relevant licensing objectives, namely the prevention of crime and disorder, public safety, prevention of public nuisance and protection of children from harm.
- The Licensing Act 2003, Regulations, Guidance and Council's Statement of Licensing Policy.

On first appointment, all staff employed at the premises will receive training on the Licensing Act 2003 including input on preventing underage sales, preventing sales of alcohol to people who are drunk and any other relevant matters. Training shall be regularly refreshed at no less than annual intervals. The training must be recorded and be accessible on the premises and made available for inspection upon request of a Police Officer or an authorised officer of a Responsible Authority or (in the case of online training) within 48 hours.

b) The prevention of crime and disorder

A CCTV system will be in operation at the premises and recorded images shall be retained for a period of 28 days. CCTV images will be provided to the police and other responsible authorities as soon as practicable and in any case within 48 hours of a request for such images, subject of the provisions of the DPA.

c) Public safety

An incident register will be maintained at the premises and made available to the authorities on request.

d) The prevention of public nuisance

A register of refusals of alcohol will be maintained at the premises. The register will be made available for inspection by the Police and an authorised officer of a Responsible Authority.

## e) The protection of children from harm

The premises will adopt a 'Challenge 25' policy. This means that if a customer purchasing alcohol appears to be under the age of 25, they will be asked for proof of their age, to prove that they are 18 years or older. Posters will be on display advising customers of the 'Challenge 25' policy.

The only forms of identification that will be accepted will bear their photograph, date of birth and a holographic mark and/

or ultraviolet feature. Examples of appropriate identification include a passport, photocard driving licence, military ID, and Home Office approved proof of age ID card bearing the PASS hologram.

## NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

# Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

## Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is A British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A current passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A current Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- A current passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A current Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
  - evidence of the applicant's own identity such as a passport,
  - evidence of their relationship with the European Economic Area family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and
  - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
    - (i) working e.g. employment contract, wage slips, letter from the employer,
    - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
    - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
    - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

**Original documents must not be sent to licensing authorities.** If the document copied is a passport, a copy of the following pages should be provided:-

(i) any page containing the holder's personal details including nationality;

(ii) any page containing the holder's photograph;

(iii) any page containing the holder's signature;

(iv) any page containing the date of expiry; and

(v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

## Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

	Christchurch Road, Boscombe	The Boscombe Engagement Hub is located at 561 Christchurch Road and is the workplace for a team of people delivering a government funded regeneration programme aimed at addressing the areas multiple social needs. We have occupied the premises since 2022 and in our interactions with the local community have become aware of high levels of unreported crime in relation to shoplifting and drug dealing and recognise that the area has a disproportionately large unemployed population (9.5% of population in the Boscombe West ward). We witness, or hear about, on a frequent basis, people openly drinking, and dealing and taking drugs in the street, causing ASB and verbal and physical abuse to members of the public.
		We have received verbal abuse in the Boscombe Engagement Hub on more than one occasion (which has included a death threat to a member of staff). There appears to be high demand for low-cost alcohol. We are concerned the proposed license will cause an increase in crime and disorder in the area, and on the street.
		The Prevention of Public Nuisance:
		We are concerned an increase of establishments authorised to sell alcohol in the central Boscombe area will invariably lead to an increase in individuals drinking in the streets.

Today I have observed a group of individuals loitering behind the Bodrum 573 building drinking at 2pm in Romelia Lane. A member of the public has also come to the Hub to express their concern and I asked them to contact 111 to report

A man outside Corals was drunk at 4pm with a beer bottle in his hand shouting obscenities at residents and workman at 4pm

## Public Safety:

Broken glass and empty alcoholic drink bottles can often be seen in an around the central Boscombe area. This presents risk of injury, through cuts and lacerations, and through touching and standing on the items. Such an example would be the broken glass on the side of the road/pavement outside the strip of shops between the Precinct and Crescent during w/c 10*th* June 2024, and empty alcoholic bottles regularly left outside the entrance to the Royal Arcade.

561 Christchurch Road, which is applying for a license to serve alcohol is also very close to the main Christchurch Road, where there are raised pavements to allow pedestrians to the road, and also located in close proximity to a recognised ASB hotspot in Romelia Lane, where groups of youths have been gathering, drinking alcohol, smashing bottles and shouting at local residents. A female resident has stated that she is afraid to leave her premises at times. The 573 property has also been the site of theft attempts.

The NHS are about to convert the inside of the BCHA building opposite McDonald to an emergency mental health intervention centre. There should therefore be concern at the number of licensed premised in close proximity to a facility that is there to help vulnerable people in a crisis situation.

The Protection of Children from Harm:
The central Boscombe area is a pedestrian thoroughfare, with a large volume of school children often walking through the area on their way to and from school. A large number of children frequent McDonalds, which is immediately beside the Riveira bar, which has just reopened to sell alcohol and opposite 561 Christchurch Road, which is just applying for a license to serve alcohol. There is an inherent danger of children being caught up in the middle of drunken situations.
In addition, The My Little Teddy charity opening in 569 Christchurch Road, opposite the Riveira bar, and in close proximity to 561 Christchurch Road, supports vulnerable children rehoused by BCP, with children leaving on site.
Finally, there are numerous large flats adjacent to the site which may accommodate family homes.

As such, I am in the process of mediating proportionate and meaningful conditions to ensure that the Licensing Objectives of the Prevention of Crime and Disorder, and Public Safety, are promoted by restricting the ABV of beers/ciders/lagers, in addition to crime prevention measures to include a member of staff on the premises at all times it is open for licensable activity who is able to access CCTV.

This condition is needed in order to safeguard both staff and customers in this late night environment.
