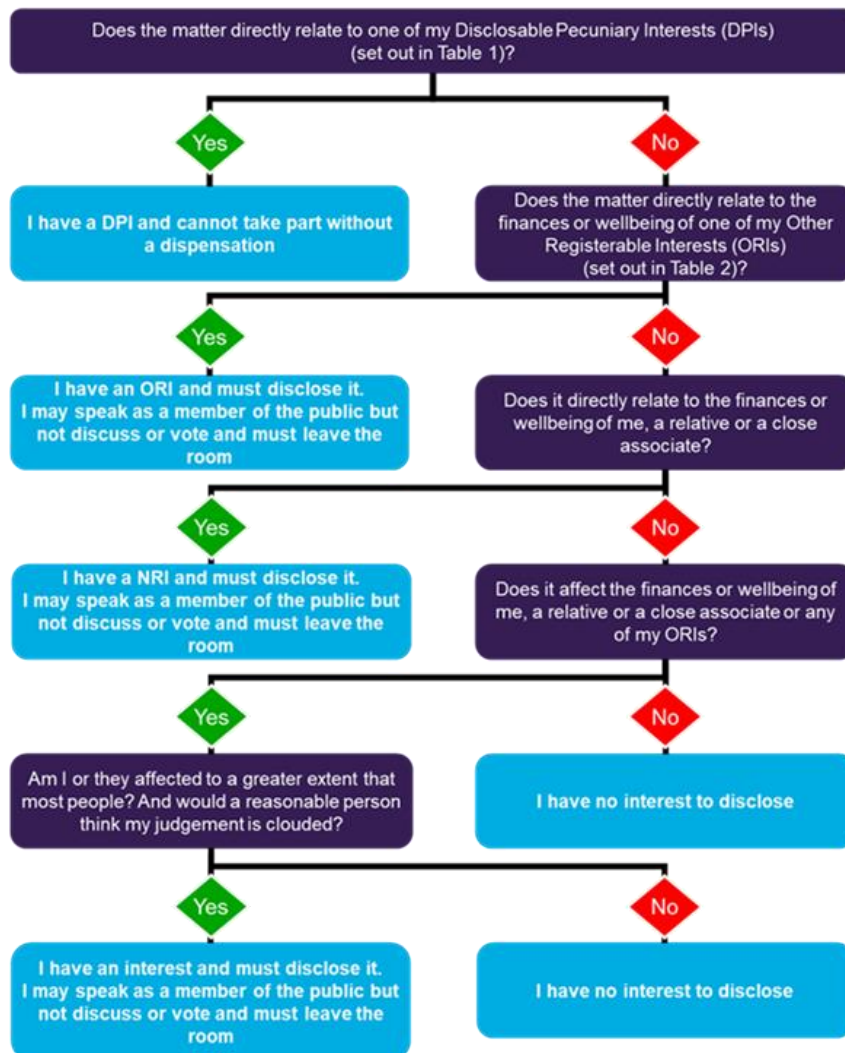


## Maintaining and promoting high standards of conduct

### Declaring interests at meetings

Familiarise yourself with the Councillor Code of Conduct which can be found in Part 6 of the Council's Constitution.

Before the meeting, read the agenda and reports to see if the matters to be discussed at the meeting concern your interests



What are the principles of bias and pre-determination and how do they affect my participation in the meeting?

Bias and predetermination are common law concepts. If they affect you, your participation in the meeting may call into question the decision arrived at on the item.

#### Bias Test

In all the circumstances, would it lead a fair minded and informed observer to conclude that there was a real possibility or a real danger that the decision maker was biased?

#### Predetermination Test

At the time of making the decision, did the decision maker have a closed mind?

If a councillor appears to be biased or to have predetermined their decision, they must NOT participate in the meeting.

### Selflessness

Councillors should act solely in terms of the public interest

### Integrity

Councillors must avoid placing themselves under any obligation to people or organisations that might try inappropriately to influence them in their work. They should not act or take decisions in order to gain financial or other material benefits for themselves, their family, or their friends. They must declare and resolve any interests and relationships

### Objectivity

Councillors must act and take decisions impartially, fairly and on merit, using the best evidence and without discrimination or bias

### Accountability

Councillors are accountable to the public for their decisions and actions and must submit themselves to the scrutiny necessary to ensure this

### Openness

Councillors should act and take decisions in an open and transparent manner. Information should not be withheld from the public unless there are clear and lawful reasons for so doing

### Honesty & Integrity

Councillors should act with honesty and integrity and should not place themselves in situations where their honesty and integrity may be questioned

## **LICENSING COMMITTEE AND SUB COMMITTEE – PROTOCOL FOR PUBLIC SPEAKING**

### **1. Introduction**

- 1.1 This protocol for public speaking applies to Licensing Committee and Sub Committee hearings in relation to matters including the licensing of alcohol, regulated entertainment, late night refreshment, gambling, sex establishments and hackney carriage and private hire drivers, vehicles and operators, as set out in Part 3.3 of the Council's Constitution.
- 1.2 These matters are considered in accordance with relevant legislation and associated regulations including the Licensing Act 2003 (as amended by the Police Reform and Social Responsibility Act 2011), the Gambling Act 2005, Part II and Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982 (as amended by Section 27 of the Policing and Crime Act 2009) and the Local Government (Miscellaneous Provisions) Act 1976.

### **2. Conduct of Hearings**

- 2.1 Chair welcomes everyone, matters of general housekeeping are dealt with, notification that the hearing may be recorded for live and subsequent broadcast on the Council's website, reminder to switch mobile phones to silent, etc.
- 2.2 Chair asks everyone present to introduce themselves and state their role.
- 2.3 Chair checks that all persons who have given notice of their intention to speak and any person who wishes to withdraw a representation or wishes not to speak have been identified.
- 2.4 Chair explains proposed procedure and order of speaking for hearing as set out in Appendix A or B of this protocol as appropriate. All parties confirm agreement or make representations on procedure proposed.
- 2.5 Licensing Officer's report is presented.
- 2.6 Parties speak in the order agreed.
- 2.7 With the exception of hackney carriage and private hire hearings, parties who are speaking should not repeat the information which they have already given in writing in their representation. They will be able to expand on the written information given, provided the information remains relevant. Any additional information should be limited to the grounds of their representation(s). For example, if they are objecting on the grounds of Public Nuisance, then they should confine their comments to matters relating to Public Nuisance.

- 2.8 Members of the Licensing Committee or Sub Committee may ask questions after each party has spoken and once all parties have spoken. Parties will be allowed to ask questions through the Chair.
- 2.9 Once all parties have been heard, the parties will be given the opportunity to sum up. Party who spoke first to go last. The hearing will then conclude.
- 2.10 Members will deliberate in private with the clerk and legal representative as appropriate present.
- 2.11 The decision will be taken by the Committee and notification of the decision will be given as follows:
  - 2.11.1 For Licensing Act 2003 and Gambling Act 2005 hearings, determination must be within the period of five working days beginning with the day or the last day on which the hearing was held in accordance with the relevant Regulations, unless otherwise specified (for example, the issuing of a counter notice following objection to a TEN, in which case the determination must be at the conclusion of the hearing).
  - 2.11.2 For Sex Establishment and other hearings, where possible determination will be within the period of five working days beginning with the day or the last day on which the hearing was held.
  - 2.11.3 For Hackney Carriage and Private Hire hearings, notification of the decision will be given at the conclusion of the hearing, followed by a written decision letter where possible within the period of five working days beginning with the day or the last day on which the hearing was held.
- 2.12 Notification of the decision will include information for all parties of any right of appeal as appropriate.

### **3 General points**

- 3.1 Hearings convened under the Licensing Act 2003 and the Gambling Act 2005 and associated regulations may be held remotely as required, if the Chairman agrees it is expedient to do so in the circumstances.
- 3.2 The hearing may be adjourned at any time at the discretion of the Members.
- 3.3 Members may amend the procedure at any time if they consider it to be in the public interest or in the interest of a fair hearing.
- 3.4 The Sub Committee may decide to conduct all or part of a hearing in non-public session in accordance with the relevant Regulations and/or where exempt information is likely to be disclosed.

- 3.5 The Chair may exclude any person from a hearing for being disruptive.
- 3.6 Meetings of the Licensing Committee in public session are recorded by the Council for live and subsequent broadcast on its website.
- 3.7 The hearing will take the form of a discussion.
- 3.8 Only persons (or their representatives) who have made an application, are subject to an application or have submitted a written representation or objection to the Licensing Authority under the relevant Act are permitted to speak at the hearing.
- 3.9 Any further information to support an application, representation, objection or notice (as applicable) can be submitted before the hearing. It may only be submitted at the hearing with the consent of all parties in accordance with any relevant Regulations. Wherever possible the Licensing Authority encourages parties to submit information at the earliest opportunity to allow sufficient time for this to be considered before the hearing and avoid the need for adjournment.
- 3.10 If a party has informed the Authority that they do not intend to participate, or be represented at the hearing, or has failed to advise whether they intend to participate or not, the hearing may proceed in their absence.
- 3.11 For other matters which are the responsibility of the Licensing Committee and not included in this protocol, the Meeting Procedure Rules in Part 4D of the Council's Constitution in relation to public questions, statements and petitions shall apply. This includes such matters as making recommendations on relevant licensing policies, approving the level of fees charged by the Council, and making decisions on tariffs charged by the Public Carriage Trade.

## Appendix A

### **Proposed procedure and order of speaking for hearings (other than hackney carriage and private hire hearings)**

1. The Licensing Officer presents report.
2. Questions of the Licensing Officer on their report. Members of the Sub-Committee to go first, then the applicant/licence holder.
3. Applicant will make their Application.
4. Questions of the Applicant by all parties, Members of the Committee/Sub-Committee to go first.
5. Responsible Authorities and Other Persons will make their representations.
6. Questions of the Responsible Authorities and Other Persons. Members of the Committee/Sub-Committee to go first.
7. All parties will be given an opportunity to sum up (with the party who spoke last to go first). The hearing will then conclude.
8. Sub-Committee will deliberate in private with Legal Adviser and Clerk present. (Councillors new to Licensing may observe but will not take part in the decision making).
9. Notification of the Sub Committee's decision will be given in accordance with the requirements of the Licensing Act and Gambling Act regulations. For other hearings, where possible determination will be within the period of five working days beginning with the day or the last day on which the hearing was held.
10. The notification of decision will include information about the right of appeal as appropriate.

## Appendix B

### **Proposed procedure and order of speaking for Hackney Carriage and Private Hire hearings**

1. The Licensing Officer presents their report.
2. Questions of the Licensing Officer on their report. Members of the Sub-Committee to go first, then the applicant/licence holder.
3. Applicant/licence holder presents their case.
4. Questions of the applicant/licence holder by all parties, Members of the Committee/Sub-Committee to go first.
5. All parties will be given an opportunity to sum up (with the party who spoke last to go first). The Hearing will then conclude.
6. Sub-Committee will deliberate in private with Legal Adviser and Clerk present. (Councillors new to Licensing may observe deliberations but will not take part in the decision making).
7. Notification of the decision will be given following deliberations at the conclusion of the hearing, to be followed by a written decision letter where possible within the period of five working days beginning with the day or the last day on which the hearing was held.
8. The Legal Adviser will advise parties of any right of appeal as appropriate at the conclusion of the Hearing. Information about the right of appeal as appropriate will also be included in the written decision letter.

## Background

1. The application to vary the premises licence, under Section 34 of the Licensing Act 2003, was made by Marston's plc on 22 October 2025. A copy of the application is attached at Appendix 1.
2. A plan showing the location of the premises is attached at Appendix 2.
3. The premises have held a premises licence, issued under the Licensing Act 2003, since 25 November 2005 when the licence was converted from the previous Justices' Liquor Licence under the 1964 Act. A copy of the current premises licence is attached at Appendix 3.
4. Following receipt of representations, the application was amended to request that regulated entertainment and films be restricted to 23:00 hours but with a retention of the proposed licensable activity of retail sale of alcohol midweek until 23:00 hours and on Friday and Saturday until 12 midnight.
5. This amendment resulted in one representation being withdrawn.
6. The application also offered to implement a Noise Management Plan.

## Consultation

7. The application was served on all responsible authorities and the applicant confirmed that the statutory notices were displayed on the premises and published in the local newspaper.
8. Environmental Health have made representation as a responsible authority and there have been 20 representations made by other persons and a petition with 23 signatures against the application.
9. A copy of the representations are attached at Appendix 4
10. Dorset Police have agreed the following conditions, which will be imposed on the licence, should the application be granted:-
  - a) SIA door supervisors shall be provided for the period of one hour before and until one hour after the undertaking of England Football Tournament games, further the premises licence holder shall conduct a written risk assessment to determine the need for door staff during any high risk events, a copy of which shall be made available for inspection by a Police officer and shall deploy door supervisors in

accordance with the outcome of the risk assessment. In any event a minimum of 2 SIA will be employed from 20.00 on New Years Eve until the close of business.

- b) Any person working at the premises in a security capacity shall clearly display his or her name badge at all times whilst on duty and shall wear high visibility arm bands.
- c) Polycarbonate/plastic drink ware is to be used by all persons during any high risk events, all alcoholic and 'soft' drinks are to be decanted by premises staff into such drink ware at the point of sale.

11. No other representations were received from any of the other responsible authorities.

### **Options Appraisal**

12. Before making a decision, Members are asked to consider the following matters: -

- The representations made by Environmental Health and other persons.
- The conditions agreed with Dorset Police.
- The submissions made by or made on behalf of the applicant.
- All four licensing objectives are relevant to this application namely the prevention of crime and disorder, public safety, prevention of public nuisance and protection of children from harm.
- The Licensing Act 2003, Regulations and Guidance.
- BCP Council's Statement of Licensing Policy in particular Section 12 which deals with the licensing objective of the prevention of public nuisance. Paragraphs 12.5 and 12.6 highlight factors which should be considered and paragraphs 12.9 and 12.10 deal with outside areas and how they are expected to be managed.

### **Summary of financial implications**

13. An appeal may be made against the decision of Members by the applicant or any person making a representation to the Magistrates' Court which could have a financial impact on the Council.

### **Summary of legal implications**

14. If Members decide to refuse the application or attach conditions to the licence which the applicant does not agree to, the applicant may appeal to the Magistrates' Court within a period of 21 days beginning with the day that the applicant is notified, in writing, of the decision.

Application is made to vary the Premises Licence for the Fiveways.

The premises is to have a significant refurbishment which addresses updating both the interior and exterior of the premises in anticipation for the property being relaunched under the Marston's brand of Grandstand.

As the name indicates the brand is focussed around the provision of sporting events both nationally and locally whilst retaining a strong food offer and being attractive to a wide range of the community including families and females. The premises will have two new dedicated menus and will seek become more fundamentally involved within the local community by way of championing local amateur teams.

This will provide a significant enhancement to the overall operation of the premises.

Application is therefore made to vary the Premises Licence in respect of three elements which are as follows:

##### 1. Layout

Application is made to amend the plan annexed to the Premises Licence as per drawing JMDA 1826/04/001A a copy of which is attached and as follows:

##### Internally

- The removal of a partition
- Installation of new bench seating to the games area.
- Installation of new booth seating adjacent to the ladies toilet.
- Relocation of Gaming machines
- Appropriate redecoration throughout.

##### Externally

- To licence external areas being front patio and beer garden:  
Sunday to Thursday until 23:00 hours  
Friday and Saturday until 12 midnight.
- To include temporary external bar location to be utilised at peak times so as to provide additional supervision to external area.

##### 2. Licensable activities.

- (a) Application is made to extend the hours in relation to the existing licensable activities retail sale of alcohol, regulated entertainment and late night refreshment. Such extension is limited to Friday and Saturday when the proposed hours are 11:00 until 01:00 hours and to permit Sunday until 00:00 hours.
- (b) Application is made to add licensable activities of films (indoors and outdoors) and indoor sporting events Sunday to Thursday 11:00 to 00:00 hours and Friday and Saturday 11:00 until 01:00 hours
- (c) Opening hours.

A consequential amendment to opening hours is sought so as to permit the premises to be open on Friday and Saturdays until 01:30 hours.

##### 3. Conditions

The application has allowed an opportunity for the conditions endorsed upon the Licence to be reviewed. It is proposed that the following condition should be added:

Children under the age of 16 shall not be permitted entry to the premises after 22:00 hours unless accompanied by an adult, attending a pre-booked function or dining.

It is considered that the amendments in conjunction with the refurbishment will continue to promote the four licensing objectives.

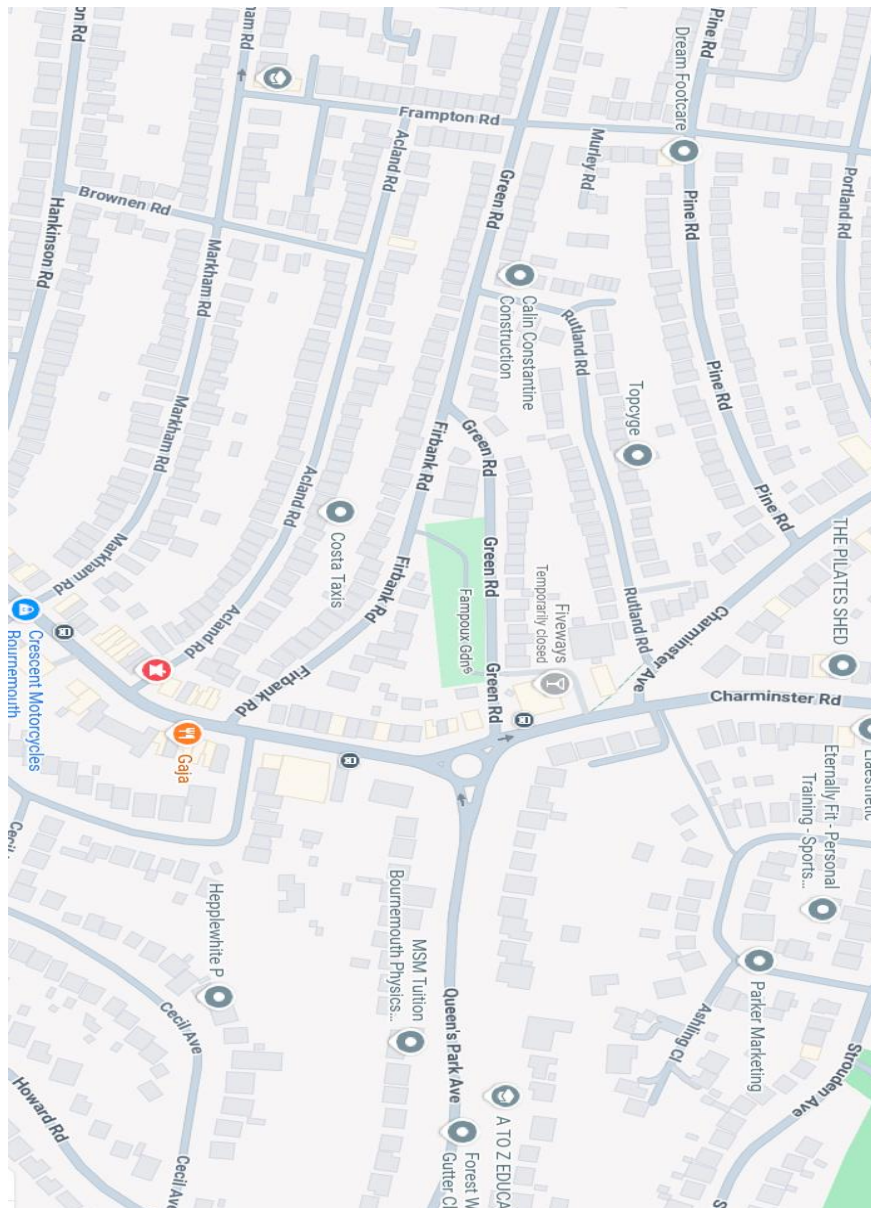

## Annex 1 – Mandatory conditions

### Mandatory Conditions (Sections 19,20,21 LA 2003)

- 1.1. There shall be no sale or supply of alcohol when there is no designated premises supervisor in respect of this premises licence or at a time when the said premises supervisor does not hold a personal licence or when his/her licence is suspended.
- 1.2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

### The Licensing Act 2003 (Mandatory Licensing Conditions) (Amendment) Order 2014

- 1.3.
  1. The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  2. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises –
    - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to -
      - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
      - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
    - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
    - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
    - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti- social behaviour or to refer to the effects of drunkenness in any favourable manner;
    - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 1.4. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 1.5.
  1. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  2. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  3. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request,

before being served alcohol, identification bearing their photograph, date of birth and either -

- (a) a holographic mark, or
- (b) an ultraviolet feature.

1.6. The responsible person must ensure that -

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
  - (i) beer or cider: ½ pint;
  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

#### The Licensing Act 2003 (Mandatory Conditions) Order 2014

1.7.

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
2. For the purposes of the condition set out in paragraph 1 -
  - (a) “duty” is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
  - (b) “permitted price” is the price found by applying the formula —

$$P = D + (D \times V)$$

Where –

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) “relevant person” means, in relation to premises in respect of which there is in force a premises licence -
  - (i) the holder of the premises licence,
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
  - (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
  4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.  
  
(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Mandatory Conditions – (Embedded Restrictions) – Attached as part of Conversion Application under Transitional Grandfather Rights Restaurants/Hotels

- 1.8. The abovementioned restrictions on the times permitted to sell alcohol do not prohibit the supply to, or consumption by, any person of alcohol in any premises where they are residing.
- 1.9. The abovementioned restrictions on the times permitted to sell alcohol do not prohibit the sale of alcohol to a trader or club for the purposes of the trade or club.
- 1.10. The abovementioned restrictions on the times permitted to sell alcohol do not prohibit the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered.
- 1.11. The abovementioned restrictions on the times permitted to sell alcohol do not prohibit the taking of alcohol from the premises by a person residing there.
- 1.12. The abovementioned restrictions on the times permitted to sell alcohol do not prohibit the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of persons so supplied.
- 1.13. The abovementioned restrictions on the times permitted to sell alcohol do not prohibit the supply of alcohol for consumption on premises to persons employed there for the purposes of the businesses carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.
- 1.14. The abovementioned restrictions on the times permitted to sell alcohol do not prohibit the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces.

## **Annex 2 – Conditions consistent with the operating schedule**

### Prevention of Crime and Disorder

- 2.1. 2.1 All staff involved in the sale of alcohol shall receive training on the law relating to prohibited sales, the age verification policy adopted by the premises and the conditions attaching to the premises licence.
  - 2.1.1 Refresher training shall be provided at least once every 12 months.
  - 2.1.2 A record shall be maintained of all staff training and that record shall be signed by the person receiving the training and the trainer. The records shall be kept for a minimum of 12 months and made available for inspection by Police, Licensing or other authorised officers.
- 2.2. An incident log shall be kept at the premises. The log shall include the date and time of the incident and the name of the member of staff who has been involved, and made available on request of an authorised officer of the Council or the Police, which shall record the following:-
  - (a) any incidents of disorder
  - (b) any faults in the CCTV system/or searching equipment/or scanning equipment
  - (c) any refusal of the sale of alcohol
  - (d) any visit by a relevant authority or emergency service
  - (e) all crimes reported to the venue
  - (f) all ejections of patrons
  - (g) all seizures of drugs or offensive weapons
  - 2.2.1 This log shall be checked on a weekly basis by the DPS of the premises.
- 2.3. A CCTV system shall be installed to cover all entry and exit points enabling frontal identification of every person entering in any light condition.
  - 2.3.1 The CCTV system shall continually record and cover areas where alcohol is kept for selection and purchase by the public whilst the premises is open for licensable activities. It shall operating during all times when customers remain on the premises.
  - 2.3.2 All recordings shall be stored for a minimum of 31 days with correct date and time stamping. Recordings shall be made available immediately upon request of Police or an authorised officer of the Council throughout the preceding 31 days period.
  - 2.3.3 The CCTV system shall be updated and maintained according to Police recommendations.
  - 2.3.4 A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open to the public. This staff member must be able to show a Police or authorised Council Officer recent data or footage with the absolute minimum of delay when requested.
  - 2.3.5 CCTV shall be downloaded on request of the Police or authorised officer of the Council. Appropriate signage advising customers of CCTV being in operation shall be prominently displayed in the premises.
  - 2.3.6 A documented check of the CCTV shall be completed weekly to ensure all cameras remain operational and the 31 days storage for recordings is being maintained.
- 2.4. The premises shall maintain membership of the Town Watch scheme (or any successor scheme) a senior member of staff shall attend all Town Watch meetings unless an emergency arises preventing such attendance and the premises will support Town Watch initiatives.

### Prevention of Public Nuisance

- 2.5. Music shall be turned down to background level at least 30 minutes before closing time.
- 2.6. Windows shall be closed by 23:00.
- 2.7. A member of staff shall ask customers to leave quietly at closing time.
- 2.8. There shall be signs at exit reminding customers to leave quietly.

#### Protection of Children from Harm

- 2.9. Challenge 21 shall be operated at the premises where the only acceptable form of identification are (recognised photographic identification cards such as a driving licence or passport/holographically marked PASS scheme identification cards).

- 2.9.1 Appropriate signage advising customers of the policy shall prominently be displayed in the premises.

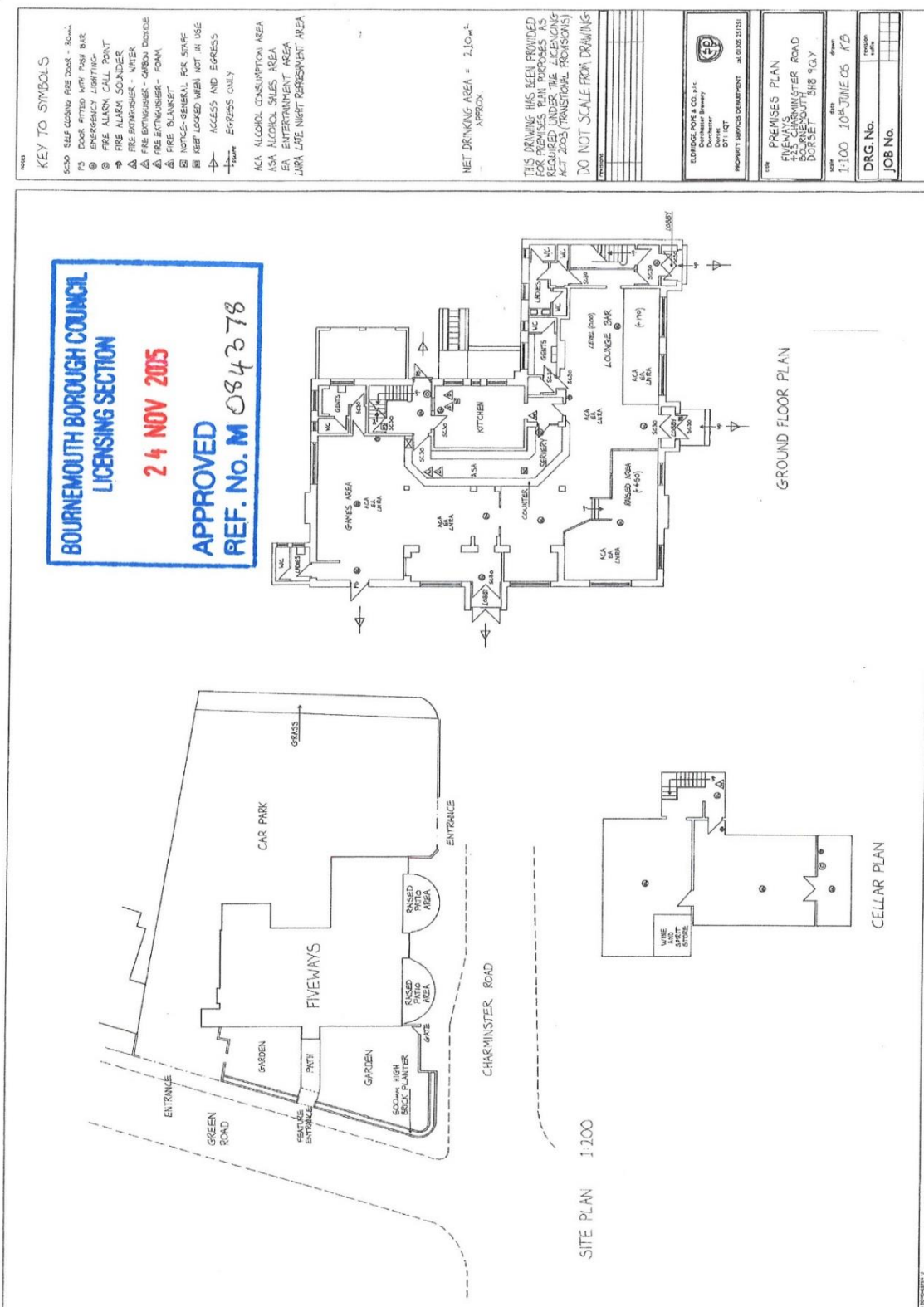



If this was allowed to stay open until midnight/ 1am and host live music, play music or show films then local residents would have their quality of life and sleep disturbed, beyond a reasonable time. Not everyone wants to be up until midnight / 1am every weekend, especially not the children who live in house near the pub. I understand the application seeks to extend the licensed hours and introduce live music and televised sport outdoors. I have serious concerns that granting this variation would have a negative impact on the local community.</p> <p>1. Prevention of Crime and Disorder</p> <p>Extending the licensing hours and encouraging outdoor gatherings late into the evening will likely attract increased antisocial behaviour and criminal activity. The area already experiences issues with disorderly conduct linked to the premises, and I am aware that drug use and related activities have taken place there. Allowing later hours and additional outdoor entertainment will only exacerbate these problems. Also, there are lots of times when people venture over to the Famboux Gardens and unsolicited events take place.</p> <p>2. Public Safety</p> <p>An increase in the number of patrons outside the premises, particularly during live music events or televised sports, raises significant safety concerns. There is a greater risk of fights, noise-related confrontations, and incidents of intoxication that could threaten both customers and nearby residents. Often people wonder up and down the road, smashing glasses and littering.</p> <p>3. Prevention of Public Nuisance</p> <p>Outdoor music and televised sport will generate substantial noise, particularly during the evening and night-time hours. This will disturb local residents, disrupt families, and reduce the overall quality of life in the neighbourhood. Many of us live close to the premises and already experience noise from patrons leaving the venue; extended hours will make this much worse.</p> <p>4. Vomiting up our wall and leaving drinks in our flower bed.</p>

	<p>We struggle to park outside our property at the best of times due to trades men parking their work vans down our road rather than using the car park as they will be at the pub for 3-4 hours which then indicates drunk driving.</p> <p>This is a road full of families with young children and we work 6 days a week where we are up early and if the pubs outside area is open till 1am this is going to be very disruptive and concerning for us and our neighbours.</p> <p>This will cause more havoc down our road with issues of not getting parked, drunk drivers hitting residents cars and anti social behaviour. With a late licence, it is also likely that the pub will attract intoxicated patrons from other pubs / restaurants that do not have a late licence, also increasing noise levels late at night.</p> <p>Protecting children from harm: There are several schools and nurseries in the vicinity, so lots of children and teenagers live or pass through the area regularly. I am concerned about the plan to show outdoor films and sports, especially when alcohol is involved, as it could mean children are exposed to drunken or rowdy behaviour, and there's an increased chance of anti-social behaviour affecting them.</p>



	<p>This kind of activity goes against the rules that are meant to protect children and doesn't help to build a safe and healthy community.</p> <p>Public safety: The proposed location of the external bar, outdoor screen, and flexible tiered seating is adjacent to a busy bus stop, that children and families use frequently which also increases the risk to public safety.</p> <p>It is also very close to both Charminster Rd, including the busy roundabout, and Green Rd and vehicles driving past will be distracted by the outdoor screen, increasing the risk of accidents.</p> <p>Preventing crime and disorder: Increased footfall and extended 'late license' opening hours will no doubt increase the anti-social behaviour in the area as well as crime. We are already exposed to arguments and fights on Green Road from intoxicated patrons of The Fiveways. There is also already a litter problem on Green Road due to pub patrons drinking cans and bottles of alcohol outside the pub and in their cars before, during and after visiting the pub, and leaving the empty cans and bottles on the road. The use of drugs in vehicles of people visiting the pub is also frequent.</p> <p>I request that these aspects are taken into consideration, and to refuse the application made by Marston's Plc.</p>



21	<p>Dear Sir/Madam.</p> <p>I have lived at ..... since Summer 2010. My Mum &amp; Dad helped me purchase my flat. Approx 5 years later, Mum &amp; Dad were offered first refusal of the upstairs flat. They ....., buy to let - and they've had permanent tenants since. My tenant's upstairs have children.</p> <p>We live on Green Road, a lovely area near a lot of schools. The houses/flats are mainly owned outright by those who are working. There are also a lot of older people in the area who have families and children. There are so many sought after schools in the area.</p> <p>The houses in the local area are very old. Houses on Green road were build in 1907/1908. The pub closed at a decent hour in those times.</p> <p>Everything is usually quiet, until there is a disturbance at the Fiveways - or when good weather/happens - and the noise becomes unbearable in the pub beer garden.</p> <p>There is an issue with ASB/drug dealing at Fampoux Gardens - at various times of the day. This is increased in the summer months - people are going from the Fiveways to the park and back, or meeting cars on Green Road. This issue happens during the day, I only noticed when I was deep cleaning my property, and was stood outside putting refuse sacks into the boot of my car.</p> <p>The floodlighting in the carpark which has a public right of way doesn't work, so there is no protection for members of the public who might walk through there during the night. The surface of the carpark has potholes 3-4 inches deep and regularly floods - making the potholes invisible. These fill with ice/black ice during the winter. The disabled bay in the carpark isn't patrolled by the pub staff, so is abused by those who do not have a blue badge.</p>

	<p>Before providing this statement, I tried telephoning the Fiveways to speak with the General Manager Hayley Connell. Unfortunately, the phone rang out and there was no way to leave a message.</p> <p>In my honest opinion, I feel it's such a shame that locals weren't consulted; let alone informed about their intentions to request an extension of the on licence hours. Especially the fact that they've applied for planning permission, to install TV screens in the garden. I tried to speak with Marston's head office, but there is no public facing telephone number listed.</p> <p>The previous General Manager/Landlady would involve the community. If anything was happening at the pub, or there was a disturbance - she'd be at the end of the telephone. She'd always welcome our feedback and there was positive engagement.</p> <p>My main concerns are:</p> <ul style="list-style-type: none"> <li>• extra noise/asb generated from having the TV's in beer garden. Both the TV's and sound + noise from patrons.</li> <li>• extra noise generated from those going from the bar to the garden to watch the new TV's</li> <li>• change of on licence hours until 0100 on Friday/Saturday night, and 0000 on a Sunday. - Will alcohol be served in the garden until that time? Will there be extra security?</li> <li>• Extra demand on local parking along Green Road.</li> </ul> <p>In Marston's defence they used to discuss issues of noise and ASB. This area manager was amazing back then - they tried bringing the drey's in at 0640am on a Monday morning. Stephanie fixed it.</p> <p>I telephoned Stephanie from Marston's this morning, she didn't seem to be bothered anymore. Dear Michelle,

I am pleased that your clients have agreed to reduce the hours which they wish to carry out regulated entertainment. My principal concern, however, remains the proposed outdoor entertainment and how this might be effectively controlled.

At this stage, I would need to review the proposed Noise Management Plan before I can assess whether it is sufficiently comprehensive to address my concerns, or whether the prospect of outdoor entertainment for extended periods each day would still present an issue.

As we are fast approaching the last date for representations, I will make a representation on the grounds of Prevention of Public Nuisance whilst we continue our discussions with the aim of agreeing a way forward.

I would therefore be grateful if you could provide a draft Noise Management Plan setting out in detail how your clients intend to control noise arising from entertainment, customers, and other operational activities, both inside and outside the premises.
