


#### Maintaining and promoting high standards of conduct

#### Declaring interests at meetings

Familiarise yourself with the Councillor Code of Conduct which can be found in Part 6 of the Council's Constitution.

Before the meeting, read the agenda and reports to see if the matters to be discussed at the meeting concern your interests



What are the principles of bias and pre-determination and how do they affect my participation in the meeting?

Bias and predetermination are common law concepts. If they affect you, your participation in the meeting may call into question the decision arrived at on the item.

#### Bias Test

In all the circumstances, would it lead a fair minded and informed observer to conclude that there was a real possibility or a real danger that the decision maker was biased?

#### **Predetermination Test**

At the time of making the decision, did the decision maker have a closed mind?

If a councillor appears to be biased or to have predetermined their decision, they must NOT participate in the meeting.

#### Selflessness

Councillors should act solely in terms of the public interest

#### Integrity

Councillors must avoid placing themselves under any obligation to people or organisations that might try inappropriately to influence them in their work. They should not act or take decisions in order to gain financial or other material benefits for themselves, their family, or their friends. They must declare and resolve any interests and relationships

#### **Objectivity**

Councillors must act and take decisions impartially, fairly and on merit, using the best evidence and without discrimination or bias

#### **Accountability**

Councillors are accountable to the public for their decisions and actions and must submit themselves to the scrutiny necessary to ensure this

#### **Openness**

Councillors should act and take decisions in an open and transparent manner. Information should not be withheld from the public unless there are clear and lawful reasons for so doing

#### Honesty & Integrity

Councillors should act with honesty and integrity and should not place themselves in situations where their honesty and integrity may be questioned

#### Leadership

Councillors should exhibit these principles in their own behaviour. They should actively promote and robustly support the principles and be willing to challenge poor behaviour wherever it occurs

- In response to a query raised regarding reduced turnover, the Board was advised that the mini golf concession had been closed for a period, resulting in decreased turnover.
- The Board was advised that the mini golf course had experienced a period of closure and had only been open during school holidays and on weekends for several months, which resulted in a decrease in income.
- In response to a query regarding the funds contributed by BCP Council, the Board was advised that the council's contributions had still exceeded the revenue generated by the Lower Central Gardens.

RESOLVED that the Board agree the financial statements and the Letter of Representation for the financial year 2023-24.

# **Background**

- 1. The Lower & Central Gardens Trust (LCGT) was created in 1873 under an Indenture (legal agreement) between BCP Council's predecessor body the Bournemouth Commissioners and Sir George Eliot Meyrick Tapps Gervis. The day-to-day control and management of the Lower Central Gardens and hence the charity, was varied by s.29 Bournemouth Borough Council Act 1985. This vested in the Council the general power to use, control and manage the Lower Central Gardens.
- 2. The object of the charity is the provision of open space for the purpose of recreation and enjoyment of the public.
- 3. The Trust Board must hold at least two ordinary meetings each year. One such meeting in each year must involve the physical presence of those Trust Board Members who attend the meeting. Other meetings may be held in person or by such suitable electronic means, including video-conferencing, as the Trust Board decide provided that the form chosen enables the Trust Board Members both to see and to hear each other.

#### 2025 - 2026 Events Programme

- 4. South Coast Makers Market (1 day monthly 2025) new small event proposal for 6 stalls within the tunnel path of local businesses and charities as an extension to the Bobby's market using hardstanding.
- 5. Arts by the Sea Festival (26 28 September 2025) annual festival with arts installations and performances throughout the Lower Gardens, Seafront and Town Centre.

- 6. Run Bournemouth (11 12 October 2025) annual running event primarily along the seafront between Bournemouth and Hengistbury Head with some elements utilising Pavilion Terrace, Street Food Corner and Pinewalk Bandstand.
- 7. Bournemouth Christmas (Nov & Dec 2025) annual ice rink and Christmas lighting through the Lower Gardens. This year will see the entire contract through external organisation which will be contract managed through the events team.
- 8. Bournemouth Bay Run (Mar / April 2026 date TBC) annual running event with race village in front of the bandstand.
- 9. As per previous years there are a number of smaller minor events planning such as duck races and bandstand performances dealt with by the events team under the delegated authority for Commercial Operations.

#### **Art & Makers Market**

- 10. The Art and Makers market went out for tender in 2024 with the view for an operator to take over the bookings and general maintenance of the space. No submissions were received so the operation is continuing in house for May.
- 11. The team received a proposal from Makers Space Markets to run the Art & Makers market from June 2025 December 2025 as a trial with the view to undertake it longer term.
- 12. The proposed operator will take full responsibility of the site including bookings, general maintenance, paperwork and marketing. References and paperwork have been received as well as approval from the council's procurement team.
- 13. The Commercial team will undertake spot checks during this time and a full review will be undertaken in December 2025 for options for the operation for 2026 onwards.

#### Westover Road Kiosk Concession Retender

- 14. The kiosk, currently trading as Picnic Park Deli, was installed on behalf of the Trust Board in 2016. It was part of a restoration of the Westover Gardens area which had become very tired. This unit replaced an old wooden kiosk next to the old aviary.
- 15. A tender exercise was carried out in 2016 for an operator and the current operator won that process. They have improved the area, and along with the new aviary building and cutting back some of the vegetation, the area is now busier, less intimidating and has less anti-social behaviour issues than previously.
- 16. The original lease term was for approximately five and half years but has had two extensions (a two year and one year extension) while resources have been sought to assist with the tender process.
- 17. Procurement have advised we are unable to offer any further extensions and must now go out to full tender.

#### **Tender process**

- 18. The tender will be drafted working with colleagues across Procurement, Estates and Legal to ensure the tender and the subsequent lease meets the legal requirements.
- 19. It will be an open tender advertised on the <a href="https://www.supplyingthesouthwest.org.uk">www.supplyingthesouthwest.org.uk</a> website.
- 20. The operator will be required to fit out the unit and maintain the kiosk during the term of the lease. They will also be required to provide external seating and to keep the leased area clean.
- 21. Whilst the tender will have a strong financial element, it will also seek to ensure a high quality offer selling hot and cold drinks, cakes and pastries and foods distinct from the variety of other foods available in the Gardens. The unit is not designed for high volume fried food and low-quality foods are not expected to be on sale.
- 22. There will be an expectation of the operator to use environmentally friendly products such as sustainable cardboard plates and wooden cutlery.
- 23. The need for some additional storage, decking (STPP) and event space has become evident during the current operation. There is currently a limited alcohol licence for 'on-sales' only.

#### Post tender

24. Once the tender deadline closes, the Environment and Procurement Teams will evaluate the submissions awarding to the successful applicant and arrange for the new lease to take effect from January 2026.

#### **Grounds Maintenance**

25. General grounds maintenance activities continue to be delivered throughout the gardens. 5,000 bulbs were planted this Spring to enhance the visual and biodiversity of the planted stock held.

#### Summary of financial implications

26. By going to the open market through a tender process for the Kiosk, it will allow for best value to be obtained.

#### Summary of legal implications

27. All appropriate legal requirements as part of the retendering process will be followed

#### Summary of human resources implications

# Summary of sustainability impact

29. The land contained within the Trust continues to be managed in a way that seeks to protect its future and move to more sustainable planting to improve biodiversity and growing impacts of climate change.

30. Access to good-quality, well-maintained public spaces can help to improve physical and mental health by encouraging individuals to walk more, to play sport, or simply to enjoy a green and natural environment. Parks create important opportunities for social integration and health and wellbeing outcomes. Lower Central Gardens positively contributes towards this outcome.
