<p>Please give a general description of the premises (please read guidance note 1)          Restaurant and Take-Away.          Note that the premises had the benefit of a Premises Licence (BH084454) that was held by Pyramids Bournemouth Ltd ("the company") which authorised Films, Live and Recorded Music, Late Night Refreshment and the sale of alcohol for consumption on the premises until 2 a.m. daily (5a.m. on Fridays and Saturdays for films, recorded music and late night refreshment and until 4 a.m. on Tuesdays for late night refreshment) with an additional 30 minutes opening each day beyond the terminal hour for late night refreshment.          The sole director of the company was the applicant's husband.          Whilst the director was abroad and without apparent reference to him, the company's accountant dissolved the company but took no steps to preserve the licence by making the appropriate applications within the 28 day period. The licence therefore lapsed.          When this came to light in mid-July 2019, the accountant advised the applicant and her husband that he would make an administrative application to Companies House to restore the</p>

company to the Register and the effect of such a restoration would have been to retrospectively reinstate the licence as if the same had never lapsed. He advised that the process would take two to three weeks.

The applicant therefore gave a number of Temporary Event Notices to permit the premises to operate on a Friday and Saturday night to provide late night refreshment until 5 a.m. whilst the company was restored to the Register

On 6<sup>th</sup> August 2019, it transpired that the advice given by the accountant was wrong in that a restoration to the Register could not be dealt with administratively and that he should have made an application to the County Court to restore the company – a process that might take two or three months, if not longer.

This application is therefore made for the grant of a new licence to effectively replace the lapsed licence.

The premises are situated in the Central Bournemouth Cumulative Impact Area and the applicant is well aware of the consequences of that.

In addressing that issue, the applicant will point to the following:-

Although this is an application for a new licence, it is not an application for an additional licence where none had previously existed;

The application is considerably more restricted than the lapsed licence in that it does not include any form of regulated entertainment nor, most significantly, the sale of alcohol;

The conditions that are proposed in the application are designed to ensure that if granted, this licence would not add to the cumulative impact, not least (but not only) because they include a requirement to have SIA registered door supervisors when there was no such condition previously.

The premises have successfully operated over recent weekends under a series of Temporary Event Notices.

Please also note that the hours now proposed (which are more restricted than before, particularly regarding the opening times of the premises) reflect the hours that are permitted under the planning consent relating to the premises but also contain restrictions on the hours permitted for the sale of hot food. The present application also reflects those restrictions.

For those reasons, the applicant is confident that the grant of this application will not have any adverse impact on any of the licensing objectives.

**a) General – all four licensing objectives (b, c, d and e)** (please read guidance note 10)

The relevant mandatory conditions will apply to the licence.

The sale of hot food or drink to be consumed away from the premises shall not be permitted after midnight on Sundays to Thursdays inclusive and after 05:00 hours on Fridays and Saturdays unless the conditions set out in the Planning Appeal decision APP/G1250/W/18/3212879 are varied.

**b) The prevention of crime and disorder**

A CCTV system shall be installed and thereafter maintained in good working order covering all public parts of the premises (except the lavatories) and the immediate outside area. All recordings shall be accurately date and time stamped and be retained for a minimum of 31 days.

Facilities shall be available to allow Police and other authorised officers to view recordings immediately on request and to be provided with copies in a readable format as soon as reasonably practicable, provided that all requests are compliant with data protection regulations. To that end, a member of staff trained and authorised to use the CCTV system shall be available at all times the premises are open to the public.

The CCTV shall be checked by a senior member of staff at least once a week; any defect in the CCTV system shall be rectified as soon as reasonably practicable and a written record shall be kept of the checks, any defect and steps taken to rectify the same. The record shall be made available for inspection on request by police and other authorised officers.

At least one SIA registered door supervisor shall be deployed at the premises from 23:00 hours until the last customer has left the immediate area on every Friday and Saturday night and on Sundays falling on a Bank Holiday.

Staff will be instructed not to serve any person who appears to be drunk or behaving anti-socially.

No deliveries to or from the premises shall take place between 23:00 and 07:00 hours, including the disposal of glass bottles or refuse.

**c) Public safety**

*Note – not to form part of any licence condition – there are no matters of public safety associated with this application that are not adequately addressed by other legislation including but not limited to the Regulatory reform (Fire Safety) Order and no conditions are specifically proposed under this licensing objective.*

**d) The prevention of public nuisance**

The use of the external area for the consumption of food will end at midnight each day.

A notice shall be displayed at the exit from the premises asking customer to leave quietly and to respect neighbours.
