Annex 1 – Mandatory conditions

Mandatory Conditions (Sections 19,20,21 LA 2003)

- 1.1. There shall be no sale or supply of alcohol when there is no designated premises supervisor in respect of this premises licence or at a time when the said premises supervisor does not hold a personal licence or when his/her licence is suspended.
- 1.2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The Licensing Act 2003 (Mandatory Licensing Conditions) (Amendment) Order 2014

1.3.

- 1. The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises –
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to -
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise antisocial behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

1.4.

- 1. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- 2. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- 3. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -

(a) a holographic mark, or

(b) an ultraviolet feature.

The Licensing Act 2003 (Mandatory Conditions) Order 2014

1.5.

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1 -
- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula —

$$P = D + (D \times V)$$

Where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 - Conditions consistent with the operating schedule

Prevention of Crime & Disorder

2.1. No alcohol product shall be sold, offered for sale or advertised as a loss leader, in other words at less than its cost price or offered either free of charge or at a reduced price if bought at the same time as a product that does not contain alcohol.

- 2.2. No sign or advertisement shall be displayed either inside or outside the premises that compares the price of any alcoholic product with a previous or future price and/or the price at which the same product may be purchased at other premises.
- 2.3. All spirits shall be stored and displayed behind the counter out of reach of the public.
- 2.4. A refusals book shall be maintained in English and shall be checked and signed by one of the management staff on a weekly basis.
 - 2.5.1 The refusals book shall be kept on the premises and made available for inspection by Licensing, Police and other authorised officers."
- 2.5. The licence holder or his representative shall attend the local shopwatch meetings regularly.
- 2.6. CCTV is installed and shall be maintained in accordance with recommendations of the Dorset Police CCTV forensic officer.
 - 2.6.1 CCTV shall be downloaded and handed to the Police or member of the responsible authority group on request.
- 2.7. A personal licence holder shall be present on the premises at all times when alcohol is offered for sale.
- 2.8. The premises shall adopt an 'under 25' policy with regards to the requirement for proof of age and production of acceptable identification. 'Challenge 25' signage shall be displayed prominently on the premises.
- 2.9. No beers or ciders shall be sold which are above 6% ABV.
- 2.10. No single cans or bottles of beer or cider under 500ml shall be sold.

Prevention of Public Nuisance

- 2.11. No waste shall be removed from the premises during the hours of 22:00 to 08:00.
- 2.12. No deliveries other than that of newspapers shall take place between the hours of 22:00 to 08:00.
- 2.13. Staff shall encourage customers to leave quietly and have regard for residents.
- 2.14. The outside of the premises shall be regularly monitored by staff and CCTV to ensure that the licensing objectives are being upheld.
- 2.15. Signs shall be displayed at the exit requesting customers to leave the area quietly, having regard for local residents.

Protection of Children from Harm

- 2.16. The only acceptable proof of age documents acceptable shall be UK photo driving licence, valid passport and ID cards bearing the PASS LOGO.
- 2.17. All staff shall be trained in responsible alcohol retailing including, a "No Proof of Age- No Sale" policy Challenge 25 policy, conflict management and any guidance given by SWERCOTS in relation to all age restricted goods.
 - 2.17.1 Written records of training and subsequent refresher training shall be kept on the premises for all staff involved in the sale of alcoholic beverages. Such records shall be kept and made available to Licensing, Police or other authorised officers.
