

Report subject	<b>Review of the political balance of the Council, the allocation of seats on Committees to each Political Group, appointment of Councillors to Committees and appointments to Outside Bodies</b>

Executive summary	The Council is asked to consider and approve: (a) the review of the political balance of the Council; (b) the allocation of seats on Committees to each political group; (c) the appointment of Councillors to Committees (d) the appointments to Outside Bodies as a result of the review of the political balance.
Recommendations	<b>It is RECOMMENDED that:</b> (a) <b>the revised political balance of the Council, as set out in Table 1 to this report, be approved;</b> (b) <b>the allocation of seats to each political group, as set out in Table 2 to this report, be approved, subject to any changes;</b> (c) <b>the appointment of Councillors to Committees and Boards taking into account the membership, as detailed in Table 3, any nominations submitted by political groups and subject to the Council’s consideration of the recommendation from the Audit and Governance Committee on 23 January 2020 – “<i>that there should be an expectation that all Councillors will sit on at least one Committee or Panel of the Council</i>”, be approved;</b> (d) <b>the appointment of Councillors to the other bodies, as detailed in paragraphs 6-8 as a result of the revised political balance of the Council, be approved.</b>
Reason for recommendations	To ensure compliance with the Local Government and Housing Act 1989 and associated Regulations in reviewing and approving the political balance of the Council and the allocation of seats together with any other associated issues.

## Background

1. The Local Government and Housing Act 1989 and associated Regulations set out the methodology and key principles to be applied when an authority appoints Councillors to Committees. In summary this ensures that Committees reflect the political balance of the authority. The authority must approve its political balance before appointing to committees. The political balance calculation is based upon membership of political groups as defined by the Regulations. The percentage is calculated on the basis of total group membership as a percentage of the total membership of the authority.
2. The Council is required to review the political balance on an annual basis and following any change in its membership. Set out below are the revised membership calculations based on 75 seats following the death of Councillor Colin Bungey:

3. Set out below is the proposed allocation of seats to the Political Groups. The following principles are contained within Section 15 of the Local Government and Housing Act 1989, and applied in order:
  - a. Not all the seats on a committee are allocated to the same political group.

- b. Where a group has a majority of seats on the Authority it should have the majority of seats on each committee.
- c. The third rule provides that, without being inconsistent with the first two rules, the number of seats allocated to each political group on all the ordinary committees taken together be as near as possible proportionate to their proportion of seats as a proportion of the authority as a whole.
- d. Finally, so far as is consistent with the above each group should be allocated seats on each committee to reflect their proportion of seats on the authority.

4. In accordance with the revised political balance of the Council Members are asked to consider the proposed allocation of seats as detailed above. The last column in the above table identifies the variances in the allocation of seats compared to calculations set out in Table 1.
5. The following table sets out the current membership of Committees and Boards, in accordance with the previous wishes of the Political Groups and decisions of Council. The Political Groups may at any time alter the Group's membership of Committees and Boards but any seats allocated to the unaligned Members must be approved by full Council. Members are asked to consider the following, any revised nominations submitted by the political groups and the outcome of the Council's consideration of the recommendation from the Audit and Governance Committee on 23 January 2020 – *“that there*

*should be an expectation that all Councillors will sit on at least one Committee or Panel of the Council.” To clarify for the avoidance of doubt this excludes Cabinet Members.*
