Subject:	Agreeing additional grant funding for works to create		
	satellite provision at Magna Academy		

Decision taken:

Corporate Director

Allocating additional grant funding to create additional special school places in BCP's administrative area through a satellite provision [subject to the outcome of a consultation and subsequent consent to the satellite provision].

To grant fund the cost of works of up to £250k from ring fenced DfE basic need capital to carry out the necessary works to create an appropriate provision.

Reasons for the decision:

To ensure there are sufficient special school places for children and young people with complex special educational needs and disabilities (SEND).

Councils have a statutory duty to ensure that there is a school place available for every child. The Children and Families Act 2014 requires councils to keep the provision for children and young people with SEN and disabilities under review (including its sufficiency).

The site was selected following a review and work with local schools to identify potential sites for increases special school places. There are limited opportunities to create additional secondary special school provision.

Background:

1. The number of children and young people assessed as requiring a place at a specialist education provision in the BCP area has increased in recent years. Local provision to meet these needs is of high quality, but capacity has not

been expanded sufficiently to meet this additional demand. This is shown through the sufficiency analysis undertaken which included a review of the provision set out in the Local Offer. As a result, increased use has had to be made of local Independent and Non-Maintained special schools which are comparatively expensive and often located outside of the BCP area.

- 2. The Council has been working with local schools to increase the number of special school places. On the 22 April 2020 Cabinet considered and approved a number of proposals to create additional capacity to meet the assessed educational needs of children and young people in BCP. The approved projects included the creation of a Winchelsea satellite at Magna, at that time the capital costs were estimated to be £20k based on the need to carry out minor works to a base which could be used, and the capital funds were allocated to the project.
- 3. Cabinet approved on 22/4/20 to allocate capital funding to several projects to create additional special school places, this included creating a Winchelsea satellite at Magna. At that time the capital costs were estimated by the school to be £20k to carry out minor works to a base, as assessed for mainstream pupils, this was relied upon as a site visit was not possible.
- 4. Since then a detailed scope of works has been developed to reflect the needs of the pupils and establish costs. This has identified that a further £250k capital is required. The proposed building for the satellite is in good repair but is a challenging building and currently does not meet the specific needs of the pupils to be located there. It is a standalone building which has very little daylight and very poor acoustic properties. Externally it requires security and landscape improvements to make it safe for the students. Existing cycle shelters must be relocated to maintain the required numbers for mainstream students. Some works are required in the main school building to enable the satellite students to benefit from mainstream facilities and to mix with their peer groups.
- 5. It is estimated that 20 places will be created. This would result in an annual cost avoidance to the HNB of £630k (this is based on the typical cost of a local special school places v the typical cost of an independent placement). The places will be for KS3/4 for young people with autistic spectrum condition and learning difficulty needs. Places for this age group and needs were identified as a priority through the sufficiency analysis.
- 6. The provision will be run as a satellite i.e. it will not require the establishment of a new school. The projected opening for the provision is September 2020.
- 7. The risk assessment, set out later in this report, explains the primary risks and mitigations. Feasibility for the SEND Capital Programme was agreed though consideration of the 22 April 2020 Cabinet report, which has been used to support the detailed development of this scheme.

Consultations undertaken:

- 8. We know from regular consultation, engagement and feedback that education provision (quality and sufficiency) is very important to children and young people with SEND and their families. For example, through a Parents and carers survey undertaken in Summer 2019 the feedback received said there was a need for more local specialist provision.
- 9. The provider is a maintained school, as such it is the responsibility of the LA to consult with the those specified by the DfE in line with the statutory guidance document 'Making significant changes ('prescribed alterations') to maintained schools' October 2018. This consultation started Wednesday 6th May (11:00) and will close on Thursday 11th June 2020 (23:59). A report will go to Cabinet 29/7/20 for a decision.

Finance and Resourcing Implications:

Capital implications

Funding - Works will be funded from Basic Need Grant, these works are above and beyond what has already been approved within the Children's Capital Strategy (May 2020). The impact is that this reduces the amount of grant funding available to fund the longer-term strategy.

Procurement and Project Management – Project Management will be provided by the School Estates Team within Children's. The construction works will be undertaken by the Council's own Construction Works Team.

Dedicated Schools Grant implications

It is estimated that the project will provide 20 special school places, resulting in an annual cost avoidance to the High Needs Block of the ringfenced Dedicated Schools Grant of £630k. This is based on the typical cost of local special school place versus the typical cost of an independent placement.

Legal Implications:

Generally, the Council has a duty to ensure a sufficiency of places in its area under section 14 of the Education Act 1996. The Council must fulfil that duty with a view to securing diversity in the provision of schools and increasing opportunities for parental choice.

Pursuant to Part 3 of the Children and Families Act 2014, the Council also has a duty to identify children who have special educational needs and must (together with its partner commissioning bodies) make arrangements for the education, health and

care provision for any children and young people in the Council's area who have special educational needs and/or who have a disability.

Any decision taken must be based on a proper and considered review of the consultation responses obtained.

In exercising any power or duty, the Council must act for proper purposes, in good faith and must exercise its powers properly. It must also act for proper motives, take into account all relevant considerations, act rationally and balance any risk against the potential reward.

The Council is empowered to enter into a contract for works pursuant to section 1 of the Localism Act 2011 and more specifically pursuant to s111 of the Local Government Act 1972 as ancillary to the exercise of its duties set out in the Education Act 1996 and the Children and Families Act 2014 (as outlined above).

However, in tendering and awarding any contracts for works, the Council must comply with the relevant procurement requirements as set out in the Council's Financial Regulations (and otherwise as per the Public Contracts Regulations 2015 to the extent they may be applicable).
