Executive Summary

The Council collects contributions from development which are invested in infrastructure to support housing growth. This Statement sets out the contributions received from developers during 2020/21 and what items of infrastructure the contributions were spent on. The Council collects contributions from development through the Community infrastructure Levy (CIL) and from planning obligations.

In 2020/21 the Council received £6.9 million of development contributions and spent £8.1 million. At 1 April 2021 the Council held £22.8 million in unspent contributions, of which £16.5 million is allocated for spending from 1 April 2021 onwards. The headline figures for 2020/21 are:

Through the neighbourhood portion a total of £0.5 million CIL was spent by communities on local projects, with a further £2.5 million unspent. The parish/town councils were given £192,508 to spend on priorities within each parish/town council area.

1. Introduction

Bournemouth, Christchurch and Poole Council (BCP Council) is a unitary authority formed on 1 April 2019. It was created from the predecessor authorities of Borough of Poole, Bournemouth Borough Council and Christchurch Borough Council.

Each year all local authorities are required through Regulation 121A of the Community Infrastructure Levy Regulations 2010 (as amended)¹ to produce an Annual Infrastructure Funding Statement setting out the contributions received from development and the infrastructure it was spent upon. The first Infrastructure Funding Statement was published in December 2020 and covered the period 2019 to 2020. This is the second Infrastructure Funding Statement and covers the period 1 April 2020 to 31 March 2021.

Our Big Plan (on the right) sets out the type of place BCP Council strives for, and the objectives over the page highlight the importance of developing sustainable infrastructure.

Infrastructure that supports new housing includes parks and open spaces, schools and colleges, and a sustainable transport system. New housing sold on the open market can also help fund affordable housing for people most in need. When delivering growth, it is equally important to protect our natural environment and tackle climate change.

When granting planning permission BCP Council secures funding from developers for infrastructure and affordable housing in the following ways:

Community Infrastructure Levy (CIL) – a standard charge per square metre of additional development. The rates are set out in the CIL charging schedule. There are 3 CIL charging schedules covering BCP Council, one for each predecessor authority of Bournemouth,

Christchurch and Poole. In time BCP Council will produce a single CIL charging schedule alongside the BCP Local Plan.

Planning Obligations – a requirement for the developer to undertake certain actions or pay financial contributions. There are 3 types used by BCP Council:

- Section 106 Agreement legal planning obligation requiring the developer, e.g. for the provision of affordable housing;
- Section 278 Agreement a legal planning obligation requiring the developer to provide specific transport infrastructure; and
- Section 111 of the Local Government Act this option was used by the former Borough of Poole as an option for developers to submit small monetary contributions without having to pay the legal costs of a formal Section 106 Agreement.

The Statement is set out in a series of tables, with contributions from both CIL and planning obligations highlighted. Due to rounding of pence, totals may not tally.

The Statement is structured to set out:

- Requests for contributions;
- Contributions received from developers;
- Contributions spent on strategic projects;
- Contributions passed to Parish/Town Councils;
- Contributions spent by local communities; and
- Contributions held by the Council at 1 April 2021.

2. Contributions requested during 2020/21

During 2020/21, the Council requested developers pay over £5.7 million of contributions towards infrastructure This contains £3.9 million of CIL and £1.8 million through planning obligations

Both CIL and planning obligations are agreed upon the grant of planning permission. However, they are not usually paid until the commencement of the development which may occur several years later. Payments can also be paid in instalments. The amounts set out in the table below therefore do not correspond to contributions received in 2020/21 (Table 2). Furthermore, developments can be altered through further planning permissions over time, often resulting in revised demand notices needing to be issued. Any such re-issued notices are not double counted in this report.

3. Contributions received during 2020/21

During 2020/21, developers paid the Council £6.9 million of contributions towards infrastructure

This contains £5.1 million of CIL and £1.8 million through planning obligations

4. Contributions spent during 2020/21

During 2020/21, the Council spent £8.1 million of contributions on infrastructure

This contains £5.2 million of CIL and £2.9 million of planning obligations

From CIL, £0.5 million was spent by communities on local projects (the 'neighbourhood portion').

From Planning Obligations, £1.5 million was spent on delivering affordable housing.

5. Contributions passed to Town and Parish Councils during 2020/21

During 2020/21, development in the four parish and town councils generated £81,329 to spend in those communities

However, the Council will be passing the parish and town councils £192,508 to include contributions from development in previous years

There are three parish councils and one town council in BCP Council area, all within the former Christchurch area that all came into being in April 2019. The Council is obliged to pass 15% of CIL receipts received from development within a parish to that parish/town council.

None of the parishes have produced a neighbourhood plan, whereby they would receive 25% of CIL collected in the parish. Although neighbourhood plans are currently in preparation by all the Christchurch local councils.

Parish/town councils are required to publish their own statement of CIL spending and publish it on their websites. After 5 years, if monies are unspent the Council can request the CIL contributions back.

6. Contributions set aside for unparished areas through the neighbourhood portion

During 2020/21, communities spent £0.5 million of CIL on local projects (the neighbourhood portion) including improvements to Selkirk Play Park, Pine Park, Bournemouth Aviary and Boscombe Chine Gardens.

A further £1.3 million of community projects have been agreed including the Bourne hub, Bournemouth Central Gardens play area, Canford Magna church community building, Baiter skate park, Canford Cliffs library and Poole Park railway

£1.2 million is available for allocation to more projects, of which the four neighbourhood forums have £0.2 million to spend

The four neighbourhood forums spent £6,762 during 2020/21

In unparished areas the Council sets aside 15% of CIL receipts received for spending on community projects, called the neighbourhood portion. Community groups can bid for the monies to fund projects. Unlike parish/town councils, the Council holds the monies and pays for projects on behalf of the community.
