Background

1. The school funding consultation for 2023-24 was open for three weeks from 11 November to 2 December 2022 with responses made on-line. The consultation paper is included as an appendix to this report.

- 2. A meeting with schools was held during the consultation period and this was well attended with a good level of participation in seeking to fully understand the options under consideration.
- 3. The results of the consultation will be available for the 13 January meeting. In the meantime, Schools Forum members are invited to comment on any aspects included in the consultation.

Options Appraisal

- 4. The consultation document includes options to release funding from the mainstream national funding formula (NFF) to contribute to the shortfall for pupils with high needs. The option of transferring only surplus funding (all schools receive their NFF allocations in full) is considered alongside methods to release funding by adjusting the NFF unit values and mechanisms.
- 5. Also included are options to adapt the NFF should there be insufficient funding when the final data is received in late December.

Summary of financial implications

6. The summary financial impact of the options is shown within the main document and for each school in the appendices. The impact will be assessed again in January when further information has been received in December from the DfE.

Summary of legal implications

 Schools must be consulted on the funding formula to be adopted by the council to fund mainstream schools, with the final outcome to be provided to the DfE by mid-January 2023.

Summary of human resources implications

8. There are no staffing implication arising from this information report.

Summary of sustainability impact

9. There are no sustainability issues arising from school funding changes.

Summary of public health implications

10. There are no public health issues arising.

Summary of equality implications

11. This is an information report with no equality implications. In terms of the NFF, the DfE has undertaken and published a full impact assessment of the changes made for 2023-24.

Summary of risk assessment

12. The funding shortfall for pupils with high needs within the Dedicated Schools Grant remains a significant risk for the council with options for a contribution from the mainstream school NFF again being considered despite the low increase in funding for most BCP schools in 2023-24.
