**The location of the scheme, to come forward, is in a sustainable location that is served by public transport, shops and local services. This in turn, will enable the implementation of safe and attractive walking and cycling infrastructure to facilitate active travel, benefit air quality, improve health and wellbeing and tackle climate change.**

**Through its adopted SPD for Parking Standards Council has reduced its parking requirements for new residential development and increased its requirements for the provision of cycle spaces. The availability of car parking can have an impact on how people travel and encourage a modal shift to non-car alternatives, including walking, cycling and taking public transport.**

**There will be a transition period until a full modal shift is enabled by a sustainable transport infrastructure, and the loss of 138 beach parking spaces could arguably impact the number of visitors/residents able to access /enjoy, take exercise and fresh air at the beach. Inevitably visitors will seek to park in local streets which will arguably reduce the health and wellbeing of the residents in those streets.**

The reasoning for the answer (details of impacts including evidence and knowledge gaps):

**In terms of any new residential development, the new Parking SPD will require 1 cycle space per unit and 0.1 per unit cycle space for visitors. In addition it also requires half of the car spaces provided at the development to have active electric vehicle charging points with the other half having the ability to easily connect at a future date.**

**A bus route runs along Pinecliff Road / Western Road, the nearest bus stop being 300 metres to the east of the site. Currently the no.50 bus service runs past the site along Pinecliff Road from Bournemouth station to Swanage via Canford Cliffs Village. The service runs daily on an hourly basis during school term time and half-hourly during school holidays (including weekends and bank holidays). In addition, the no. 52 Poole to Sandbanks service stops in Canford Cliffs Village. The removal of 138 public car spaces may encourage more people to use these services for the beach.**

Details of proposed mitigation and monitoring (inc. timescales, responsible officers, related business plans etc):

**The Parking Standards SPD will support the actions of BCP Council's**

**Corporate Strategy to tackle climate change and ecological emergency by**

**helping to prioritise opportunities to walk, cycle and use public transport. Other measures will include:**

- **A multi-modal transport app which enables people to make more sustainable travel choices. Integrated smart travel app to be delivered by 2023 (contact [adrian.hale@bcpcouncil.gov.uk](mailto:adrian.hale@bcpcouncil.gov.uk))**
- **Development of a local cycling and walking infrastructure plan by end of 2021**
- **Incorporation of e-bikes and potentially e-scooters into bikeshare across the conurbation by March 2023**

- **Strengthening the quality Bus Partnership to provide higher quality bus services for residents to encourage increased usage and reduce carbon emissions**

- **Launching a communications campaign to promote sustainable travel to residents, schools, businesses, and visitors through to 2024**
- **Developing a sustainable fleet replacement strategy & an annual percentage increase for no's of council operated ultra-low emission vehicles by Dec2021.**
