RESOLVED that planning permission be REFUSED, contrary to the recommendation to grant set out in the Officer's report, for the following reasons:

The proposal, because of the excessive proportions of its frontage; inclusion of flat roofs and balconies; extent of built site coverage; finish materials; and design of the elevations, would represent a visually incongruent structure in the streetscene which is otherwise defined by detached two-storey houses. The position relative to the prominent corner would result in the proposal being visible from three road routes of approach and also from the parkland opposite the site, representing a discordant and alien structure, out of character with the established local area defined by detached two-storey houses and be out of keeping with the pattern of development in the area. The proposal would thus be contrary to the design aims of policies CS6, CS21 and CS41 of the Bournemouth Core Strategy (2012).
