Good morning. You will have been aware of the flurry of activity, primarily as we have continued to try and mediate with the residents, resulting in further and updated documents. With apologies for the unavoidable lateness in filing, but I would be most grateful if you could kindly arrange for the below to be before the Committee members at the earliest opportunity, and in any event at the hearing:

- 1. Mediation communications with residents. I understand the sense in reducing our various responses to residents of 6 April to the common core response set out at Appendix 5, but the email to Mr and Mrs Gurden did cover the additional issues they raised as well, hence its inclusion in this pack.
- 2. Amended application details and consequential amendment to conditions, which includes the amendment to the decibel level terminology sent to Andrew yesterday.
- 3. Event Operations Manual extracts. To try and permit a higher quality of print for reproduction, I have not put these together in a pdf, but am most willing to do that if it would make it easier for you. The documents should please kindly be reproduced in the below order to follow the EMP index:
 - Events Operations Manual frontsheet and index
 - Event Overview
 - 19. Zone Ex plan
 - 20. Transportation plan
 - 28. Spectator Code of Behaviour
 - 32. NMP. The noise contour plots referred to have now been prepared and I hope to be in a position to send those to you shortly.
 - Draft letter to be delivered to local residents.
- 4. Amended plan of external South Stand area to permit the bars and WCs to be contained within an area backing onto the South Stand so that it is both on hard standing and has lower risk and better access to power supplies etc. The area to be used is shown on the attached extract plan before the SAG on 21 April and it is understood that there is sufficient emergency access over the rest of the road (3m). However, the blue line includes both the area by the South Stand (plan A) and the originally planned area on the grass in case there is a preference from any of the services or the operator for this layout at any time.

I shall split this email, sending the EMP attachments separately, to hopefully avoid overload. Please let me know if you need any of the documents in any other format to assist you. I shall be in Bournemouth this afternoon and can deliver the originals to your office if that helps.
