Continuing education of volunteers re operation of restriction and that deliveries and access to property including holidaylets permitted but could also be arranged for outside restriction times. Arrival time to property could change to 3.30pm School street is enforced by way of barrier term time only. Customers could be made aware in advance re school street operation, and informal pedestrians, student scooting and cycling 'contraflow' behaviour at end of school day Continuing education of pupil and parents re highway risks Road is proposed to be part of 20mph zone as part of scheme including neighbouring Durley Road with raised tables on the highway at each end of Somerville Road. More signage to be installed to highlight school street.
