Good morning Ms. Wozniak.

As a normal part of the Premises Licence application, **Trading Standards** have received notification of your application for a Premise Licence for the following business: **Gaja, 360 Charminster Road Bournemouth BH8 9RX.**

As you will be aware, It is the legal responsibility of a business to ensure age-restricted products (in this case **alcohol**) are not sold to anyone under the age of 18. Therefore this will require the business to have effective systems in place that are routinely reviewed to ensure their effectiveness and robustness.

In that regard, I note from your application, in **Section M, (in particular and specifically, sub section e) (The protection of children from harm)**, you don't appear to mention any detailed or specific age-verification policies concerning alcohol sales and staff training. Therefore I would like to propose the following conditions, to ensure the licensing objective of the prevention of children from harm is upheld. I suggest the following wording (which is in line with standard Police wording). If you are happy with it, I'll ask our licensing team to add to your licence **subject to its approval**:

1. ***Challenge 25, shall be operated at the premises where the only acceptable forms of identification are (recognised photographic identification cards, such as a driving licence or passport / Holographically marked PASS scheme identification cards). Appropriate signage advising customers of the policy shall prominently displayed in the premises.***
2. ***All staff involved in the sale of alcohol shall receive training on the law relating to prohibited sales, the age verification policy adopted by the premises and the conditions attaching to the premises licence. Refresher training shall be provided at least once every 6 months. A record shall be maintained of all staff training and that record shall be signed by the person receiving the training and the trainer. The records shall be kept for a minimum of 12 months and made available for inspection by police, licensing or other authorised officers.***

I hope the above wording is acceptable to you, and I look forward to hearing from you at your earliest opportunity.
