<b>Executive summary</b>	<p>Statutory guidance Working Together (2023) requires safeguarding partners to jointly report on partnership safeguarding activity they have undertaken in a 12-month period. The report should focus on multi-agency priorities, learning, impact, evidence and improvement and must be published by the end of September of each year.</p> <p>The Pan Dorset Safeguarding Children Partnership (PDSCP) is responsible for delivering the Lead Safeguarding Partners<sup>1</sup> multi-agency safeguarding arrangements for children and young people.</p> <p>Lead Safeguarding Partners must ensure there are arrangements for effective independent scrutiny in place for their local area.</p> <p>PDSCP's<sup>2</sup> quality assurance and scrutiny framework include presentation of its annual report to the BCP/Dorset scrutiny committees and cabinets as part of its independent scrutiny arrangement.</p>

## 1. Background

Statutory guidance Working Together 2023 requires safeguarding partners to jointly report on partnership safeguarding activity they have undertaken in a 12-month period. The report should focus on multi-agency priorities, learning, impact, evidence and improvement and must be published by the end of September of each year.

Until July 2024 the PDSCP was responsible for delivering the Lead Safeguarding Partners<sup>3</sup> multi-agency safeguarding arrangements for children and young people, therefore the annual report reflects progress on the activity of the Pan Dorset Safeguarding Children Partnership between April 2023 – March 2024.

In July 2024 it was agreed that the PDSCP would separate and create two new multi-agency safeguarding children partnerships one covering Bournemouth, Christchurch and Poole (BCP) and Dorset Council areas. This decision was ratified at the BCP Council, Cabinet meeting 17 July 2024.

Subsequent annual reports will reflect the activity and achievements for the BCP Safeguarding Children Partnership only.

Statutory guidance Working Together (2023) requires Lead Safeguarding Partners to agree the level of funding needed to deliver the multi-agency safeguarding arrangements.

The PDSCP (Delegated Safeguarding Partners) agree the annual contribution on behalf of the three LSPs.

Since the agreement to separate into two local safeguarding partnerships, going forward annual contributions will be agreed by the LSPs specifically for the BCP Safeguarding Children Partnership.
