# **Background**

- At the request of Cabinet and Audit and Governance Committee in January 2024, the framework by which BCP Council manages its shareholder responsibility has been reviewed. As such two governance documents have been prepared for consideration by Cabinet at its meeting on 2 October 2024.
- Whilst one of these documents is a governance framework creating the Shareholder Advisory Board and the Shareholder Operations Board, the second relates directly to supporting the related ethical governance framework namely the Guidance to Councillors and Officers who are appointed to Outside Bodies. This Guidance appears at Appendix 1 of this report.
- The Guidance has been written to provide both Councillors and Officers with an
  overview as to the varying roles and responsibilities associated when appointed to
  an outside body so as to provide support and assurance and to try and avoid and or
  prevent positions of conflict and personal and corporate liability.
- 4. Standards Committee is the custodian of the Council's ethical governance framework and therefore is invited to note this document which is proposed to be incorporated into Part 6 of the Council's Constitution.
