Executive summary	he Council is asked to consider and approve the review of the olitical balance of the Council, the allocation of seats on committees to each political group, the appointment of Councillors in Committees and appointments to outside bodies following the esult of the by-election in the Muscliff and Strouden Park Ward on 4 October 2024.

	(d) the appointment of Councillors to Committees and Boards in accordance with the wishes of the political groups, as detailed in Table 4 to this report, be approved;						
	(e) the allocation of seats to each political group on the outside bodies, as detailed in Table 5 to this report, be approved;						
	(f) the appointment of Councillors to the outside bodies in accordance with the wishes of the political groups, as detailed in Table 6 to this report, be approved;						
	(g) subject to (c) above the appointment of the unaligned Members to the Committees and Boards as shown in table (d) be approved.

### Background

- 1. The Council is asked to consider the political balance of the Council following the byelection for the vacancy in the Muscliff and Strouden Park Ward on 24 October 2024.
- 2. Councillor Toby Slade was duly elected as Councillor and the proper officer has receive notice that Councillor T Slade has joined the Conservative political group.
- 3. Set out in Table 1 below is the revised political balance of the Council reflecting these changes.

4. The seat entitlement calculation (rounded to the nearest whole number) is based on the total number of seats on all applicable committees. Table 2 below, sets out the proposed number of seats on each committee. The total number of seats is 112.

5. The following principles are contained within Section 15 of the Local Government and Housing Act 1989 and have been amended under the regulations to take account of the fact that not all the seats are held by members of political groups. They need to be applied in the following order and as far as practicably possible:

- (a) Not all the seats on a committee are allocated to the same political group.
- (b) Where a group has a majority of seats on the Authority it should have the majority of seats on each committee.
- (c) The third rule provides that, without being inconsistent with the first two rules, the number of seats allocated to each political group on all the ordinary committees taken together be as near as reasonably practicable proportionate to their proportion of seats as a proportion of the authority as a whole.
- (d) Finally, so far as is consistent with the above each group should be allocated seats on each committee to reflect their proportion of seats on the authority.
- 6. Councillors are advised that the Act and Regulations make provisions where a proposal is not as far as possible politically representative. This includes instances where a Group 'gives up a seat' which they are entitled to hold in favour of another and thus distorts the political balance rules.
- 7. In such an instance, the proposal can only be accepted if no member votes against the proposal.

#### Allocation of Committee Seats to Political Groups

8. The Council is asked to consider the proposed changes to the allocation of seats to each political group as detailed in Table 3 below. The last column in the table below identifies that there is no variance when compared to the calculations set out in Table 1. These calculations are therefore not at variance with the political balance provisions. The effect of required changes to achieve political balance is to allocate a seat on the Audit and Governance Committee to the Conservative Group from the Independents Group.

- 9. Seats on committees, which are allocated to political groups, are to be filled by councillors of the respective political group in accordance with the wishes of the relevant group.
- 10. As previously reported and approved by Council, the Leader of the Poole Engage Political Group, which consists of two members, advised that whilst recognising the important work of the Appeals Committee neither member of the group was able to attend the scheduled meetings and gave notice that they were unable to appoint to the seat in question<sup>(a)</sup>.
- 11. The Local Government (Committees and Political Groups) Regulations 1990 makes provision, where a political group is unable to appoint a member of that group to an allocated seat, for the council to 'make such appointment as they think fit'. In such circumstances, the seat may be allocated to a named councillor without regard to the political balance requirements. This same position was taken in November 2023 and May 2024 and Councillor Chris Rigby was appointed to this seat. It is proposed that Councillor Rigby continues to be allocated the seat on the Appeals Committee.

#### **Appointment of Councillors to Committees**

- 12. Table 4 below includes the membership of committees in accordance with the wishes of the political groups. The political groups may at any time alter the Group's membership of Committees, but any seats allocated to unaligned Members must be approved by full Council. Where a political group has not advised of their proposed members to serve on each committee or board, this will be shown as a vacancy.
- 13. It should be noted that Part 4D of the Constitution Procedure Rules (Meeting Procedure Rules) Sub Part A Council Meetings states "1.4 All councillors should be expected to sit on at least one committee or panel of the Council."

## Allocation of Outside Body Seats to Political Groups

- 14. The Council is asked to consider and approve the allocation of seats to the bodies listed in Tables 5 and 6 below, which are required to be appointed, as far as practicably possible, in accordance with the political balance principles. The number of seats on each body is fixed with the exception of the Lower Central Gardens Trust Board which may be either 4 or 5 seats.
- 15. To achieve political balance, it is necessary to change the allocation of one seat on the Dorset and Wiltshire Fire and Rescue Authority from the Independents Group to the Poole People Group, and to reduce the number of seats on the Lower Central Gardens Trust Board from 5 to 4 by removing the seat allocated to the Poole People Group.
