Annex 1 – Mandatory conditions

Mandatory Conditions (Sections 19,20,21 LA 2003)

- 1.1. There shall be no sale or supply of alcohol when there is no designated premises supervisor in respect of this premises licence or at a time when the said premises supervisor does not hold a personal licence or when his/her licence is suspended.
- 1.2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The Licensing Act 2003 (Mandatory Licensing Conditions) (Amendment) Order 2014

- 1.3.
 1. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 2. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 3. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
- 1.4. The responsible person must ensure that -
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

The Licensing Act 2003 (Mandatory Conditions) Order 2014

- 1.5.
 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
 2. For the purposes of the condition set out in paragraph 1 -
 - (a) “duty” is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
 - (b) “permitted price” is the price found by applying the formula —

$$P = D + (D \times V)$$

Where –

- (i) P is the permitted price,
 - (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
 - (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
 - (c) “relevant person” means, in relation to premises in respect of which there is in force a premises licence -
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
 - (d) “relevant person” means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
 - (e) “value added tax” means value added tax charged in accordance with the Value Added Tax Act 1994.
3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (“the first day”) would be different from the permitted price on the next day (“the second day”) as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 – Conditions consistent with the operating schedule

Crime and Disorder

- 2.1. A CCTV system shall be installed and/or maintained in accordance with the reasonable recommendations of Dorset Police Crime Prevention Officer. The CCTV system shall include an external camera covering the entrance to the premises. CCTV recordings shall be retained for a minimum period of 28 days and copies made available to the Police and other Responsible Authorities on request.
- 2.2. No sign or advertisement shall be displayed either inside or outside the premises that compares the price of any alcoholic product with: A previous or future sale price and/or the price at which the same product may be purchased at other premises.
- 2.3. No alcoholic product shall be sold, offered for sale or advertised as a "loss leader," in other words at less than its cost price or offered either free of charge or at a reduced price if bought at the same time as a product that does not contain alcohol.
- 2.4. No poster or notice advertising any specific alcohol product or products shall be displayed outside the premises including but not limited to 'A' boards or wall mounted notice boards or window displays.

Prevention of Public Nuisance

- 2.5. No deliveries other than of newspapers shall take place between the hours of 22:00 and 07:00, the placing of refuse into receptacles outside the premises shall not take place between the hours of 22:00 and 07:00.
- 2.6. Reasonable steps shall be taken to discourage and disburse groups of youths from congregating outside the premises.

Protection of Children from Harm

- 2.7. The premises shall operate a Challenge 21 Policy so that any person attempting to purchase alcohol who appears to be under the age of twenty-one shall be required to produce photographic identification in a form recommended by the Licensing Authority and/or Trading Standards from time to time (currently being a passport, photographic driving licence or PASS approved identification).
- 2.8. All staff shall be trained in the sale of alcohol under guidance issued by Trading Standards and retraining shall be carried out at regular intervals.
- 2.9. Training records shall be maintained and kept on the premises and made available for inspection by Authorised Officers upon request.
- 2.10. Challenge 21 Signage (for example notices asserting "no proof of age - no sale" and "think 21") shall be displayed in prominent positions throughout the premises, including in particular at or near the till point, shop entrance and in areas where alcohol is displayed. Other than such signage, a notice stating the opening hours of the shop and such signs as may be required by law (for example the "No Smoking" sign), no notices or signs shall be attached or affixed to the entrance to the premises whenever the same are open so as to maintain as good an external view as possible.
- 2.11. A refusals register shall be kept and maintained on the premises, the same to be checked and signed by either the Designated Premises Supervisor or his/her nominated deputy on a weekly basis.
- 2.12. All alcohol shall be displayed in clear view of the till point and no alcohol shall be displayed in close proximity to the entrance of the store.

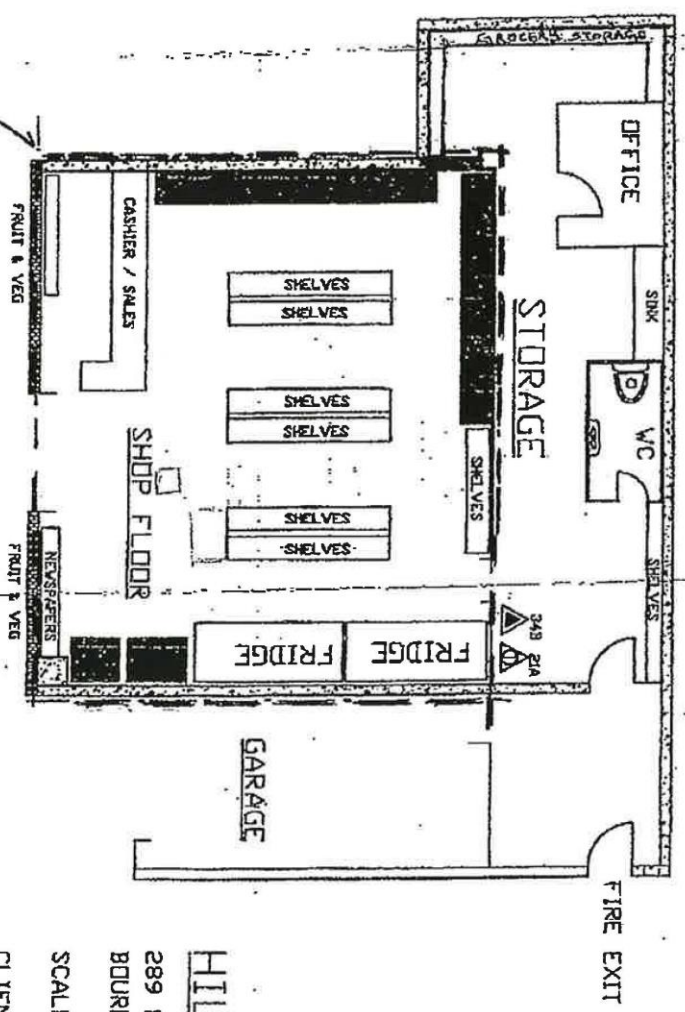
Annex 3 – Conditions attached after a hearing by the licensing authority
