A Bournemouth Town Council, charging the current precept of £2.27, would receive gross income of £226,367 per year even if Northbourne, Boscombe and Southbourne were to become separate parishes. That alone would easily fund a full-time clerk, hired premises, a Remembrance Sunday event (for which the Charter Trust budgeted £10,000 a year) and a few memorial benches. Increased tax burden without proven benefit: Town councils are funded through council tax precepts. The current Bournemouth Charter Trustee precept is just £2.27 per Band D household. Creating a Town Council will inevitably introduce a much higher charge. As highlighted in Section 5.5 of the consultation document, town councils across the region currently charge anywhere from £27 to over £260. This is money out of residents' pockets for services already managed by BCP Council. Discretionary, not essential services: As outlined in Section 5.4, the services a new council could take on are entirely discretionary, most of which are already being effectively handled by BCP. Establishing a Town Council for non-essential services at additional cost is fiscally irresponsible, especially during a time of ongoing public service pressure. This was stated as a possibility during a public meeting of the Forum, in reference to the issue of Charter Trustees — namely, that Boscombe and Pokesdown might be the only unparished area, preventing the Trustees from being dissolved. This is not acceptable practice. Our area should not be absorbed into a much larger structure simply to resolve an administrative gap — especially when there is no consultation asking us if we wish to join the proposed Town Council. We therefore request the following: That the Bournemouth Town Council proposal be reconsidered unless it can demonstrate genuine community demand and a clearer governance rationale. That any future inclusion of Boscombe and Pokesdown in this structure must be subject to separate, transparent consultation, not imposed by default. That the Council continue to support smaller-scale, community-led governance, such as the proposed Boscombe and Pokesdown Community Council, which has emerged through years of resident engagement and aligns with the principles of neighbourhood democracy. Whilst this could be resolved by altering the boundary between WB4 and TB6, we would question whether that would be appropriate considering the community identity of electors in that area. If it is considered that the community identity of electors in that area does not align with TB6 rather than WB4, then that part of WB4 should not be included in the proposed parish. We believe that if either the Bournemouth or Poole Parish proposal is approved while the other is not, the boundary along the dividing line should be reviewed. This would help ensure that no properties or areas are adversely affected or left isolated due to partial implementation. Furthermore, if any of the smaller parish areas proposed within the Bournemouth Charter Trustees area are not approved, consideration should be given to including those areas within the approved parish to maintain continuity and avoid administrative gaps.
