Dear Police & Crime Commissioner, Cllr Martin, Jessica Toale MP, BCP Licensing, and Members of the Licensing Committee,

Thank you, Sarah, for circulating the submissions from Cameo Nightclub's solicitor ahead of the forthcoming hearing.

It is deeply concerning that no Responsible Authorities have objected to the nightclub's application to relocate its entrance directly opposite Glen Fern Car Park and within 10 metres of the bedroom and living room windows of St Peter's Court Retirement Home. This is despite clear concerns expressed by some of the residents.

Approving this application would place vulnerable residents at risk of increased exposure to antisocial behaviour and crime, including: shouting, fighting, drug-related activity, theft, loud music, revving vehicles, and other disruptive incidents that already occur in the vicinity—often into the early hours of the morning. For residents, particularly older people, being forced to endure such behaviour so close to their homes would be intolerable.

If committee members would not accept such activity outside their own homes at 4am, then it is only fair to ask: why should the residents of St Peter's Court be expected to? The assumption that because they live in a retirement home they will not be affected—or that their concerns carry less weight—is simply unacceptable.

For these reasons, I respectfully urge the Licensing Committee to refuse this application.
