1 Introduction

BCP Council ran a consultation on draft proposals to create new parish, town and community councils across Bournemouth and Poole and to make some small changes to the existing town/parish arrangements in Christchurch.

Bournemouth and Poole are the only places in Dorset without town and parish councils. There are four parish councils and a town council in our conurbation already that focus on local priorities, projects, and activities such as improving parks and greenspaces, managing car parks and community centres, providing street furniture, Christmas decorations and community events and entertainment.

We wanted to hear whether the public and key stakeholders:

- Wanted a town and parish council in the area they live in?
- Felt the proposed boundaries are right, or whether they would change them?
- Felt the community they live in is in the right parish or if they would prefer to be a part of another parish area?

Before any decisions were made, we wanted to hear their views on setting up a **new parish, town or community council** in the following areas:

- Boscombe and Pokesdown
- Bournemouth Town
- Broadstone
- Poole Town
- Redhill and Northbourne
- Southbourne.

And their views on **existing parish and town council** arrangements in the following areas:

- Burton and Winkton
- Christchurch Town
- Highcliffe and Walkford
- Hurn
- Throop and Holdenhurst.

The consultation ran from **31 March to 22 June 2025**.

2 Background

Bournemouth, Christchurch and Poole (BCP) Council is running a full Community Governance Review for the first time since it was formed on 1 April 2019, following Local Government Reorganisation.

This review is taking place following a decision made at [Full Council](#) on 15 October 2024. Government guidance advises that a review should be carried out every 10–15 years and there has been no full review of Bournemouth and Poole within this period.

Local councils are the first tier of local government and play a crucial role in providing local services and involving people in their local community. This could be at a town, community, neighbourhood, parish or village level.

The BCP Council area currently has five local councils with parish or town status (Burton & Winkton, Christchurch, Highcliffe & Walkford, Hurn, Throop & Holdenhurst), while the remainder of the area is unparished

2.1 Stage One Survey

For the first stage of the Community Governance Review we ran a survey from 25 November 2024 to 19 January 2025, where we invited existing parish and town councils, residents' groups, community associations, neighbourhood organisations and individual residents to put forward their suggestions for their area.

3 Methodology

The consultation used online and paper surveys to ensure broad participation from residents and key stakeholders.

The main consultation page was hosted from the council's Engagement HQ Platform along with a brief description of the consultation and had all the relevant documents and support information.

The consultation was designed in Engagement HQ (engagement platform software). The online responses were downloaded from the software for analysis. The data was checked and verified in preparation for analysis and held in the Research and Consultation Team's secure area. The quantitative data was analysed by the in-house consultation and research team using Power-BI.

We wanted to ensure that councillors could see the views of people living in and outside each of the proposal areas. To do this it was important that respondents' postcodes were cleaned and checked for accuracy.

The validated postcode was then joined with the **ONSPD_MAY_2025_UK** reference table to enrich the dataset with geographic information. This included the **electoral ward, easting and northing coordinates**, and **latitude and longitude**.

The eastings and northing coordinates and latitude and longitude represent the centre-point of postcodes (postcode centroid) and are used instead of specific addresses to protect privacy.

Postcode centroids were mapped using Geographic Information System software (QGIS), and spatial joins were used to match each respondent's postcode to the proposal area it is situated in. This allowed us to determine whether a respondent was responding from inside/outside the proposal area for which they were answering questions and allowed filtering by respondents living inside/outside of the proposal areas.

The write in (qualitative) analysis was outsourced to a research company due to capacity within the in-house team. The comments were exported into Excel and sent to the research company who analysed them and coded them into theme based categories.

3.1 Participation

During the consultation period, paper copies of the strategies and surveys were available on request at any of BCP's libraries.

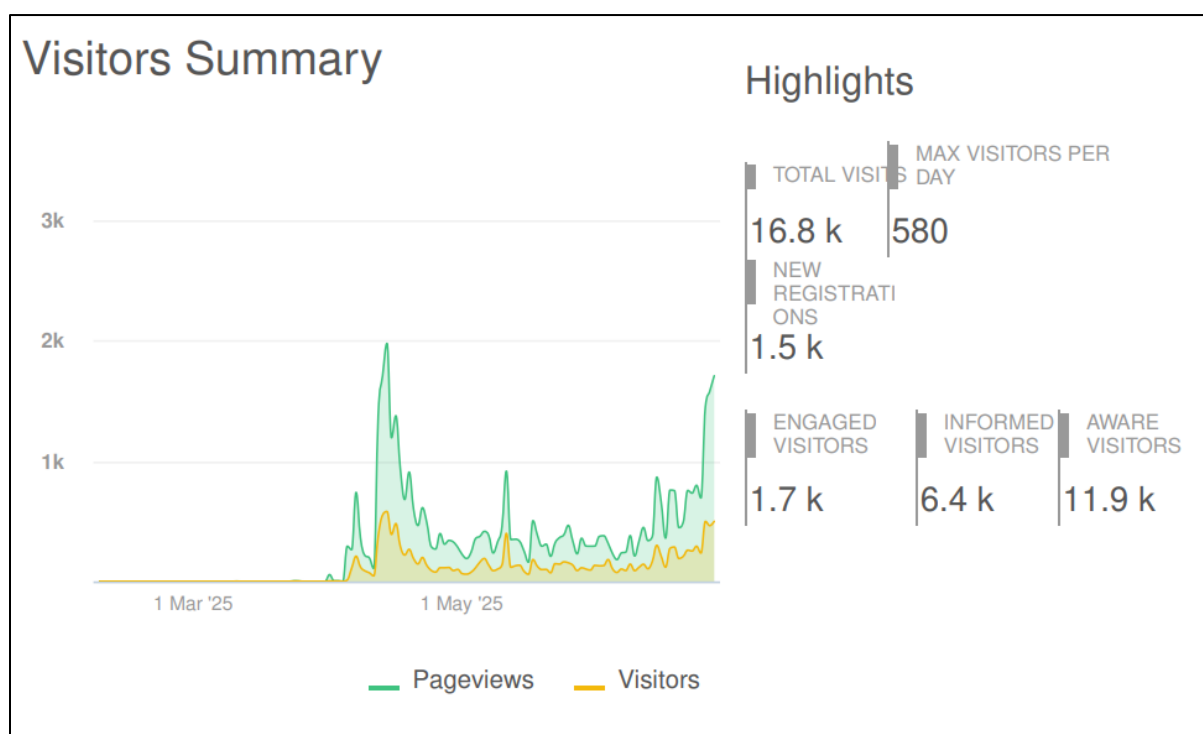
4 Engagement Figures

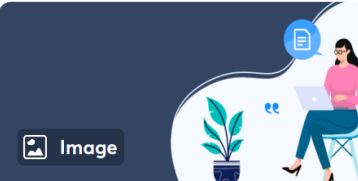

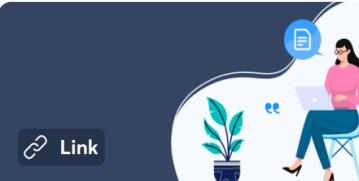

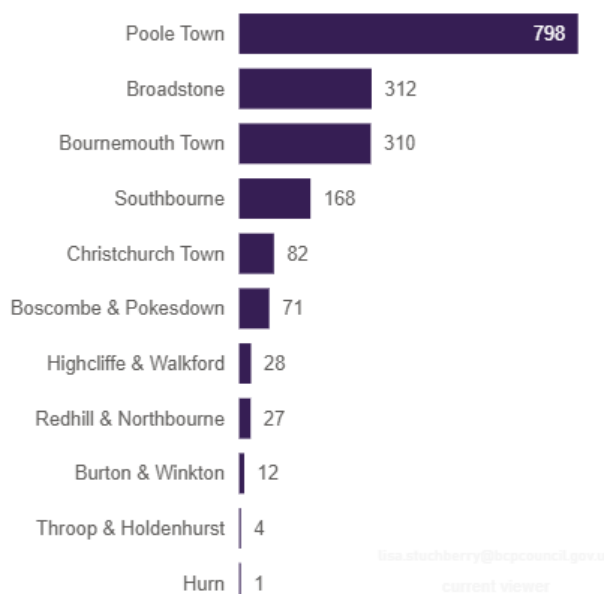
In total 1866 respondents replied to the Community Governance Review survey either online or in paper format.

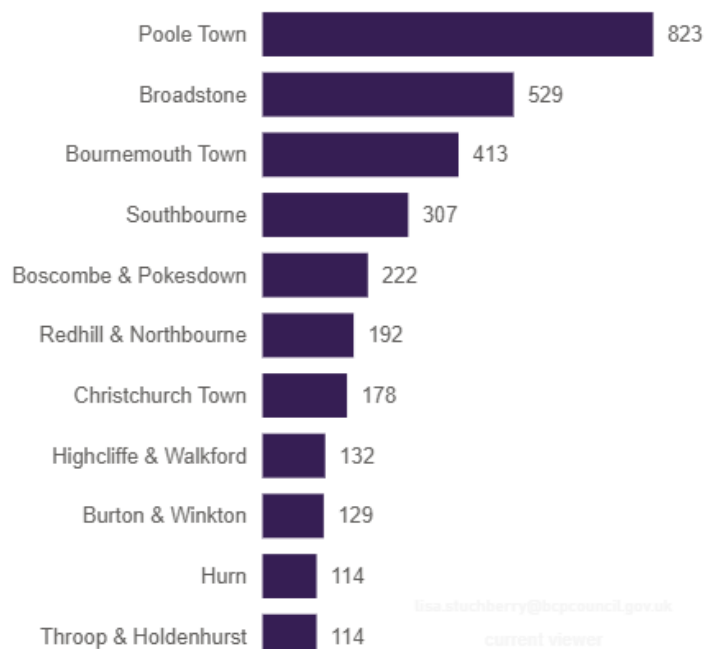
Q. Which of these best describes you?

The graph below shows the number of respondents who chose to share their views on each of the proposal areas, for example 823 respondents shared their views on the Poole Town proposal.



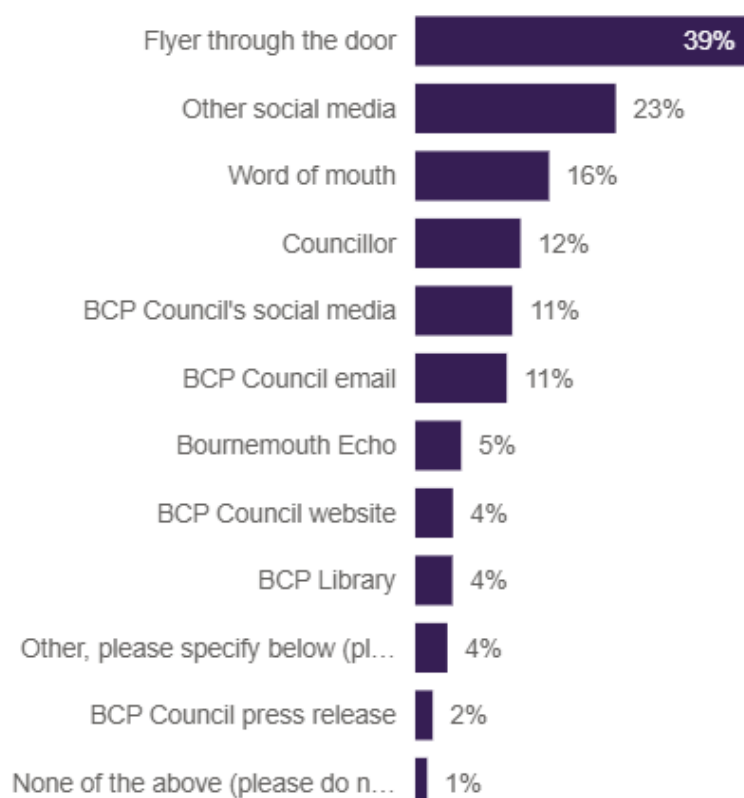
6.2 Consultation Awareness

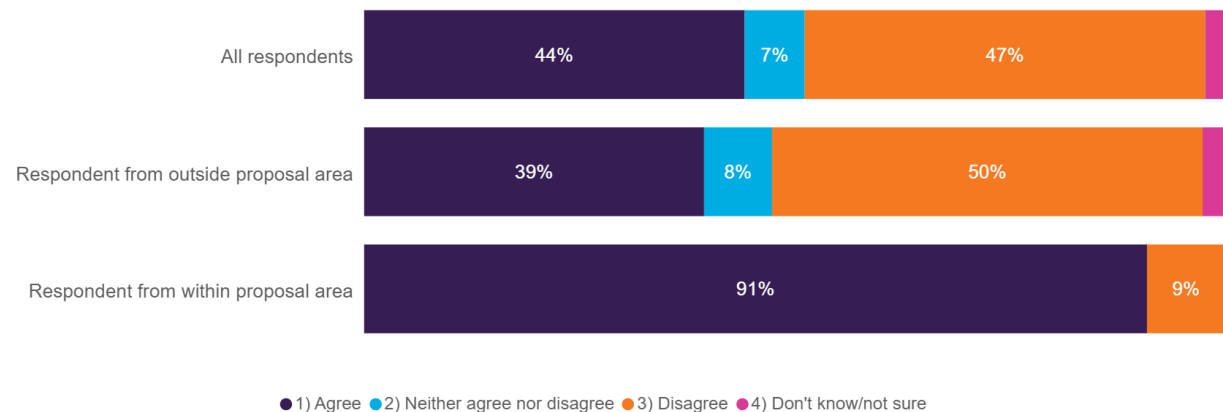
How did you find out about this consultation?

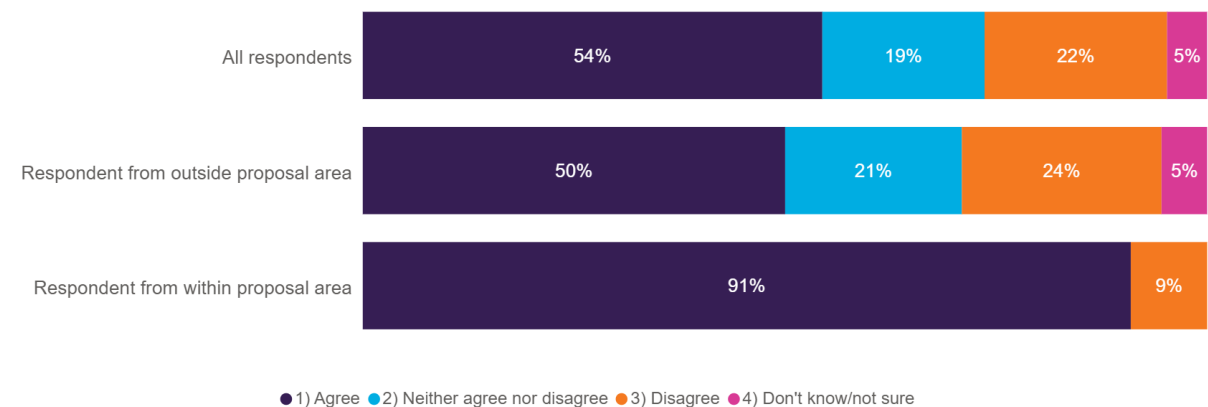

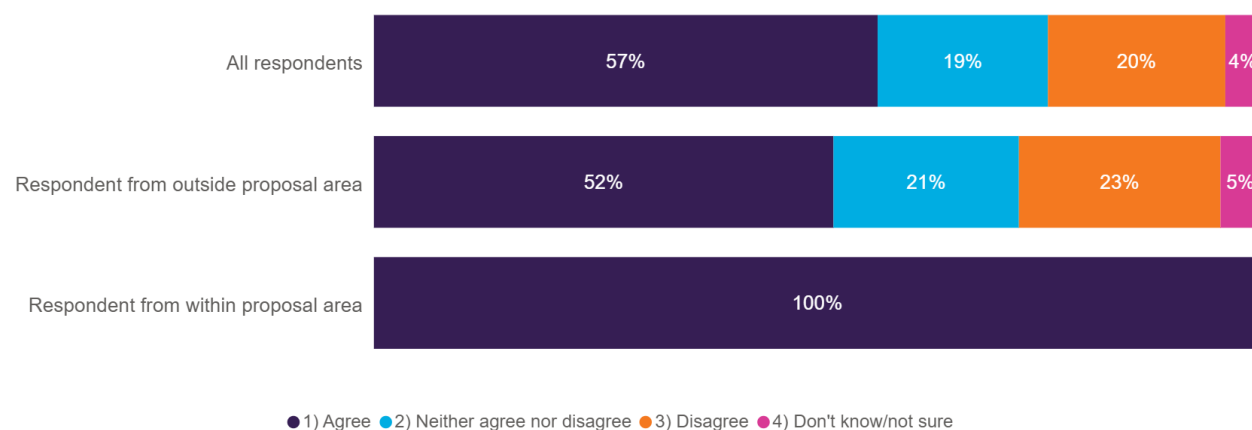

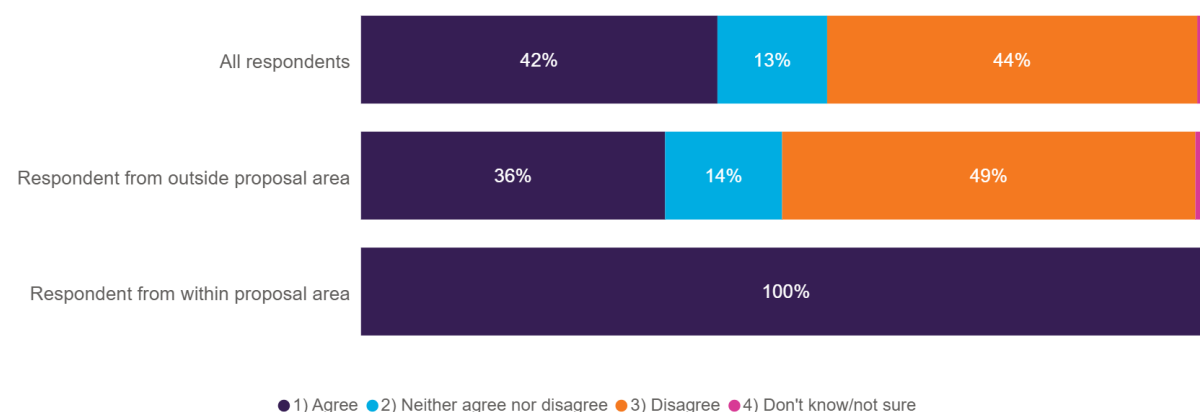

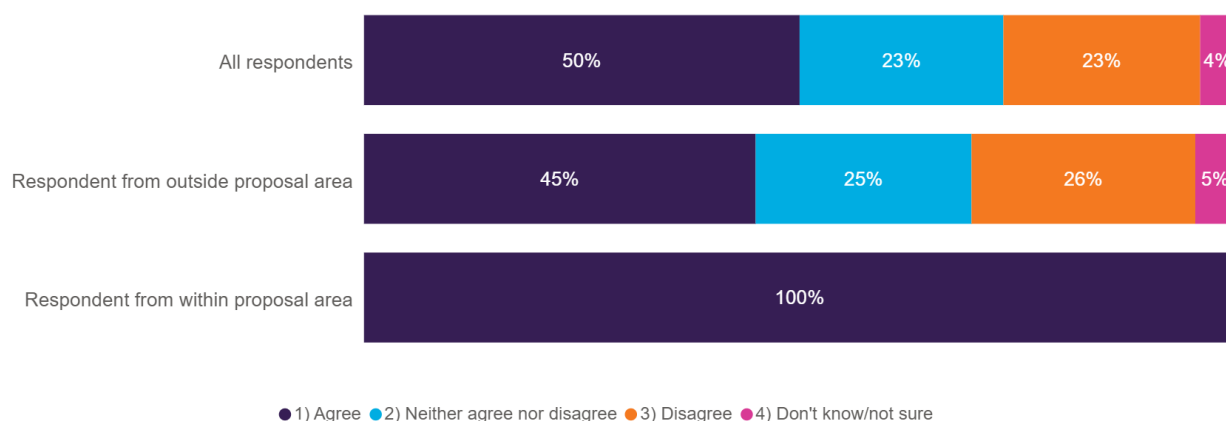

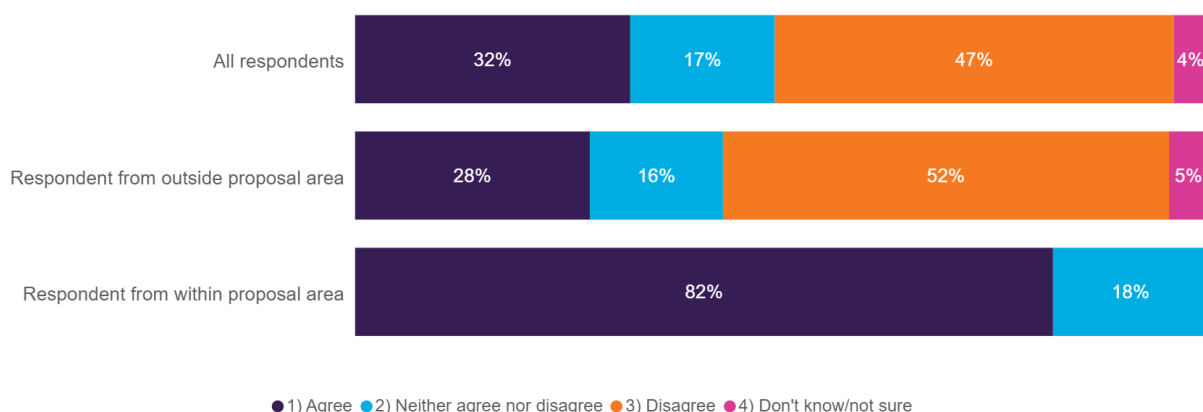

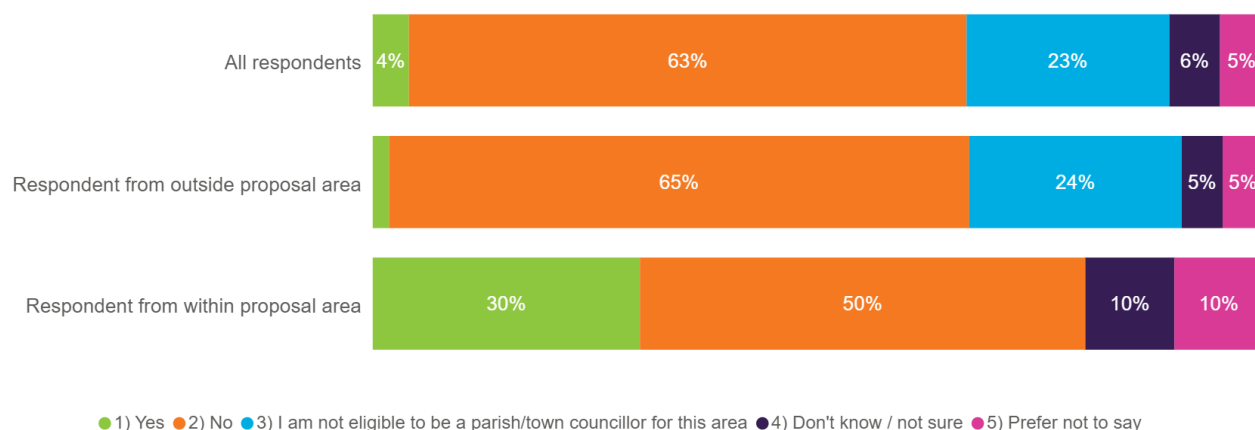

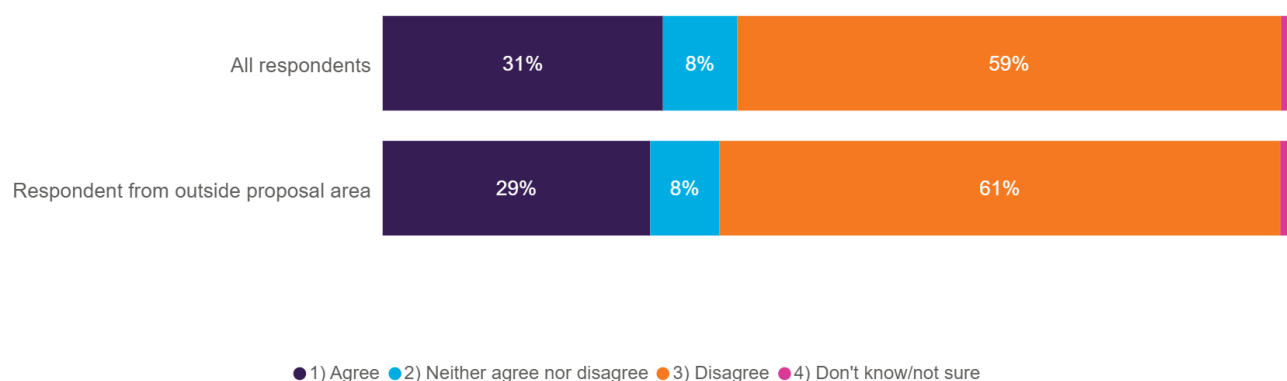

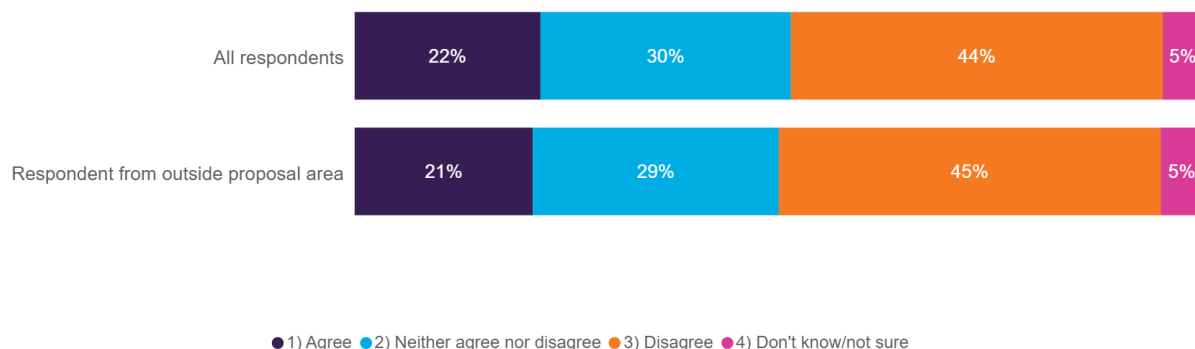

Qa. To what extent do you agree or disagree that the parish of Hurn should not be abolished?



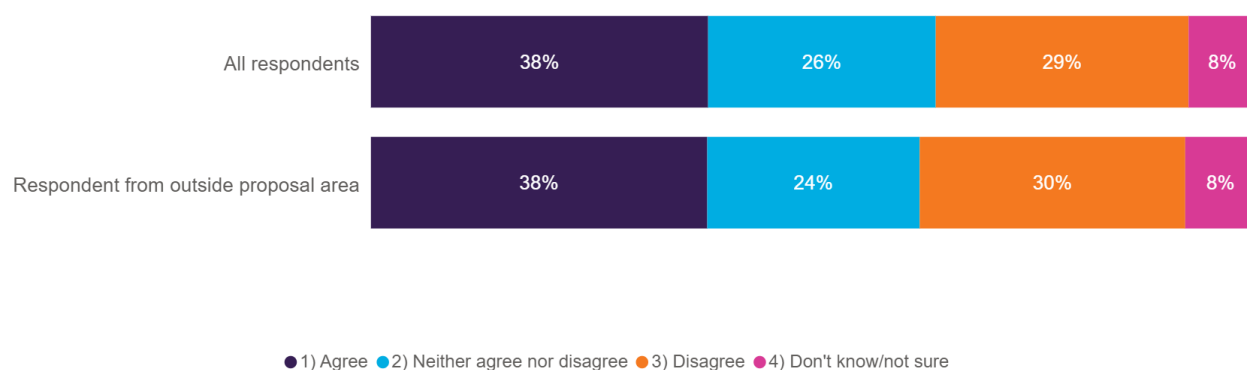

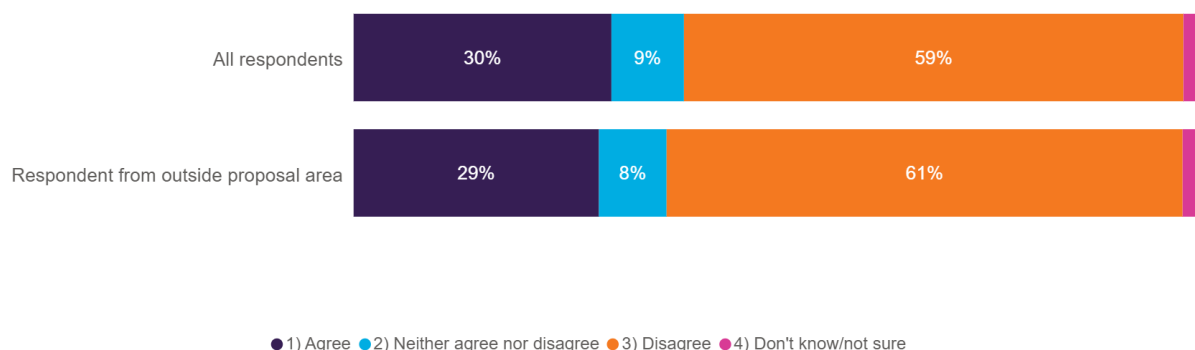

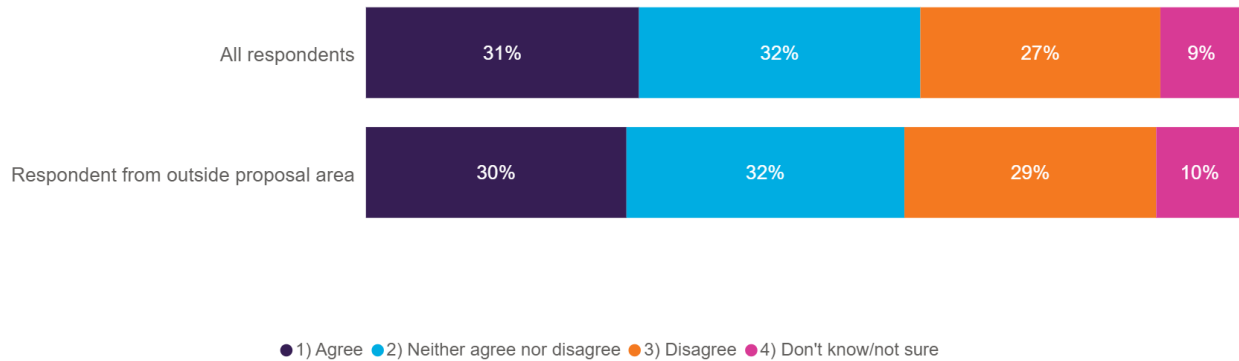

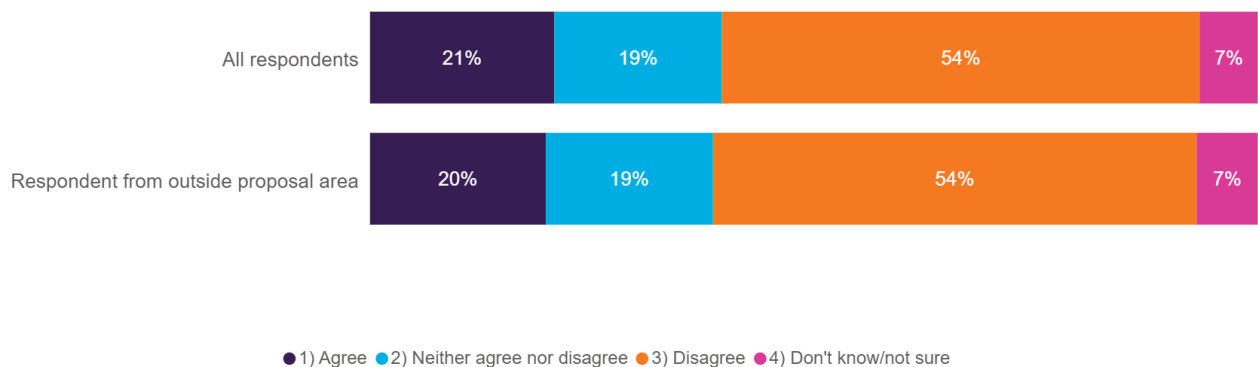

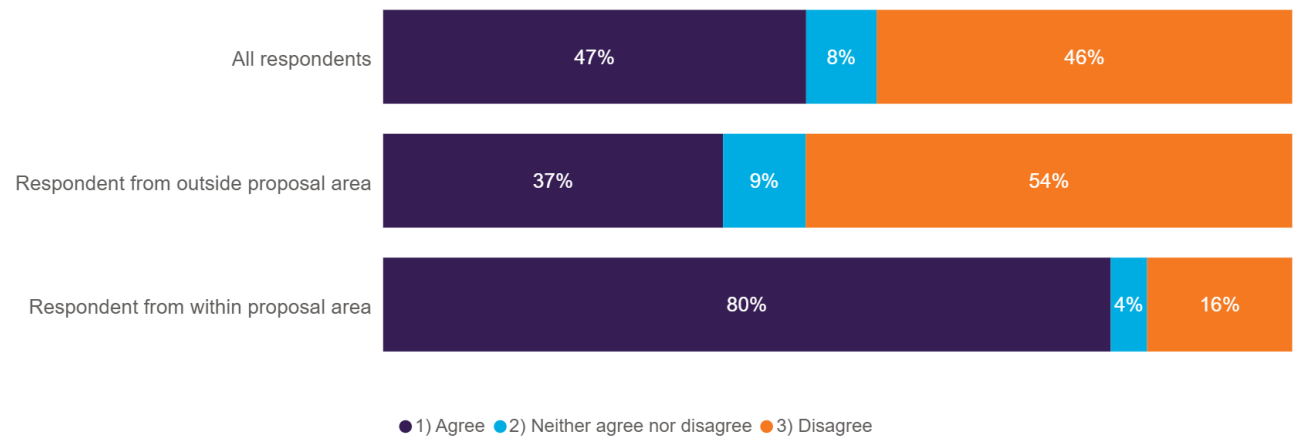

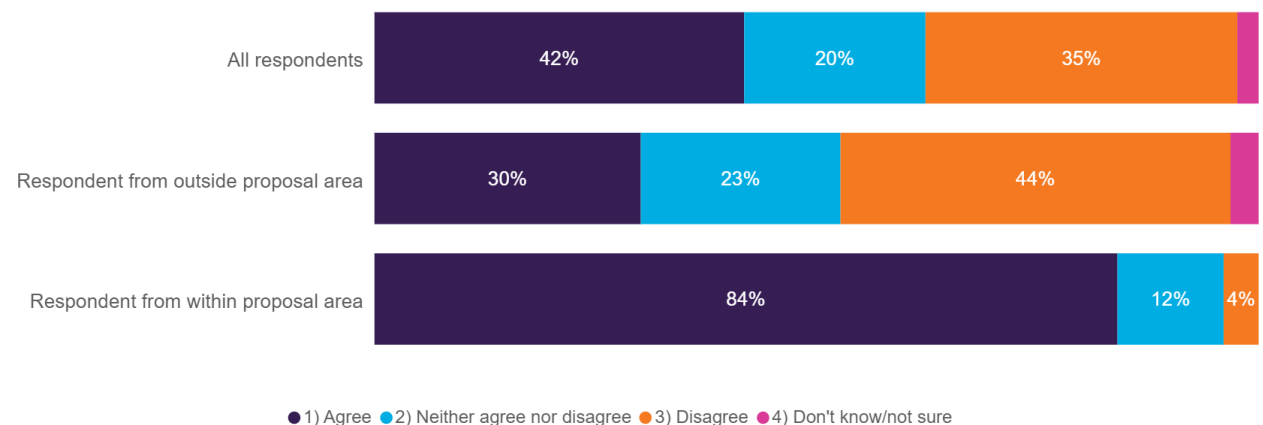

Qa. To what extent do you agree or disagree that the parish of Highcliffe and Walkford should not be abolished?



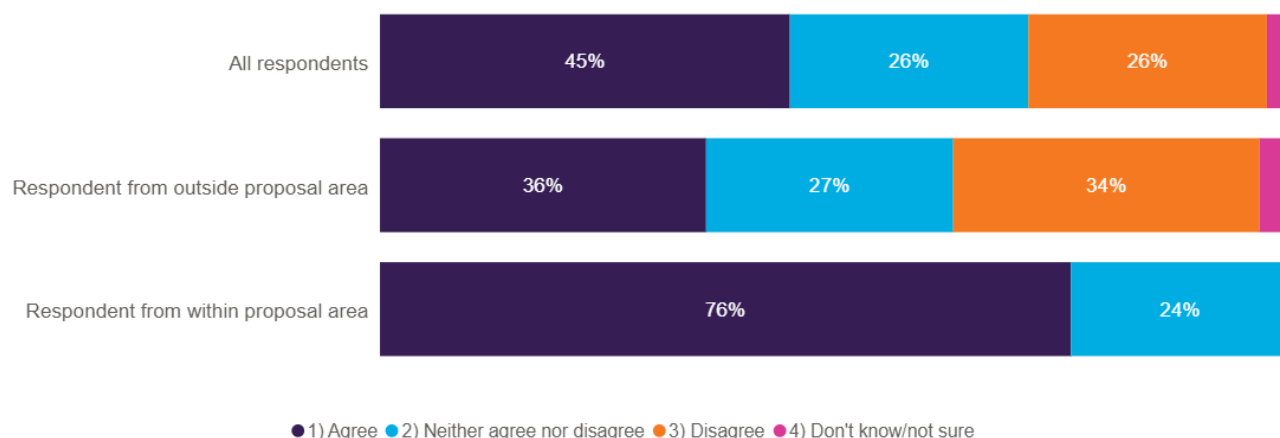

Qb. To what extent do you agree or disagree that no change be made to the boundary of the existing parish of Highcliffe and Walkford?



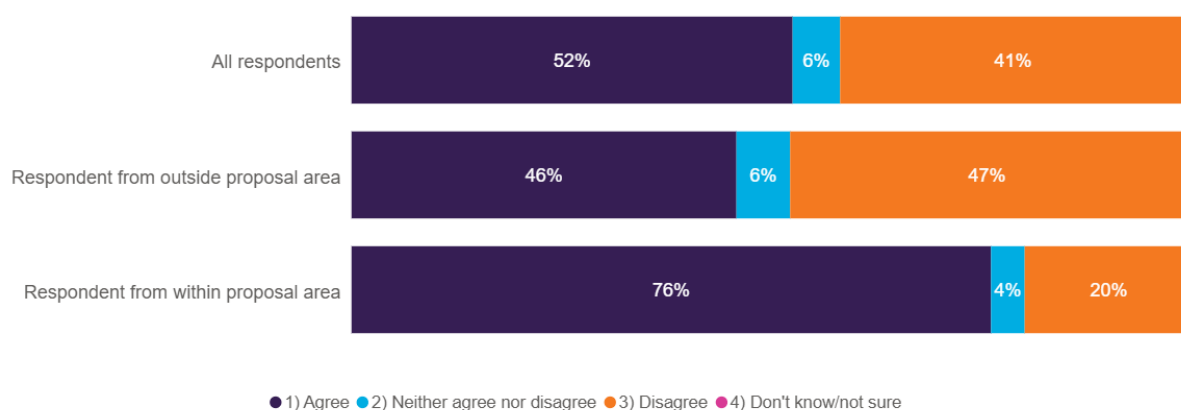

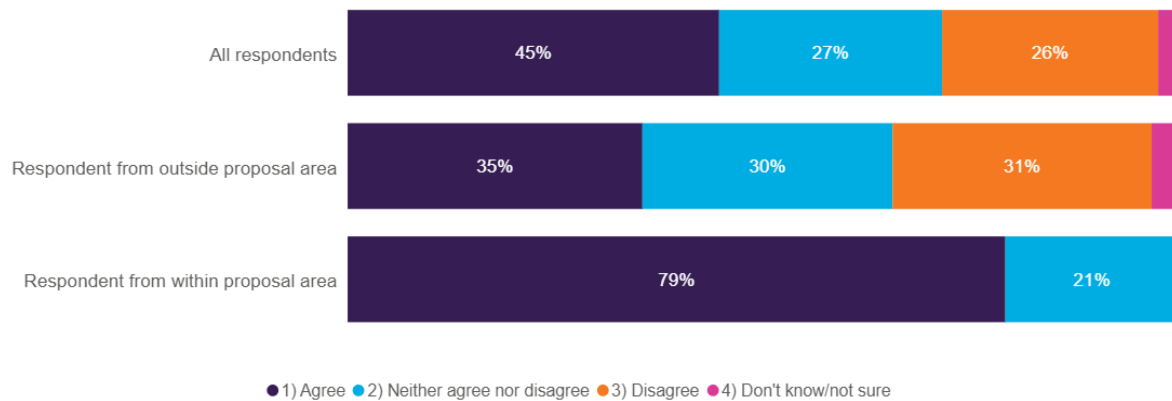

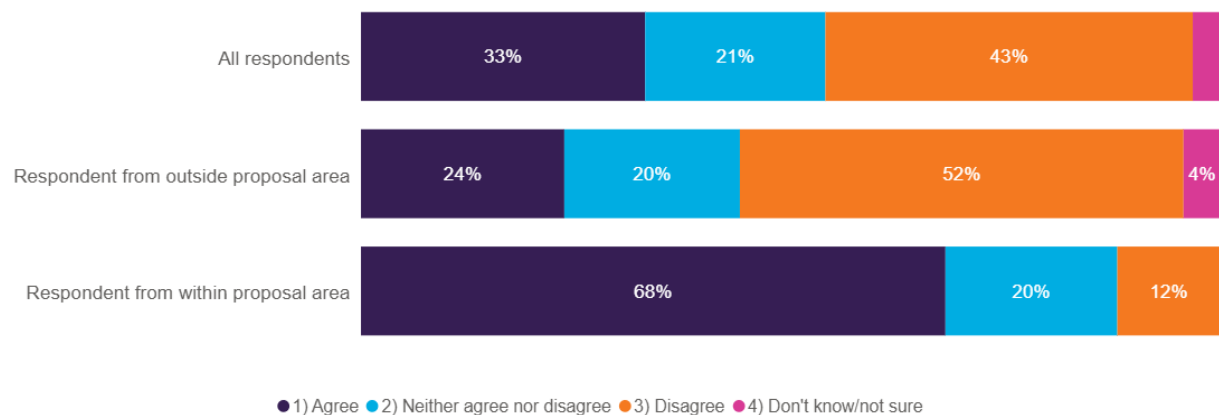

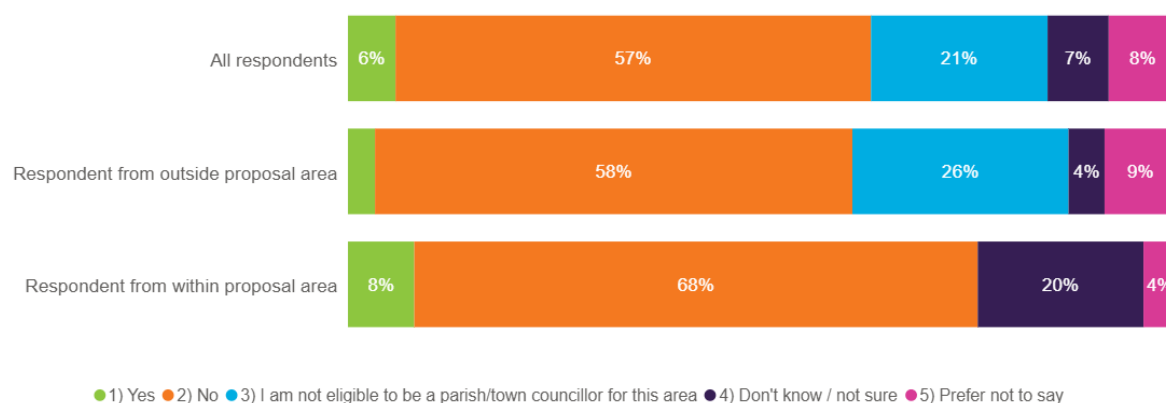

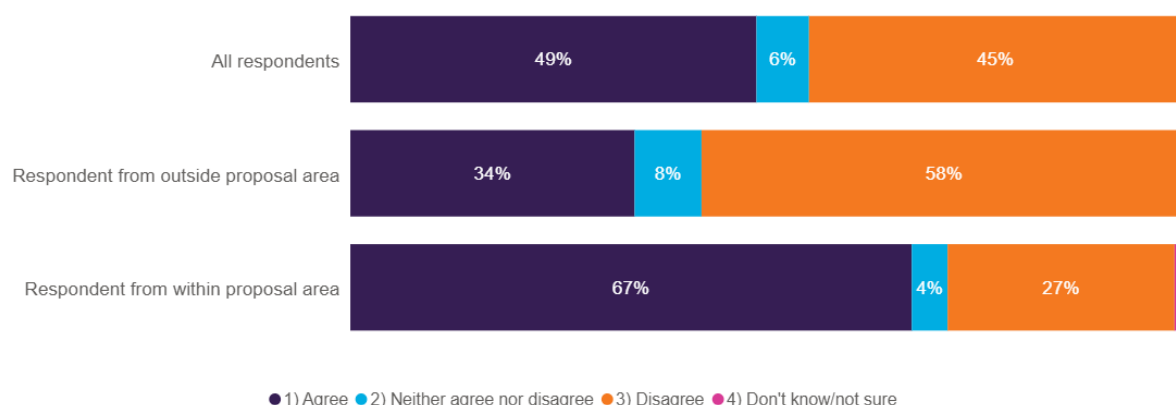

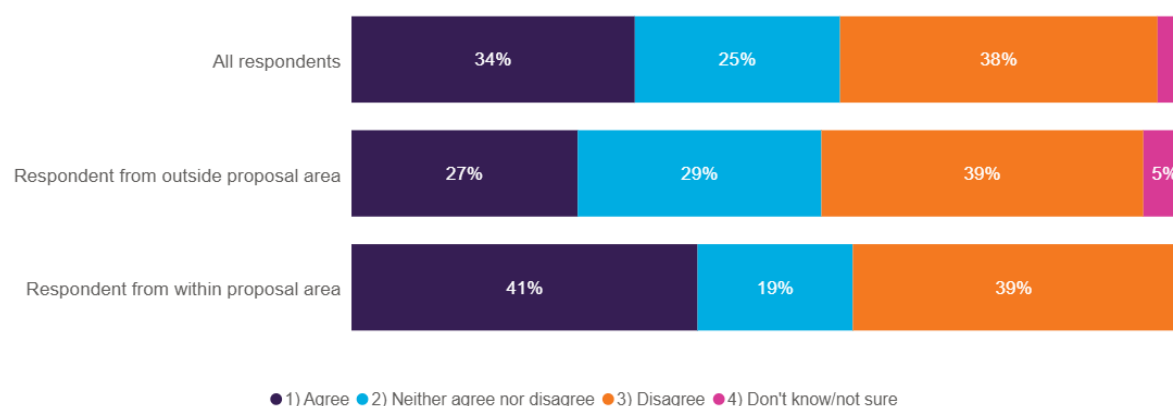

Qa. To what extent do you agree or disagree that the parish of Christchurch Town should not be abolished?



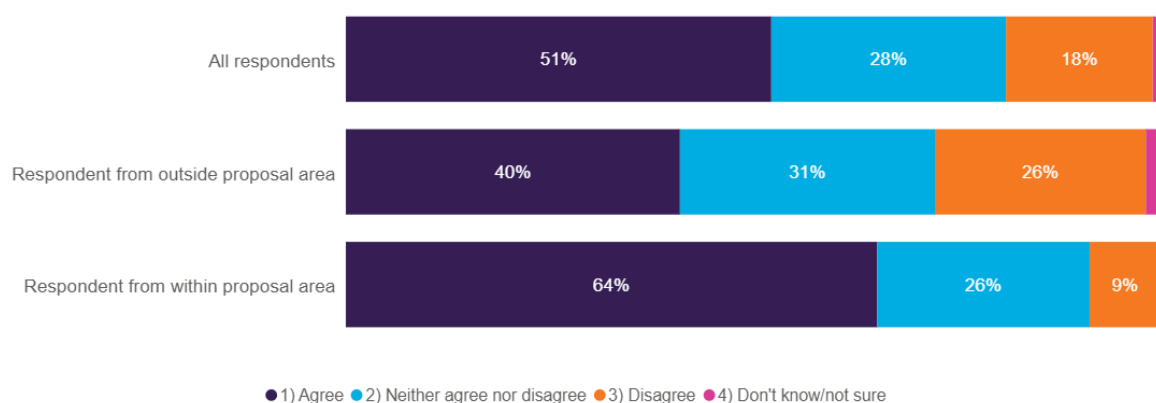

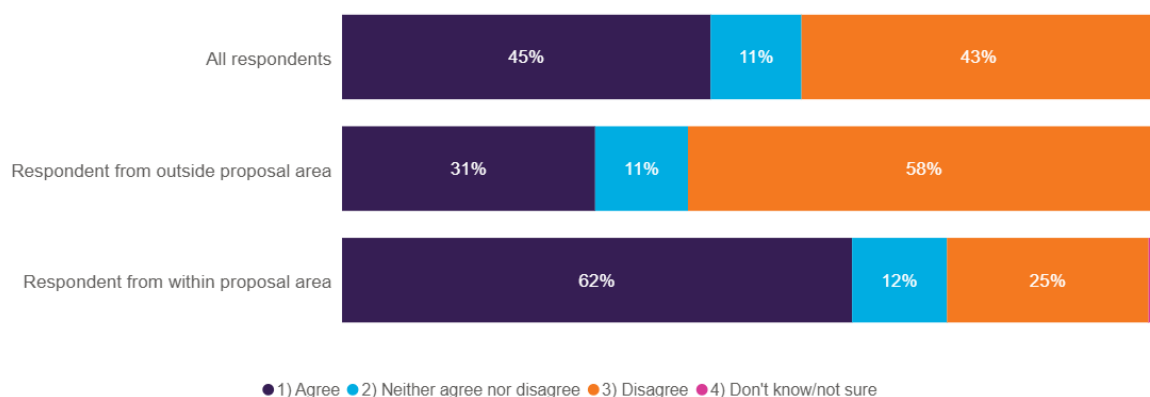

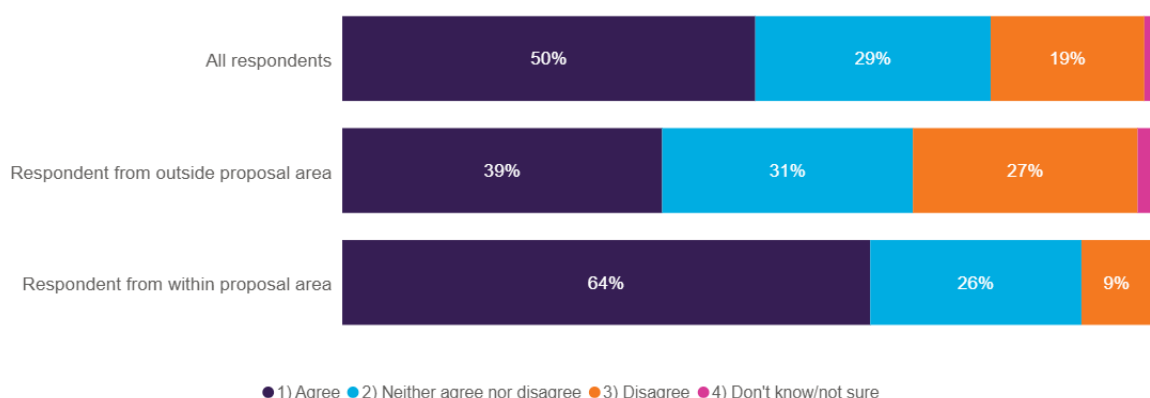

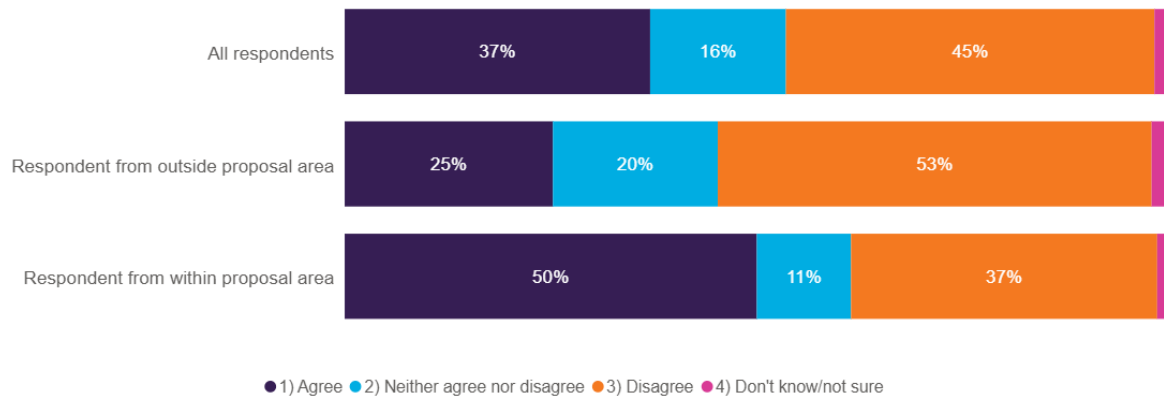

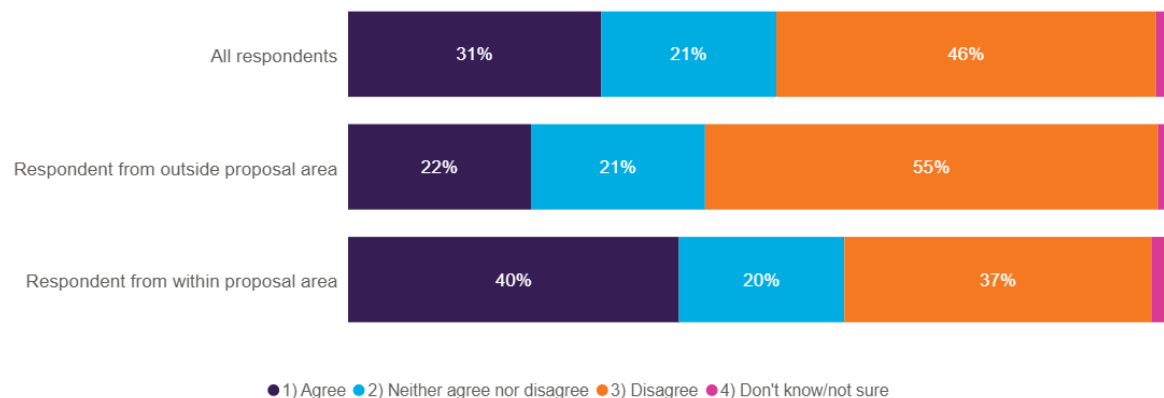

Qf To what extent do you agree or disagree that the parish of Christchurch Town continue to be divided into 5 parish wards.



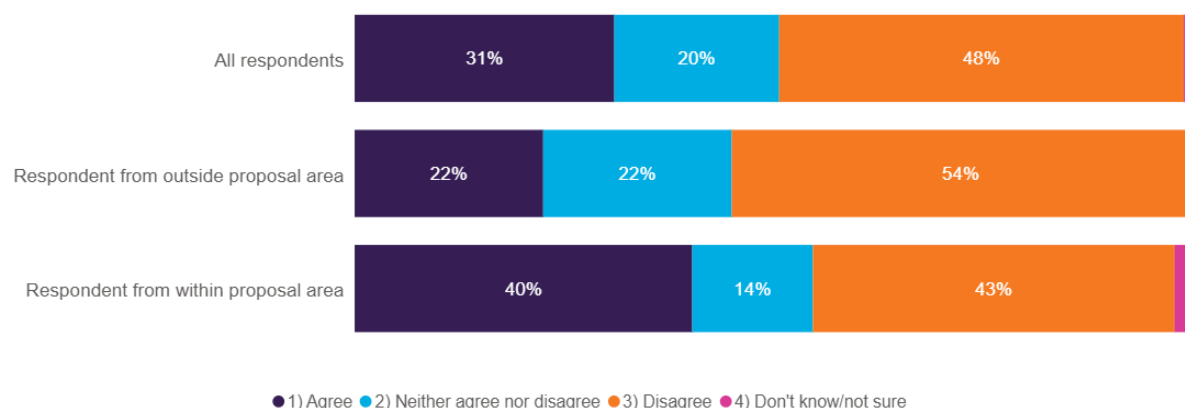

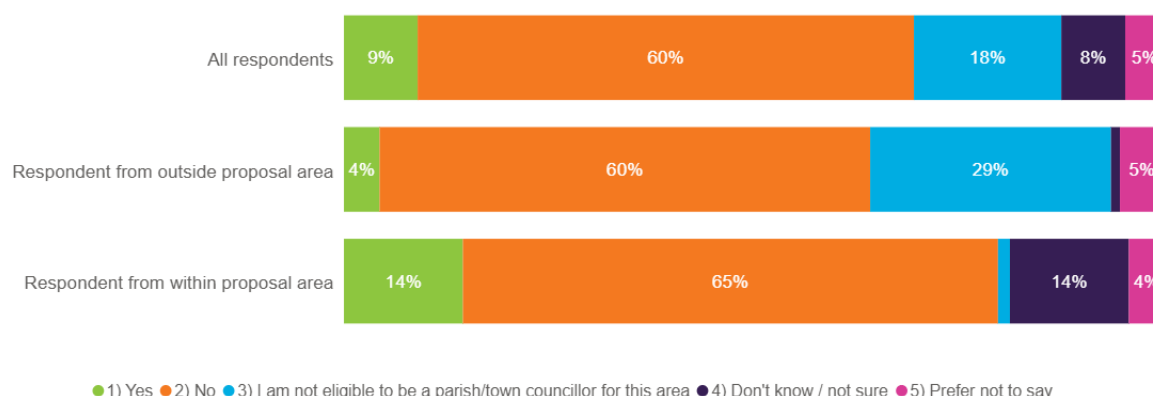

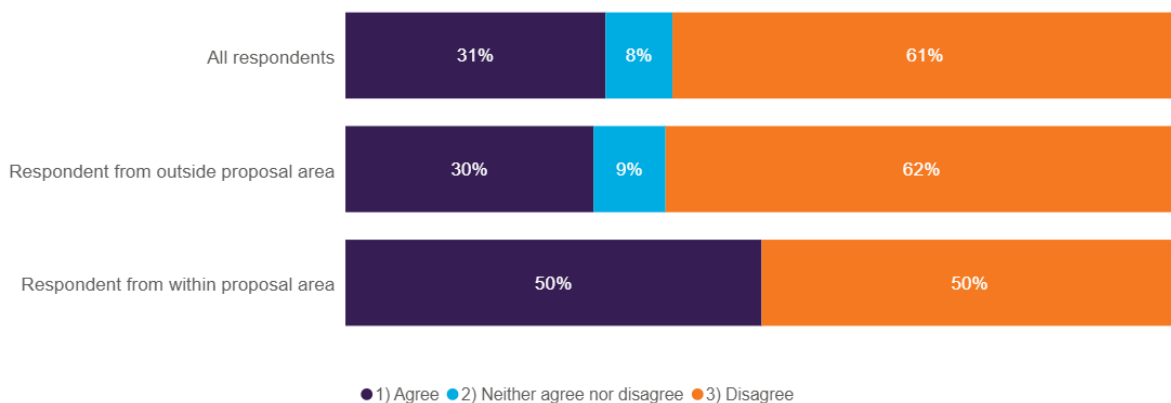

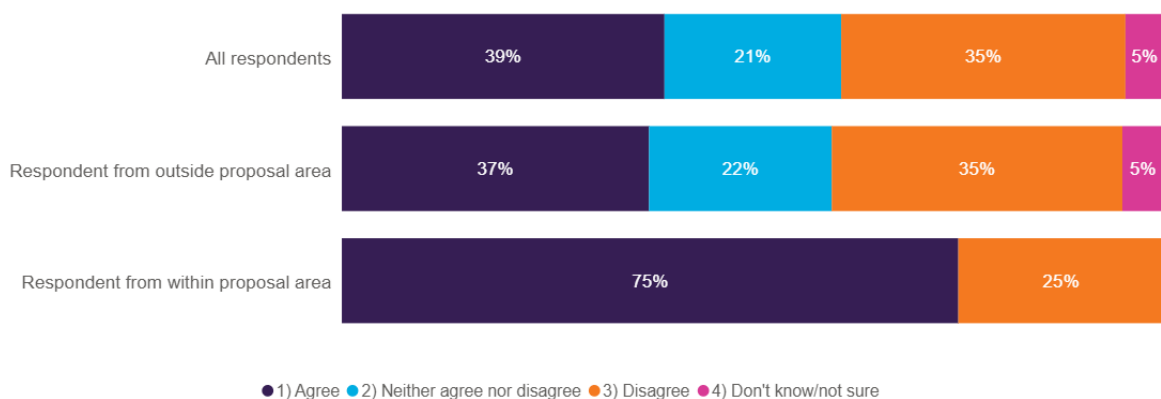

Qa. To what extent do you agree or disagree with the draft recommendations for Throop and Holdenhurst the parish of Throop and Holdenhurst should not be abolished?



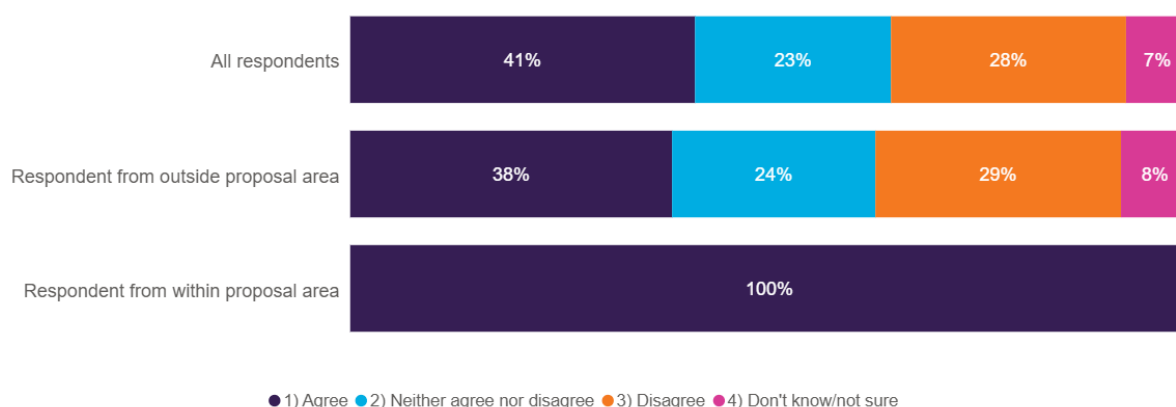

Qb. To what extent do you agree or disagree that no change be made to the boundary of the existing parish of Throop and Holdenhurst?



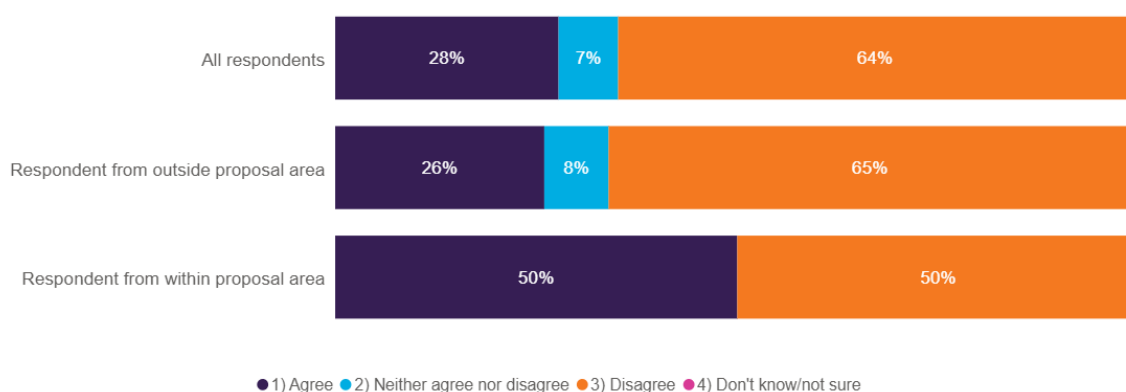

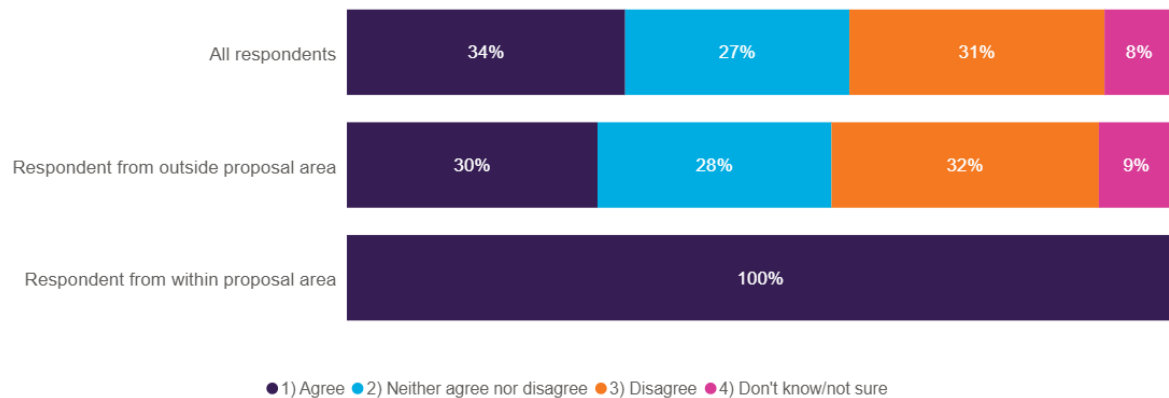

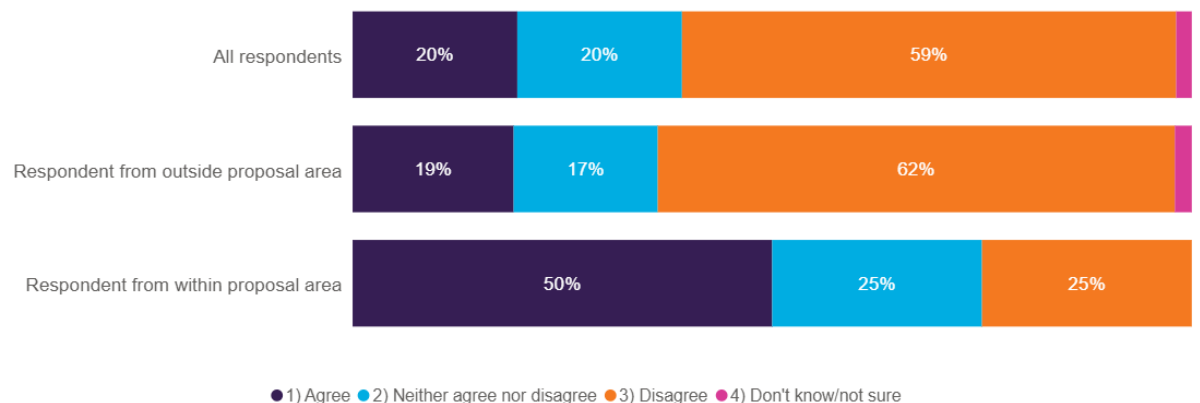

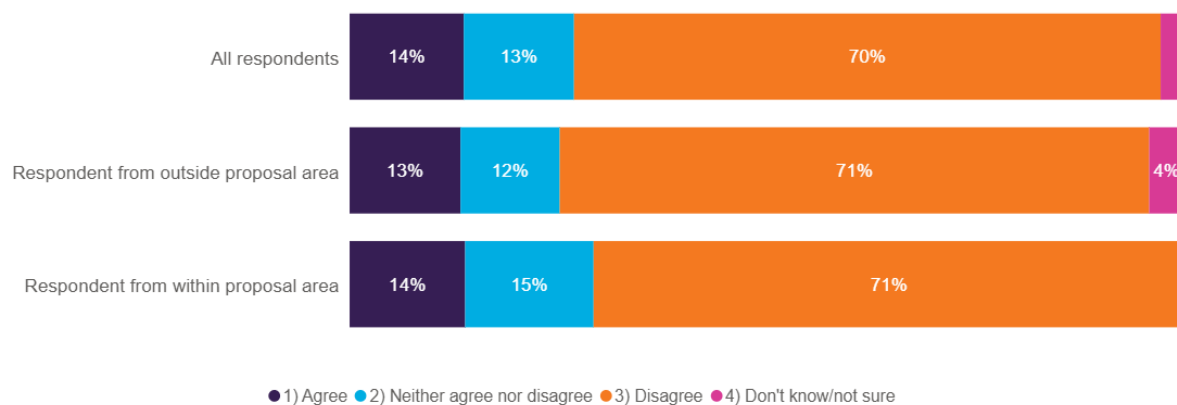

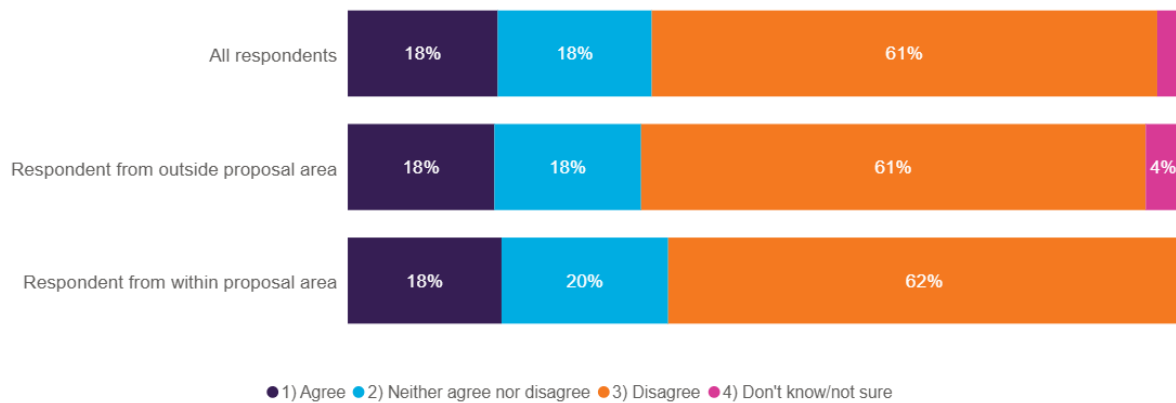

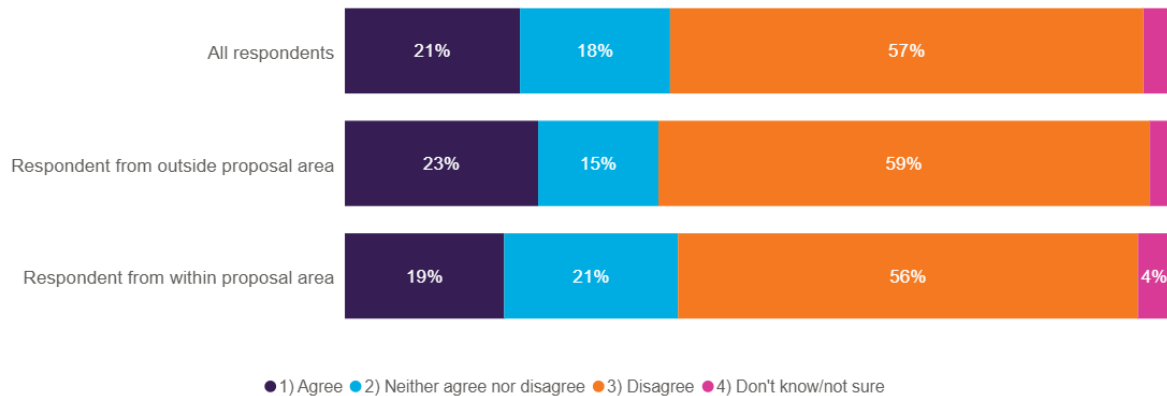

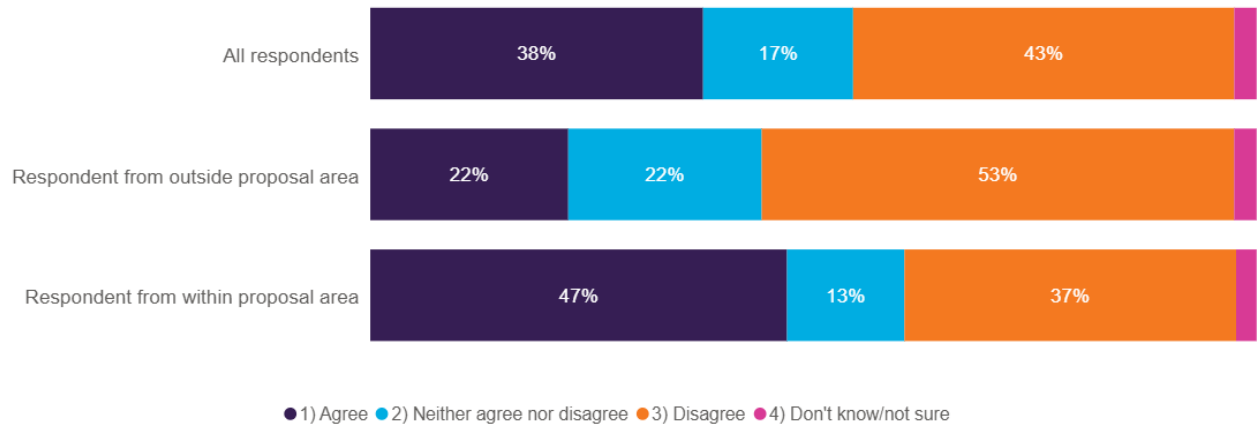

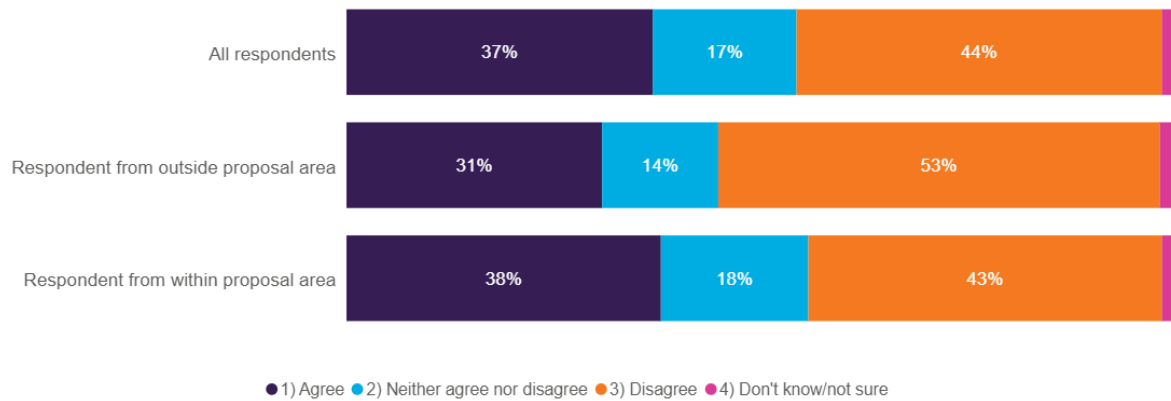

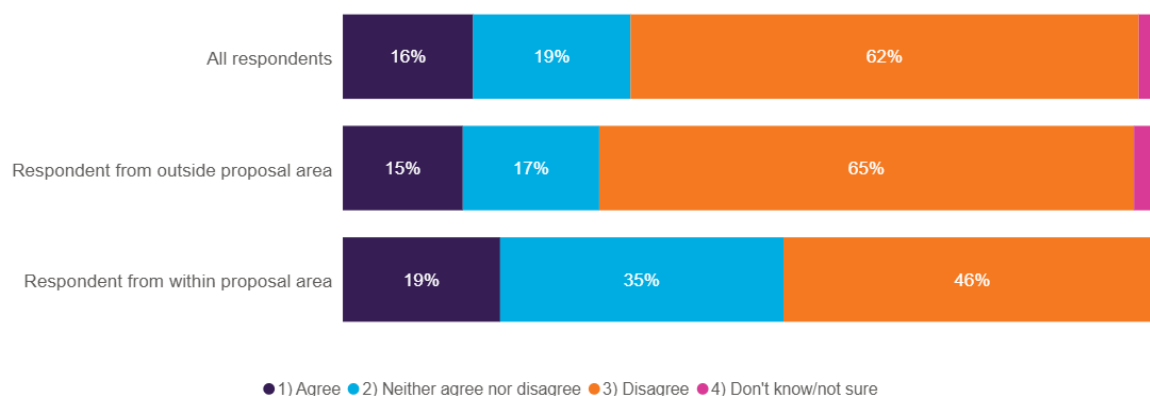

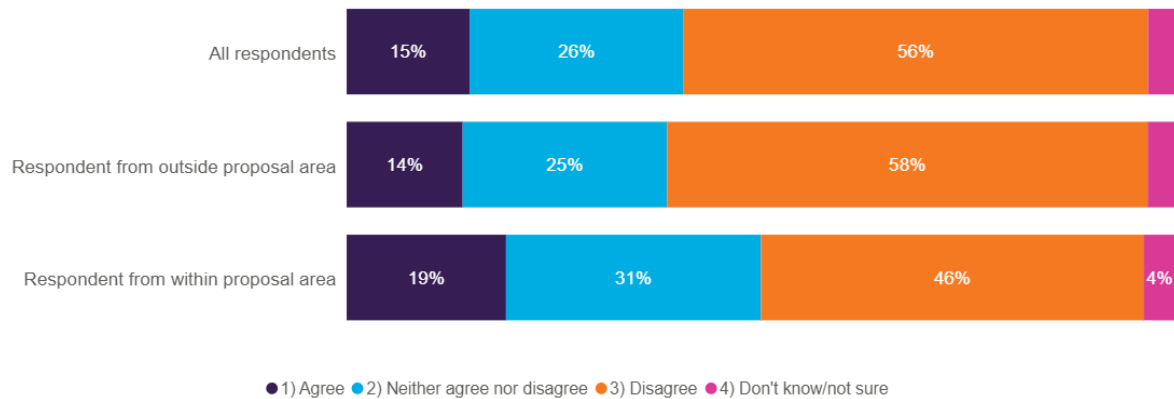

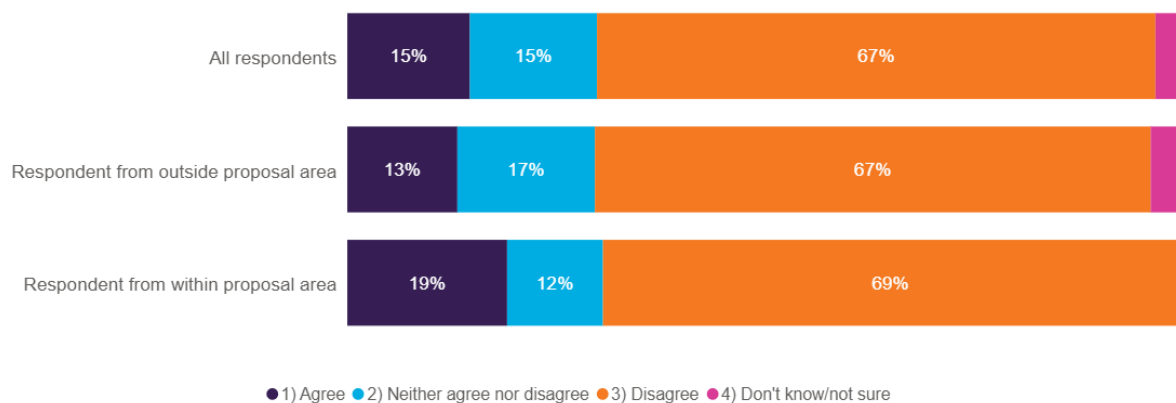

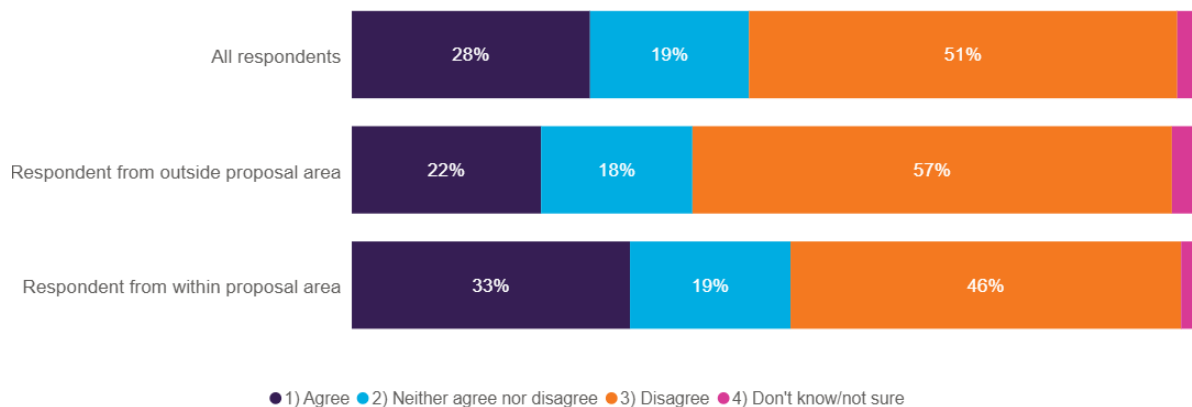
