I am writing in support of the local Premier convenience store and ask that this correspondence be taken into consideration as part of any current or future licensing proceedings relating to the premises.

I am a local resident and a registered nurse. I live immediately behind the premises and am therefore in a particularly good position to comment on any noise, disturbance or nuisance arising from its operation.

During the time that I have lived here, I have not experienced excessive noise, antisocial behaviour, disorder, public nuisance or any other issues associated with the business. Given my close proximity to the premises, I believe I would be among the first residents affected if such problems existed.
