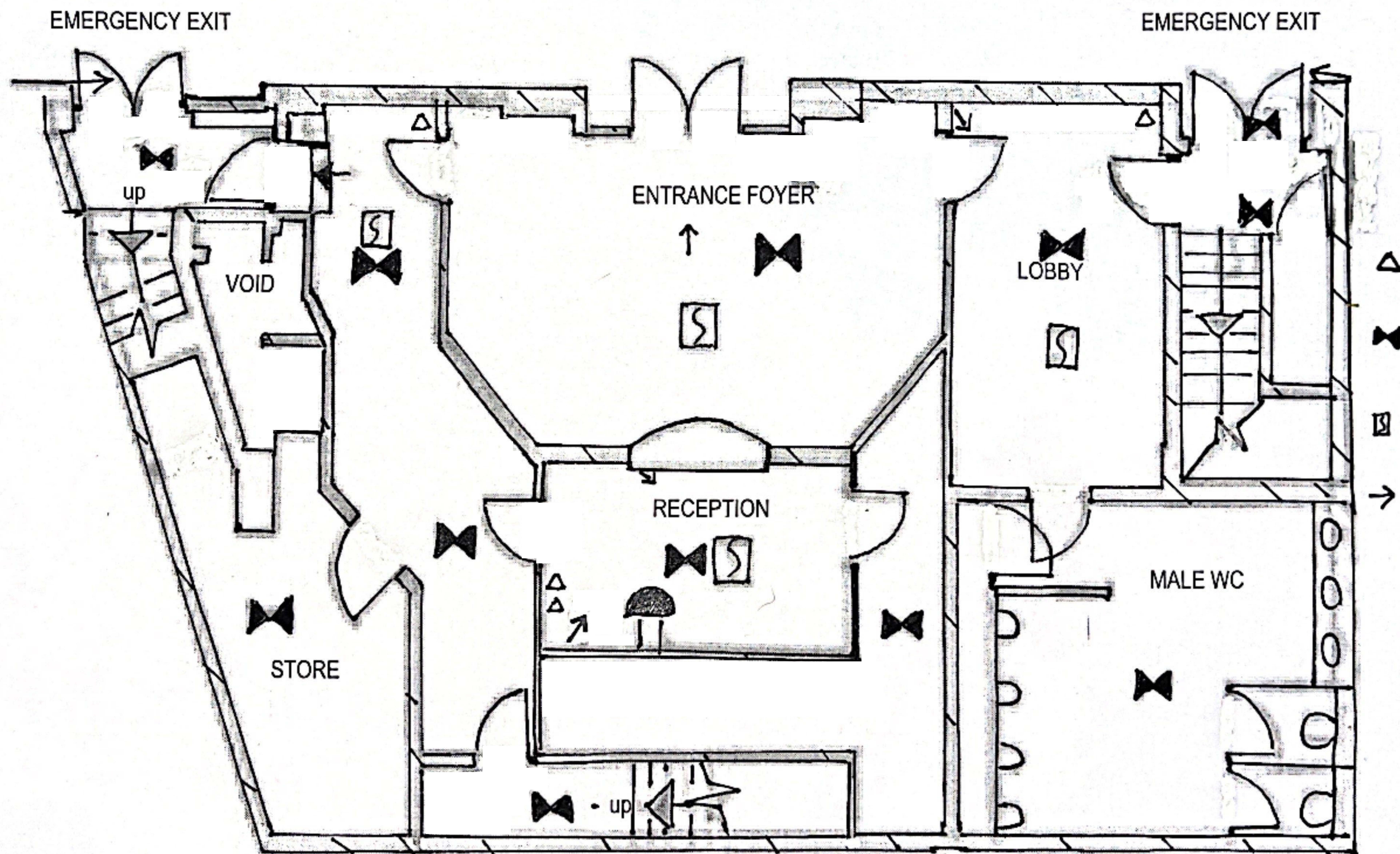


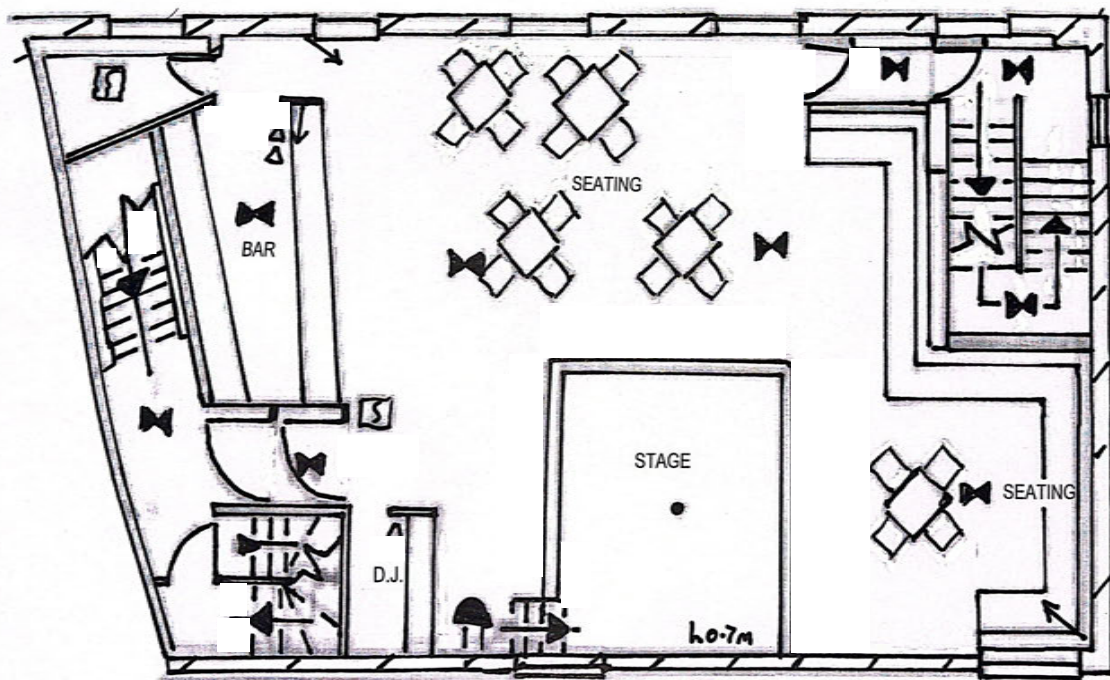
BASEMENT FLOOR

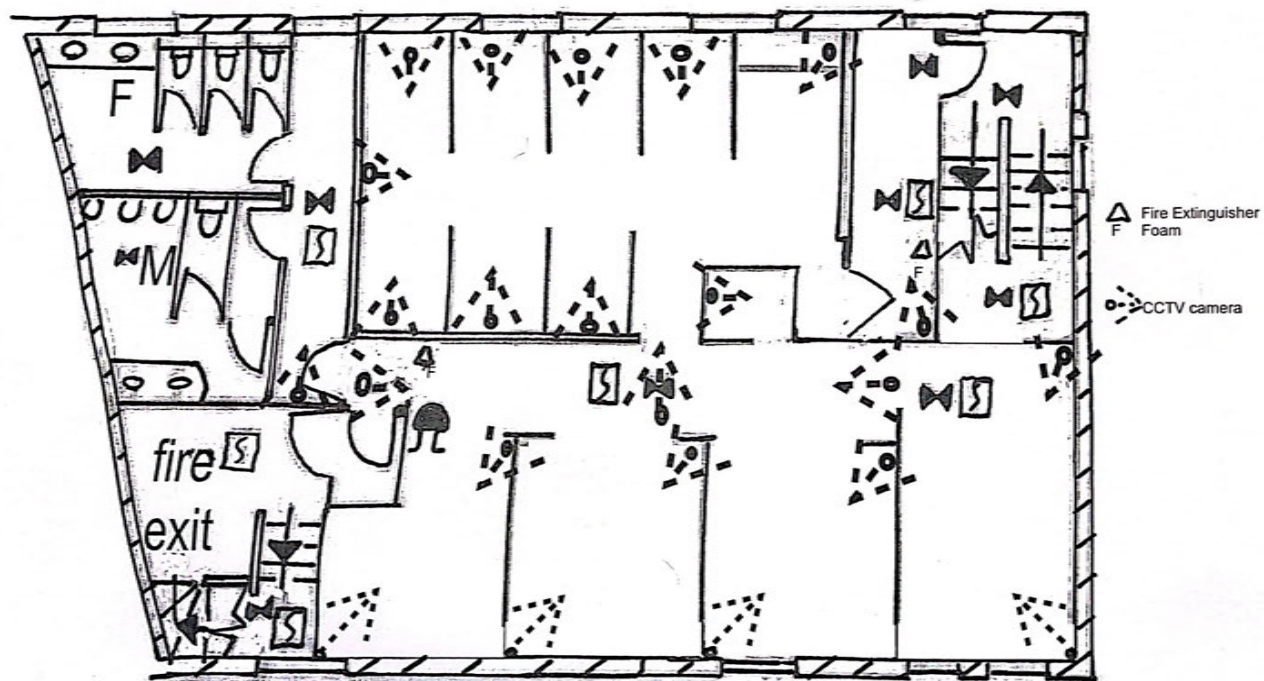




PREMISES BOUNDARY

AREA FOR RELEVANT ENTERTAINMENT

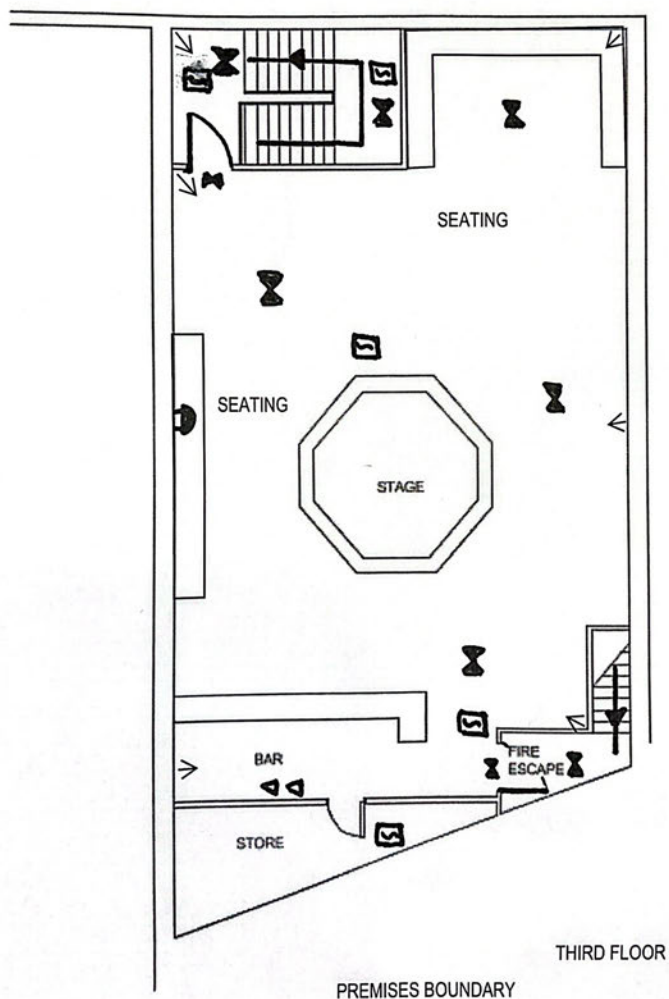


PREMISES BOUNDARY
